We have audited the financial statements of Saroyan 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit") for the year ended December 31, 2024, and have issued our report thereon dated October 13, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodian and insurance company, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter dated August 25, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Saroyan 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

The fair value of investments, as the fair value is derived by the trustee using valuation methodologies that were not audited by us. However, the trustee provided certification that the information provided was complete and accurate as disclosed in Note 5 to the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

The disclosure of party-in-interest transactions in Note 4 to the financial statements. This disclosure describes transactions with a party-in-interest. This disclosure is sensitive due to the increased focus the Department of Labor places on party-in-interest transactions to ensure there were no prohibited transactions. As described in Note 4 to the financial statements, the Company failed to comply with the DOL's regulations concerning the timely remittance of certain participant contributions and loan repayments. These delinquent remittances are considered nonexempt party-in-interest transactions and are reported in the supplemental schedules.

The disclosure of information certified by the trustee (unaudited) in Note 5 to the financial statements which describes that investments in participant directed accounts are stated at fair value and that the information has been prepared from information provided by the trustee that certified this information as complete and accurate.

The disclosure of fair value measurements in Note 8 which provides the framework for measuring fair value as well as a description of the valuation methodologies used.

The disclosure in Note 9 Fully Benefit-Responsive Investment Contract. Note 9 describes the Plan's annuity contract, which is valued at contract value, and details events that could limit the Plan's ability to transact at contract value.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements or any material misstatement of fact. These procedures are not sufficient nor are they intended to ensure that the form was completely and accurately prepared. Differences, if any, between the net assets and net income (loss) on Form 5500 and these amounts in the financial statements are described in Note 7. We identified no material inconsistencies that have not been disclosed or any material misstatement of fact in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 13, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Internal Control

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Saroyan 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Saroyan 401(k) Plan's system of internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodian and insurance company, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies, and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in Saroyan 401(k) Plan's internal control to be significant deficiencies and reportable findings:

1. Timeliness of Contribution Remittances

During testing, we noted that there were 5 instances in which employees' deferrals totaling approximately \$21,775 were not remitted to the Plan within the Plan's contribution policy and one of which had not been remitted at all due to error. The Company is in the process of remitting the missed contributions along with lost earnings.

The Department of Labor requires that participant contributions be remitted on the earliest date on which they can be reasonably segregated from the Company's general assets. Failure to remit participant contributions in a timely manner results in prohibited transactions which must be reported to the Department of Labor and can result in excise tax penalties to the Plan Sponsor.

In addition, we identified a third instance where a contribution was deposited into the Plan without a corresponding payroll deduction. Management is in the process of correcting the incorrect contribution.

We recommend Plan management review the procedures surrounding the remittance of employee deferrals and institute the necessary controls to ensure employee deferrals are reviewed prior to submission and they are remitted accurately and in a timely manner.

2. Lack of Separation of Duties and Secondary Review

During our audit, we noted there is no separation of duties or secondary level review of payroll reports prior to processing payroll. The absence of a systematic review process represents an internal control weakness that increases the risk of undetected errors and may expose the Plan Sponsor to potential fraud, such as unauthorized payments or adjustments.

Although we noted compensating controls in that management reviews cash reports and financials monthly, we recommend that Plan management implement policies and procedures to incorporate a secondary level of review to strengthen their internal controls.

During our audit, we also became aware of the following other matters that are opportunities for strengthening internal controls and operating efficiency:

1. Participant Data Documentation.

During our testing of participant data, we identified multiple discrepancies between the census file and supporting documentation. These included: differences between census and recordkeeper data for hire and termination dates, an instance where census information conflicted with I-9 documentation and an instance where an I-9 was not available. Failure to keep accurate employee data could result in the eligibility status being incorrectly calculated.

We recommend Plan management establish policies and procedures to ensure personnel data is consistently accurate and that required personnel records are obtained and retained in personnel files to properly support Plan operations.

2. Plan Trustee and Plan Administrator.

During our audit, we noted the signed Adoption Agreement lists John Saroyan and Pete Wachob as discretionary Plan trustees. Through discussions with Christine Byrd and Jeff Saroyan, we understand the Pete Wachob has retired from his position with the Company and Jeff Saroyan has taken on the role as Plan Administrator and Plan Trustee; however, we were unable to obtain documentation supporting the modification.


We recommend that Plan management establish policies and procedures to ensure important Plan documents are retained to support changes in Plan administration. Further, we recommend Plan management contact Empower to determine that the appropriate documentation is in place with respect the modification of the Plan Administrator and Plan Trustee duties.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of those charged with governance and management of Saroyan 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
