Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Physicians for Women's Health, LLC Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 — PLAN DESCRIPTION

The following description of the Physicians for Women's Health, LLC Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) and profit sharing plan available to employees and physician members of Physicians for Women's Health, LLC (the "Sponsor"). Employees are eligible to participate immediately upon being hired and attaining age 18. Eligibility for the safe harbor and profit sharing component of the Plan requires participants to complete one thousand hours of service during a 12-month period and also attain the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor's Membership Board, when necessary.

Contributions

In accordance with Section 401(k) of the Internal Revenue Code ("IRC"), participant voluntary contributions are made on a pre-tax basis. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants can also make voluntary after-tax contributions to the Plan up to limits set by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes a provision for automatic deferrals, giving participants the ability to make an affirmative election to opt out. Under this provision, automatic contributions will initially equal 3% of pre-tax compensation. As of the first day of the second Plan year, after the initial automatic deferral, the automatic deferral percentage will increase on a uniform basis by 1%, up to a maximum of 6% of compensation. Participants may direct their contributions and employer contributions among the investment options offered by the Plan.

The Sponsor made a safe harbor matching contributions to the Plan equal to 3% of compensation for the Plan year for non-highly compensated employees. The Sponsor also makes a profit-sharing contribution on behalf of eligible participants as determined by the Sponsor's Membership Board and physician members, which is based on a percentage of eligible salary. In 2024 and 2023, these percentages were generally 9% for physician members, and up to 2% for employee managers and physician employees. A participant must be employed on the last day of the Plan year to receive an allocation of the Company's profit-sharing contribution. The Company made discretionary profit sharing contributions of \$4,156,176 and \$3,835,293 for years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in full in their own contributions and the Company's safe harbor matching contribution plus earnings credited thereon. For employer profit-sharing contributions and earnings thereon, employees are 100% vested after three years of service. In the event of termination due to death, disability or retirement, as defined, participants shall become 100% vested in the employer's contribution portion of their account.

Forfeitures

Forfeitures are utilized to first reinstate previously forfeited amounts of participants who have rejoined the Sponsor. Any remaining balance is used to pay administrative expense of the Plan or reduce future employer contributions. The forfeiture balance was \$147,310 and \$137,328 at December 31, 2024 and 2023, respectively. During 2024 and 2023, employer contributions were reduced by \$0 and \$3,026, respectively, from forfeited nonvested accounts. During 2024 and 2023, fees were paid with forfeited nonvested accounts totaling \$0 and \$269, respectively.

Payment of Benefits

Account balances are normally paid to employees at retirement. The Plan also provides for the distribution of account balances upon termination of employment, permanent disability, death, for certain hardships or for in-service distributions at age 59½, in accordance with the terms of the Plan. Participants may receive their distribution in a single-sum cash payment or partial withdrawals, as allowed, in accordance with the Plan. For participants with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of their account. For participants with a balance greater than \$1,000 have the option to defer payment until a later date.

Notes Receivable from Participants

Participants may borrow one-half of the participant's account balance, up to \$50,000, in the form of a note. Note terms range from one to five years or a longer reasonable period if the note is used to acquire a principal residence. Notes bear interest at a rate which approximates local prevailing rates as determined by the Plan administrator at the time the note is issued, which is currently the prime rate plus ½%. As of December 31, 2024, rates range from 3.75% to 9.00%.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions as of the date of such termination.

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements were prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) as determined by the trustee of the Plan, generally based on reference to published market data. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants, safe harbor matching contributions and employer profit sharing from the Company are recorded in the year in which participants compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The Plan pays for all expenses of maintaining the Plan. During 2024 and 2023, the Plan received credits of \$137,023 and \$125,220, respectively, from Empower Annuity Insurance Company, a custodian of the Plan and Empower Trust Company, LLC, a

trustee of the Plan, which are classified as other income within the accompanying financial statements and may be used to fund the payment of certain Plan expenses. The expense budget account balance as of December 31, 2024 and 2023 was \$96,038 and \$164,389, respectively.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expense. Investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. While management believes that the estimates and related assumptions used in the preparation of these financial statements are appropriate, actual results could differ from these estimates.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 — CERTIFIED INVESTMENTS

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividend income on investments, net appreciation in fair value of investments and interest income on notes receivable from participants for the years then ended, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company, the custodian of the Plan and Empower Trust Company, LLC, the trustee of the Plan.

NOTE 4 — TAX STATUS

The Plan has been designed using a nonstandardized plan document designed by FIS Business Systems, LLC ("FIS"). FIS received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the volume submitter plan satisfies the applicable requirements to the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-

exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 — RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a guaranteed income fund managed by Empower Annuity Insurance Company, a custodian of the Plan, Empower Trust Company, LLC a trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Administrative expenses of \$492,316 and \$387,641 (which include fees paid out of the administrative budget account) were paid to parties-in-interest during the years ended December 31, 2024 and 2023, respectively. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions. The Plan pays directly for any other fees related to the Plan's operations.

NOTE 6 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 7 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement and Disclosures*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, money market funds and common stocks that are valued on the basis of readily determinable market prices.

Pooled separate accounts: Valued using the net unit value, which is based on the fair value of the underlying assets of the account.

NOTE 8 — FULLY BENEFIT-RESPONSIVE CONTRACT

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted

transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The balance in the traditional investment contract as of December 31, 2024 and 2023 was \$19,767,918 and \$22,331,879, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

NOTE 9 — Subsequent events

Effective January 1, 2025, participants who attain ages 60 through 63 during the taxable year are eligible for an increased catch-up contribution limit. For 2025, this limit is the greater of \$10,000 or 150% of the standard catch-up amount, resulting in a maximum catch-up contribution of \$11,250 for eligible participants.

Effective January 1, 2025, the Plan was amended to require terminated participants with vested account balances of \$7,000 or less to distribute their account balances as soon as administratively feasible. Vested account balances under \$1,000 are automatically distributed directly to the participant, while vested balances between \$1,000 and \$7,000 are distributed via automatic rollover to an individual retirement account.
