Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Dupaco Community Credit Union Health Care Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Dupaco Community Credit Union Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on September 1, 1998, to provide health and other benefits to substantially all employees and their dependents of Dupaco Community Credit Union (the Credit Union). The Plan was restated effective January 1, 2024, to comply with the provisions of the Affordable Care Act (ACA). The Plan is self-insured, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is administered by the designee (the Plan administrator) of the Credit Union.

Contributions

The Credit Union makes contributions on a self-funded basis to the Plan to provide benefits to the employees and eligible retirees. In addition to deductibles and copayments, participants and retirees contribute specified amounts based on applicable monthly premiums for their respective benefit elections.

Benefits

The Plan provides benefits on the first of the month following employment for all employees. The Plan provides health benefits (medical, vision, dental and prescription drugs). Certain benefits are subject to the participant deductibles and coinsurance. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits and benefit obligations as administrative expenses. All other administrative expenses are absorbed by the Credit Union on behalf of the Plan.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of net assets available for benefits and benefit obligations.

Stop-Loss

Premiums for stop-loss insurance are included in the accompanying statement of changes in net assets available for benefits and benefit obligations. There were no stop-loss refunds offset against benefit payments for the year ended December 31, 2024.

Refunds

Refunds are recorded when earned. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

The Plan "self-funds" the benefits provided to participants. As of each December 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable was estimated based on actual claims adjudicated prior to December 31 but paid after December 31. The liability for claims incurred but not reported (IBNR) was estimated by Plan management using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE 4 TAX STATUS

The Employer and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA, which are exempt from the prohibited transactions rules of ERISA.

NOTE 7 RISKS AND UNCERTAINTIES

The liability for claims payable was estimated based on actual claims adjudicated prior to December 31 but paid after December 31. The liability for claims incurred but not reported (IBNR) was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.
