## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DCA Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Note 1 - Description of Plan**

The DCA Profit Sharing 401(k) Plan (the “Plan”) is organized as a defined contribution plan under Section 401(k) of the Internal Revenue Code and covers substantially all eligible employees of The Falcon Corporation and Dave Carter & Associates, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by trustees appointed by the Board of Directors of the Company. The Plan was established effective September 1, 1993. The Plan has been restated and amended throughout the years, with the most recent restatement effective January 1, 2022. The following is provided only for general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

**Eligibility**

Employees who have attained age 18 and completed at least three months of employment are eligible to participate in the Plan.

**Contributions**

Each year, participants may contribute up to the maximum amount allowable not to exceed the limits of Internal Revenue Code Sections 401(k), 402(g), 404 and 415. Additional profit sharing or matching amounts may be contributed at the option of the Company’s Board of Directors. Participants direct the investment of contributions into various investment options offered by the Plan. For 2024 and 2023, the Company elected to match 50% of employee contributions up to the first 2% of the participant’s compensation. The Company did not elect to make any profit sharing contributions for 2024 or 2023.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s discretionary contribution and Plan earnings and may be charged with an allocation of administration expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary and matching contribution portion of their accounts plus actual earnings thereon is determined under the following schedule:

**Vesting, (Continued)**

A participant will also be 100% vested under any of the following circumstances:

- Death before retirement date.
- Disability before retirement date.
- Attainment of normal retirement age.

In addition, a participant is immediately 100% vested in any amount which has been transferred or rolled over into the Plan from another qualified employee benefit plan.

**Forfeitures**

The nonvested portion of a participant's account is forfeited upon termination of their employment with the Company. Forfeitures attributable to matching contributions will be used to reduce the employer's matching contribution. All other forfeitures are allocated to all participants eligible to share in the same proportion that participant's compensation for the Plan year bears to the compensation of all participants for such year. At December 31, 2024 and 2023, there was \$17,963 and \$14,715 in forfeited nonvested accounts, respectively.

**Payment of Benefits**

On termination due to death, disability, or regular retirement, a participant is entitled to receive a lump-sum amount equal to the value of the participant's account. Upon termination for any reason other than death, disability, or retirement a participant shall receive the value of the vested interest in his or her account. Annuities are allowed but are not the normal form of distribution.

**Participant Loans**

Participant loans are not allowed under the Plan.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are managed by Empower Annuity Insurance Company of America ("Empower"), which consist of various publicly traded mutual funds and a fixed account. Empower served as the intermediary for all asset purchases and redemptions. The Plan's investments are stated at fair market value at December 31, 2024 and 2023, except for fully benefit-responsive investment contracts, which are reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The fixed account is considered fully benefit-responsive and is reported at contract value.

**Investment Valuation and Income Recognition, (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

All expenses of administration may be paid out of the Plan unless paid by the Company. Certain expenses of maintaining the Plan are paid by the Plan and included in fees expense. General expenses of the administration of the Plan that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through the date the financial statements were available to be issued, or October 14, 2025. No subsequent events have been recognized or disclosed, except as noted below.

The Plan was amended in September 2025 to change the sponsor from The Falcon Corporation to Dave Carter & Associates, Inc.

**Note 3 - Information Prepared and Certified by Custodian (Unaudited)**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified by Empower Annuity Insurance Company of America under power of attorney on behalf of Talcott Resolution Life Insurance (the custodian of the Plan) as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$9,637,568 and \$8,823,181 at December 31, 2024 and 2023 respectively, and related gains of \$1,137,049 for the year ending December 31, 2024. The related gains of \$1,137,049 consist of the appreciation in fair value of the investments of \$1,085,603 and interest income of \$51,446.

**Note 4 - Investment Contract**

The Plan has an investment contract with Talcott Resolution Life Insurance (formerly Hartford Life Insurance Company), which is administered by Empower. The investment, a fixed account, is held in the insurance company's general account, subject to the group annuity contract and funding agreement.

The fixed account, valued at contract value, is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses and is considered fully benefit-responsive. The Plan holds the fixed account at December 31, 2024 and 2023. The fixed account has a declared interest rate, or minimum guaranteed rate, of 3%. The account allows participants

to direct permitted withdrawals and/or transfer transactions at contract value, which represents contributions plus credited interest, less participant withdrawals and fees. Employer initiated events, such as premature termination of the contract by the Plan, could limit the funds' ability to transact at contract value with the Plan. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The issuer is contractually obligated to pay the principal and the specified rate of interest that is guaranteed to the fund as stated in the group funding agreement. The contract values of the fixed account are \$1,563,421 and \$1,951,223 at December 31, 2024 and 2023, respectively.

**Note 5 - Fair Value Measurements**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the assets or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers in and transfers out as of the actual date of the event or change in circumstances that caused the transfer. For the years ending December 31, 2024 and 2023, there were no significant transfers into or out of levels 1, 2, or 3.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

**Note 7 - Tax Status**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8 - Risks and Uncertainties**

The Plan invests in a variety of publicly traded funds and a fixed account. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 9 - Related Party and Parties-In-Interest Transactions**

Parties-in-interest include fiduciaries of the Plan, any person who provides services to the Plan, the employer, and certain other parties. Transactions during the year with parties-in-interest included the following:

The employer, Dave Carter & Associates, Inc., provided certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Furthermore, the custodian and recordkeeper held the Plan investments and provided investment advisory and recordkeeping services to the Plan. Investment and administrative fees incurred by the Plan totaled \$57,826 and \$48,067 in 2024 and 2023, respectively.
