NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

NOTE 1    PLAN DESCRIPTION

The following description of Near Earth Autonomy, Inc. 401(K) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan available to all employees of Near Earth Autonomy, Inc. 401(K) Retirement Plan (the “Plan Sponsor”). The Plan covers all employees who have one-half (1/2) year of service and are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Each year, participants are permitted to make elective deferrals up to the maximum percentage of compensation and flat dollar amounts permissible under the Internal Revenue Service Code, not to exceed certain limits. Participants may also designate all or a portion of their elective deferrals as after-tax Roth elective deferrals. The Company will make a non-discretionary matching contributions in an amount equal to 100% of your deferral contributions up to 2% of eligible compensation contributed to the Plan. In addition, the Company will make a safe harbor nonelective contribution in amount equal three percent (3%) of an eligible participant’s compensation. At the direction of the Board of Directors, the Company may also make a discretionary nonelective contribution to the plan. There were no discretionary nonelective contributions made to the plan during the year ended December 31, 2024. Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers registered investment companies and self-directed brokerage as investment options.

Participant contributions to the Plan are made through periodic payroll deductions. Plan Sponsor discretionary profit sharing or qualified nonelective contributions, if any, are remitted annually. Receivables from the Plan Sponsor are unsecured.

*Participant Accounts*

Each participant's account is credited with the participant's contribution allocations of (a) the Company's matching contribution, and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In addition, employees are able to allocate all or a portion of their contributions to a ROTH account.

### *Investment Options*

Participants may direct the investment of all contributions into various options offered by the Plan. The Plan currently offers pooled separate accounts as well as an self-directed brokerage sponsored by Fidelity investments.

### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon, discretionary qualified nonelective contributions and rollover contributions plus actual earnings on these contributions. A participant is 100% vested immediately upon entry into the Plan.

### *Notes Receivable from Participants*

Participant loans are not permitted according to terms of the plan document.

### *Payment of Benefits*

Upon qualified reservist, active duty military, retirement, disability, death or termination of service, a participant may elect to receive either a lump sum amount, installment payments based on participant life expectancy or joint life expectancy, or participant elected payments. Participants may apply for hardship withdrawals, subject to approval by the Plan Administrator. Contributions and earnings are taxable to the participants upon withdrawal from the Plan. Participants may also withdraw their vested account balances at any time on or after the age of fifty-nine and a half (59 ½), or upon retirement. Participants may not postpone payment of account balances of less than \$7,000 and any account exceeding \$1,000 these account balances will be distributed to an Individual Retirement Account or Annuity ("IRA") for your benefit. If your vested Account balance is \$1,000 or less, the Plan Administrator will direct the Trustee to distribute it to you as a lump sum distribution without your consent.

### *Forfeited Accounts*

Forfeited amounts are used to reduce employer matching contributions or pay administrative expenses. Forfeiture balances amounted to \$-0- for both years ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$2,575 of forfeitures were used to increase employer matching contributions.

## NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States.

### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation/depreciation includes the Plan's losses and gains on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### *Payment of Benefits*

Benefit payments to participants are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

## NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

Level 1 – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Value based on the closing price of the security as quoted by the principal exchange on which the security is traded, which represents fair value.

Registered investment companies: Valued at the net asset value (“NAV”) of shares held by the plan at year end, which is based on quoted market prices in active markets.

Common Stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Options/Units: Valued at the closing price reported on the active market on which the individual options or units are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the year ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2, or 3. The following table sets forth by level, within the fair value hierarchy, a summary of the Plan’s investments measured at fair value on a recurring basis as follows:

#### NOTE 4 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

#### NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

#### NOTE 6 TAX STATUS

The Plan adopted Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Non-Standardized plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the Non-Standardized Pre-Approved Profit Sharing Plan with CODA plan's qualified status. The Non-Standardized plan opinion letter has been relied upon by this Plan. The Non-Standardized plan has been amended since receiving the determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

## NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

## NOTE 8 RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid to Fidelity Management Trust Company amounted to \$3,716 during the plan year ended December 31, 2024.
