## Report of Independent Auditors

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of Lewis Resource Management, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution plan covering all eligible employees, as defined, of Lewis Resource Management, LLC and two affiliated entities (collectively, the Company) who have completed one month of service and attained the age of 21.

Lewis Resource Management, LLC is responsible for the general administration of the Plan. Reliance Trust Company is the trustee and ADP, LLC is the record-keeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants may elect to contribute pretax and Roth elective deferrals up to 90% of eligible compensation, as defined, subject to the annual Internal Revenue Service (IRS) limit. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

The Company made safe harbor matching contributions of 100% of the first 3% of compensation and 50% on the next 2% of compensation for the year ended December 31, 2024.

Effective June 1, 2024, the Plan was amended to allow for employer matching true-up contributions.

Additional discretionary matching or profit-sharing amounts may be contributed at the option of the Company's partners. There were no discretionary matching or profit-sharing contributions made for the year ended December 31, 2024.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Investment Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan administrator in 1% increments. Participants may change their investment options daily.

#### Participant Accounts

Each participant's account is credited with the participant's contribution; the Company's matching contributions; allocations of the Company's profit-sharing contributions, if any; and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions, the Company's safe harbor matching contributions, and actual earnings thereon. Participants are vested using a graded vesting schedule for Company discretionary matching and profit-sharing contributions, becoming 20% vested after their second year of service and 100% vested after their sixth year of service.

#### Payment of Benefits

Upon a participant's retirement, death, disability, or termination, the account balance shall be distributed to the participant or beneficiary using one of the several distribution methods. During employment, participants may withdraw account balances upon attainment of age 59½. Benefits are payable in lump-sum payments, with certain exceptions allowed. A mandatory distribution will be made for terminated participants with account balances of less than \$5,000.

#### Forfeitures

Participant forfeitures of non-vested balances will be used to reduce future employer contributions and pay the expenses of the Plan. During 2024, employer matching contributions were reduced by \$15,961 from forfeited non-vested accounts. Forfeited non-vested accounts totaled \$18,173 and \$11,995 as of December 31, 2024 and 2023, respectively.

### 1. Description of Plan (continued)

#### Participant Loans

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The repayment term may not exceed five years, with the exception of loans used for the purchase of a primary residence, in which case the Plan administrator may permit a longer repayment term. A participant may not have more than one loan outstanding at any point in time. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

#### Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and trustee fees. Loan administration fees are paid by the participant electing the loan. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan administrator and management determine the Plan's valuation policies, utilizing information provided by the trustee. See Note 4 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

The Plan has evaluated subsequent events through September 24, 2025, the date the accompanying financial statements were issued.

#### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- **Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2:** Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices for the asset or liability that are observable
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability.

- **Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### **4. Fair Value Measurements (continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

##### *Mutual Funds*

Mutual funds are valued at the quoted daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### *Self-Directed Brokerage Accounts*

Accounts consist of mutual funds and individual corporate common stocks that are valued at the closing price reported on the open market.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Related-Party and Party-in-Interest Transactions

Investments of the Plan are managed by the trustee. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

#### 6. Tax Status

The underlying preapproved plan has received an opinion letter from the IRS dated October 6, 2020, stating that the written form of the underlying preapproved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

#### **6. Tax Status (continued)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
