Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Eleven Counties Cement Masons Vacation Savings Plan (the “Plan”) is a collectively-bargained multi-employer benefit plan that provides vacation benefits to eligible participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

Contributions received are credited to each employee’s vacation account for work performed between March of each year through the last day of February in the following year. The amounts credited each year are paid semi-annually as follows:

<u>Period Worked</u>	<u>Distribution Date</u>
March through August	December 1st
September through February	June 1st

If the participant fails to cash a vacation check prior to July 1st of the fourth year following the issue date, the check is forfeited, and the participant shall be deemed to have elected to contribute such amount to the cost of maintaining the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accounts of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Employer Contributions

Contributions are reported on the financial statements on the accrual basis. Contributions as reported are contributions made for hours worked during the year. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

D. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under a separate payroll compliance program.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

E. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701(i).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Plan shares common expenses with four related entities (Cement Masons Southern California Pension Trust, Cement Masons Joint Apprenticeship Trust, Cement Masons Southern California Health and Welfare Fund and Cement Masons Southern California Individual Retirement Account Defined Contribution Trust) (collectively the "Trust Funds") and three additional related organizations based on allocation percentages periodically approved by the Board of Trustees.

Employer compliance audits and collection services are performed by Zenith American Solutions. The Plan is charged its allocable share of the \$61,999 per month. The allocation percentages are periodically approved by the Board of Trustees.

NOTE 4 - PLAN TERMINATION

The Plan shall remain in effect for the period set forth in any applicable collective bargaining agreement, or as determined by the Board of Trustees, or by mutual consent of the parties to the Trust Agreement.

In the event of the termination of the Plan, any remaining funds shall be expended exclusively for the Plan's purposes.

NOTE 5 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.


