### Report on the Financial Statements

#### ***Opinion***

We have audited the accompanying financial statements of Santini Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of Santini Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 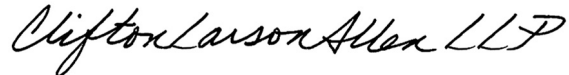

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Santini Employee Stock Ownership Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Santini ESOP, Inc (the Employer) established the Plan effective January 1, 2020. The Plan was last amended November 29, 2021. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan covers all employees of Santini Fine Wines, Inc. and Santini Foods, Inc. (participating employers) who have completed the eligibility requirements including the completion of one year of service and 1,000 hours. The Plan excludes employees who are classified as leased employees, nonresident aliens and employees whose employment is governed by a collective bargaining agreement. An eligible employee will begin participation on January 1 or July 1 following the completion of the eligibility requirements. The Plan is designed to invest primarily in securities issued by the Employer and is authorized to borrow money for such investments. It is subject to the provisions of ERISA, as amended.

Effective January 3, 2022, the Plan purchased shares of Employer common stock using a note agreement with the Employer (see Note 5). The borrowing is collateralized by the Plan's unallocated shares of the Santini common stock. As the Plan makes debt payments, an appropriate percentage of stock is allocated to eligible participant's accounts. The lender has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- a) The account of employees with rights in allocated common stock (Allocated) and
- b) Common stock not yet allocated to employees (Unallocated)

**Contributions**

Each year, the Employer may contribute to the Plan up to 25% of covered compensation as determined annually by the Employer's Board of Directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Employer. In order to receive an allocation of Employer contributions, a participant must be employed on the last day of the Plan year unless termination is due to death, disability, or retirement. Contributions by Plan participants are not permitted by the Plan.

Contributions are subject to Internal Revenue Service (IRS) limitations.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with contribution and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Employer as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation, as defined. Plan earnings or losses are allocated to each participant's account based on the ratio of the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

Vesting of participant's accounts is based on years of credited service with the Employer. A participant's account becomes fully vested after six years of credited service with the Employer, under a graded vesting schedule. A participant is fully vested upon reaching normal retirement age 65 or fifth anniversary of joining the Plan, if later, death, or permanent disability.

**Voting Rights**

All Employer stock held by the Trust is voted by the Trustee. Each participant is entitled to direct the Trustee as to the voting of any voting shares of Employer stock allocation to their stock account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business. The Trustee shall vote on such matters any unallocated shares held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction.

**Put Option**

Under federal income tax regulations, the Employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Employer buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Employer can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify may receive a cash distribution or roll over the amount to another qualified IRA or plan.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

For participants who terminate employment due to normal retirement, death, or total and permanent disability, distributions of total account balances of \$5,000 or less will occur as a lump sum as soon as administratively feasible following the close of the Plan year in which the event occurs. For account balances exceeding \$5,000, distributions of the Employer stock account will occur in substantially equal annual installments over a period of five years.

For participants who terminate employment for reasons other than normal retirement, death, or total and permanent disability, distributions of vested account balances of \$5,000 or less will occur as a lump sum as soon as administratively feasible following the close of the Plan year in which the event occurs. For vested account balances exceeding \$5,000, distributions will occur in substantially equal annual installments over a period of five years as soon as administratively feasible following the close of the fifth Plan year after termination of employment. Notwithstanding the other provisions, the Plan shall not be required to distribute any Employer Securities acquired with the proceeds of a Securities Acquisition Loan until the close of the Plan Year in which such Securities Acquisition Loan has been repaid in full.

**Forfeited Accounts**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. There was no balance in the forfeiture account as of December 31, 2024 and 2023. Forfeitures totaling \$200 were reallocated to participants during the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to other administrations are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 INVESTMENTS**

The Plan's initial investment in Employer securities consisted of 1,000,000 shares of the outstanding common stock of Santini Foods, Inc. The shares were originally acquired on January 3, 2022 for \$14,000,000 (\$14.00 per share). Subsequent to year end, the Company and the Anna Liu Revocable Trust entered into a settlement agreement and agreed to reduce the original purchase price in 2022 by \$4,500,000 and forgive related accrued interest on the \$4,500,000 from the date of execution of the original note.

The estimated fair market value, determined by independent appraisals as of December 31, 2024 and December 31, 2023, was \$0.77 and \$1.03 per share, respectively. During the Plan year ended December 31, 2024, 43,154 shares were released to eligible Plan participants. The following table presents the investment in the Employer common stock at December 31:

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Company Common Stock* – The fair value of the Company common stock held by the Plan is valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

**NOTE 6 PLAN TERMINATION**

The Employer reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Trustees will pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such a sale to be necessary in order to repay the loan. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The IRS has determined and informed the Employer, by a letter dated March 8, 2023, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan is administered by the Employer and certain administrative functions are outsourced to a third-party administrator. The Plan has engaged an external trustee. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan provides for investment primarily in Company common stock. The stock of the Company is valued annually by an independent third-party valuation specialist. Because of the inherent subjectivity in any valuation, those estimated values may differ significantly from the values that would have been used had a ready market for the securities existed, and the differences could be material. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
