NOTE A. DESCRIPTION OF THE PLAN

The following description of the Metco Industries, Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan as described under Internal Revenue Code Section 401(k). The Plan covers full-time employees of Metco Industries, Inc. (collectively, the “Company”) who have at least one year of service and are eighteen or older. Effective February 1, 2023, the service requirement changed from one year to six months. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

The Plan is funded through employer contributions and both pre-tax and Roth (effective September 1, 2024) employee payroll deductions. Each year participants can elect to defer a percentage of their annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The amount a participant may defer in any tax year is limited by law.

The Company matches 20% of employee deferral amounts up to \$1,000 annually.

Participant Accounts

Each participant’s account is credited with the participant’s respective deferral, the employer contributions and plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

Participants are immediately 100% vested in amounts attributable to employee deferrals and earnings. A participant is 100% vested in their discretionary employer contribution after six years of credited service.

Payment of Benefits

Upon termination of service, if a participant's vested benefit in the Plan does not exceed \$1,000, the participant's benefit will be distributed in a single lump sum payment. If the participant does not consent to a distribution, the vested benefit will be automatically rolled over to an IRA selected by the Plan Administrator. If the vested benefit in the Plan exceeds \$1,000, then the participant must consent to the distribution before it may be made. The participant may elect to receive a distribution in the form of a single lump sum payment or a series of installment payments.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,742 and \$6,123, respectively. Forfeitures may either be used by the Plan at the discretion of the plan administrator for payment of plan expenses, employer contributions or allocated to the participants. For the year ended December 31, 2024, employer contributions and plan expenses were not reduced by forfeited non-vested accounts.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassification

Amounts in the prior period's financial statements are reclassified whenever necessary to conform to current period presentations.

Date of Management's Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the trustee of the Plan, for the period of January 1, 2024 through September 5, 2024, and John Hancock Life Insurance Company, the custodian of the Plan, for the period of September 6, 2024 through December 31, 2024.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Northwest Bank, the trustee of the Plan.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs available to the Plan.

The fair value of mutual funds is based on quoted net asset values of shares held by the Plan at year end. Mutual funds are classified within Level 1 of the fair value hierarchy.

The fair value of the pooled separate accounts is measured at the NAV of each account on the last day of the plan year. The NAV is based on the market value of the underlying assets.

Members of the management team are currently participants in the Plan, and one member serves as the plan administrator.

Finally, the plan sponsor directly pays most administrative expenses for the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE H. TAX STATUS

The Internal Revenue Service has determined and informed the trustee by a letter dated August 20, 2014, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
