NOTE A | DESCRIPTION OF THE PLAN

The following description of UTG, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all employees of UTG, Inc. and its wholly-owned subsidiaries (collectively the Company) who have met the requirements expressed in the Plan document. The Plan was adopted and began operations on January 1, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings. Voya Retirement Insurance and Annuity Company serves as the custodian of the Plan's assets.

2. Contributions

Each year, participants may contribute up to the maximum dollar amount as determined by the Federal government of pre-tax or post-tax (Roth contribution) annual compensation, as defined in the Plan document. The maximum deferral was \$ 23,000 and \$ 22,500 for 2024 and 2023, respectively. Participants who will be at least 50 by the end of the year may make an additional "catch-up" contribution of up to \$ 7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2022, the Safe Harbor Matching Contribution formula under the Plan was amended to provide for Safe Harbor Matching Contributions equal to 100% of the amount contributed for the Plan year up to 6% of compensation. Salary deferrals that are "catch-up" contributions are not matched.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled unless they affirmatively elect not to participate in the Plan. Effective January 1, 2023, the Automatic Contribution Arrangement under the Plan was amended to increase the automatic deferral amount from 3% to 6%. Contributions are invested in a designated balanced fund until changed by the participant.

The employer has discretion to make non-elective contributions that it may, from time to time, deem advisable. These non-elective employer contributions are to be determined each year on a discretionary basis. Employer discretionary contributions are allocated in the ratio in which the considered compensation of each participant bears to the considered compensation of all participants as of the allocation date. For the years ended December 31, 2024 and 2023, no non-elective contributions were made by the employer.

3. Participant Accounts

The Plan is intended to qualify as a participant-directed plan under Section 404(c) of ERISA for investments held in the custody of Voya Retirement Insurance and Annuity Company (VRIAC). Each participant is responsible for his or her own investment decisions under the Plan and any resulting investment activity. A separate account is established for each participant who receives and/or makes a contribution.

Each participant's account is credited with the participant's contribution, the Company's matching safe harbor contributions, allocations of the Company's discretionary contributions and the Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

4. Vesting

Participants are immediately vested in their elective contributions and Safe Harbor matching contributions and actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of service as follows:

5. Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, installment payments, or IRA rollover or conversion to another qualified plan. The Plan also allows for hardship distributions, subject to the Plan provisions.

5. Payment of Benefits

Participants who terminate employment, for any reason, may elect to receive their vested benefits within a reasonable period following termination. Participants whose benefits exceed \$ 5,000 may receive a distribution in any form permitted by the Plan. Participants whose benefits do not exceed \$ 5,000 may receive a lump sum distribution following their termination. Any non-vested benefits are forfeited to the Plan at the time of distribution. Participants who do not terminate employment may make withdrawals from the Plan in accordance with IRC regulations.

6. Forfeitures

Forfeited non-vested accounts totaled \$ 1,212 and \$ 910 as of December 31, 2024 and 2023, respectively. These accounts can be used to pay plan administrative expenses or offset other employer contributions. No administrative expenses or employer contributions were paid from forfeitures for the year ended December 31, 2024. Administrative expenses of \$ 4,358 were paid from forfeitures for the year ended December 31, 2023.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

3. Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Payment of Benefits

Benefits are recorded when paid.

5. Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Any additional administrative expenses of the Plan are paid by the Plan participants, as provided in the Plan document. Certain investment-related expenses are included in net appreciation (depreciation) of the fair value of investments.

6. Subsequent Events

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 8, 2025, which is the date the financial statements were available to be issued. Through October 8, 2025, no subsequent events required recognition or disclosure in the financial statements.

NOTE C | FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs needed in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts consist of common stocks, mutual funds, interest bearing cash, unit investment trusts, and U.S. Treasury securities that are valued on the basis of readily determinable market prices.

Investments in units of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of units held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund. The underlying investments of these funds consist of mutual funds.

NOTE D | INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan allows participants to invest in a fully-benefit responsive contract with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company maintains these contributions in a general account. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The investment contract is designed to accrue interest based on a crediting rate established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract. Accordingly, the contract value is also the fair value. If an event should occur such that realization of full contract value for a particular investment contract is no longer probable, the contract will no longer be considered fully benefit-responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE D | INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (such as complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an incurred violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE E | SUMMARY FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The following is a summary of the unaudited information of the Plan at December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplementary schedule that was prepared by, or derived from, information prepared by the custodian of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certification from Voya Retirement Insurance and Annuity Company that such information is complete and accurate.

NOTE F | PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of partial or total Plan termination, participants will be entitled to the full amount in their accounts as of the date of termination.

NOTE G | TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document; the plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I | PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian for the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

NOTE J | PROHIBITED TRANSACTIONS

During the plan year, certain employee contributions were not remitted to the plan within the time frame required by the Department of Labor (DOL) regulations. The Plan sponsor has remitted all delinquent contributions and lost earnings to the Plan. The Plan sponsor has corrected these transactions via self-correction procedures.
