### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of HughesLeahyKarlovic, Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF THE PLAN

The following brief description of HughesLeahyKarlovic, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by HughesLeahyKarlovic, Inc. (the "Company" or "Plan Administrator"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until December 31, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Ascensus, LLC, an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC ("Ascensus") is the recordkeeper and trustee.

Eligibility

The Plan covers all employees of the Company with no service or age requirements. Participants are eligible to participate in the Plan beginning the first day of the month following their date of hire. Participants are eligible for the Company matching contribution and all other Company contributions on the first day of the month following one-year of service.

Contributions

Participants can contribute up to 100% of pretax annual compensation, as defined in the Plan, as pretax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Contributions are subject to certain Internal Revenue Service ("IRS") limitations. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The Plan automatically enrolls participants with a deferral rate set at 8% of eligible compensation. In addition, the Plan provides for an automatic escalation provision, automatically increasing participant deferral contributions 1% each year until the participant reaches a 10% deferral rate. Participants may opt out at any time.

The Plan provides for matching contributions. For the years ended December 31, 2024 and 2023, the Company matched 25% of the first 8% of eligible compensation.

Contributions (continued)

The Company may also make discretionary contributions. There were no discretionary contributions made by the Company for the years ended December 31, 2024 and 2023.

Vesting

Participants are 100% vested in their deferral contributions and rollovers plus actual earnings (losses) thereon. Vesting in Company contributions is based on years of service. Participants vest at 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and become fully vested after six years of service. Participants also become 100% vested upon reaching normal retirement age (age 65), death, or becoming disabled.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to pay Plan expenses or to reduce future Company contributions. Forfeited non-vested accounts amounted to \$8,007 and \$21,431 as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeitures used to pay Plan expenses and to reduce Company contributions amounted to \$25,822 and \$31,398, respectively.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions and an allocation of Plan earnings. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

A participant may borrow a minimum of \$1,000 from his or her account with a maximum of two loans outstanding at any given time. In no event can the participant borrow more than \$50,000 or 50% of his or her vested account balance, whichever is less. Loans are for a period not to exceed five years, unless used to acquire a personal residence, and then the loan may extend to fifteen years. Loans bear interest at a reasonable fixed rate of interest equal to the Prime rate plus 1%. All loans are secured by the participant's vested account balance and are payable in installments of principal and interest through payroll deductions.

1. DESCRIPTION OF THE PLAN (continued)

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code ("IRC") are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits

Participants are entitled to receive the balance of their accounts upon death, total disability, retirement, or termination of employment in the form of a lump-sum or annuity. Participants are also entitled to receive early retirement benefits, upon reaching age 55 with six years of vesting service.

In-service withdrawals

Participants who attain the age of 59-1/2 may withdraw any portion of their vested account balance. In certain circumstances, a participant may elect a hardship distribution, as defined in the Plan Document. In-service distributions may not be less than \$1,000.

Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. A portion of the administrative expenses of the Plan are paid by the Company. Fees related to the administration of notes receivable from participants and distributions are charged to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are maintained on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect certain amounts reported in the financial statements and related notes. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, which is when the financial statements were available to be issued.

3. CERTIFICATIONS OF INVESTMENT INFORMATION

For the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from Ascensus that all of the investment and notes receivable from participant information provided by Ascensus and included in the accompanying financial statements and the supplemental Schedule of Assets (Held at End of Year) is complete and accurate. Information as to the investments, investment income, interest, and all information appearing in the accompanying statements and supplemental Schedule of Assets (Held at End of Year) is presented in reliance solely upon the certifications.

4. FAIR VALUE MEASUREMENTS

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund* - The Plan's collective trust fund is held in a separate investment account, which is valued using the readily determinable fair value ("RDFV"). The RDFV is based on the value of the underlying assets owned by the fund. The collective trust fund held by the Plan publishes their RDFV daily and transacts at that price.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The Plan has adopted a prototype standardized plan, for which a favorable opinion letter was issued by the IRS on June 30, 2020. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are held within investments of The Vanguard Group, Inc., the Plan's custodian. Expenses paid to The Vanguard Group, Inc. for custodial services for the years ended December 31, 2024 and 2023 were \$26,345 and \$28,015, respectively. As described in Note 1, the Company directly pays some of the expenses related to the Plan's operations.

These transactions are considered party-in-interest transactions allowable under ERISA.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company had late employee deferral and loan repayment contributions totaling \$319,015, \$474,794, and \$2,175 for the Plan years ended December 31, 2023, 2021, and 2019, respectively. The 2021 and 2023 late remittances were corrected in 2024, and the Plan Administrator intends to correct the 2019 late remittances during 2025..
