Independent Auditors' Report

To the Plan Participants and Plan Administrator
Columbia Forest Products, Inc. Employee 401(k) Retirement Savings Plan and Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Columbia Forest Products, Inc. Employee 401(k) Retirement Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

(1) Plan Description

The following description of the Columbia Forest Products, Inc. Employee 401(k) Retirement Savings Plan and Trust (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

(a) General

The Plan is a defined contribution plan established July 1, 1988 by Columbia Forest Products, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2000, the Plan was amended to allow transfer of certain participant's balances from the Columbia Forest Products, Inc. Employee Stock Ownership Plan and Trust (ESOP) to the Plan. Total transfers during 2024 and 2023 were \$979,020 and \$302,081, respectively.

Effective January 1, 2015, the Plan document was restated to comply with applicable changes in law caused by various regulations and related guidance.

(b) Plan Administration

The Plan is administered by the Administrative Committee consisting of one or more persons appointed by the Company. Principal Trust Company (the Trustee) holds the Plan's investment assets and executes investment transactions for the Plan.

(c) Eligibility and Vesting

Employees meeting the service requirements may participate in the Plan unless they are leased employees, working outside the United States, or certain union employees covered by a collective bargaining agreement. Employees are eligible to enter the Plan after completing 30 days of employment. Under the Plan, participants are immediately vested in all contributions plus actual earnings thereon. Employees are automatically enrolled in the Plan upon obtaining eligibility and have the ability to elect to not participate in the Plan.

(d) Contributions

Participants may elect to contribute an amount from 1% to 75% of their eligible compensation as defined by the Plan, or a fixed dollar amount not in excess of the maximum amount allowable under the Plan, limited by requirements of the IRC. The Company may, at its discretion, make supplementary contributions. There were no discretionary Company contributions during the years ended December 31, 2024 and 2023.

(e) Participant Accounts

Individual accounts are maintained by the recordkeeper for each of the Plan's participants to reflect the participant's share of the Plan's net earnings, the participant's regular contributions, the participant's catch-up contributions, if applicable, the participant's rollover contributions, if applicable, and employer contributions, if applicable. The Plan's net earnings are allocated according to the ratio that the balance

of each participant's account bears to the total balance of accounts of all participants within each fund. Employer contributions, if any, are allocated according to the ratio that the compensation of each participant for the plan year bears to the total compensation of all participants.

(f) Benefits and Withdrawals

Upon termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's interest in his or her account. Benefit payments are paid in the form of a lump-sum distribution or in installments.

A participant may elect a hardship withdrawal during employment for a portion of their account upon the approval of the recordkeeper.

(g) Notes Receivable from Participants

Notes receivable from participants are recorded at amortized cost plus accrued interest. A participant may apply for a loan of up to 50% of the participant's account balance with a minimum of \$1,000, and the loan amount shall not exceed \$50,000. The loans are generally repayable over a maximum period of five years. The notes receivable from participants are secured by the balance in the participant's account. The interest rate is set by the Administrative Committee and is based upon the prevailing prime rate plus an applicable margin. The interest rates for outstanding notes receivable from participants at December 31, 2024 ranged from 5.25% to 10.50%. Principal and interest are paid ratably primarily through payroll deductions.

(h) Investment Options

Plan investments are participant directed. Upon enrollment in the Plan, participants may direct contributions into a variety of investment options including shares of registered investment companies, pooled separate accounts and common or collective trusts in no less than 1% increments. Participants may change their investment elections at any time via internet or telephone.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of these financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from these estimates.

(c) Payment of Benefits

Benefits paid to participants are recorded upon distribution.

(d) Administrative Expenses

All plan administration and recordkeeping costs, with the exception of individual participant loan fees, are paid by the Company. Participants pay for loan fees upon execution of the loan from loan proceeds. Expenses directly related to the management of plan assets are paid from the trust.

(e) Investment Valuation and Risk

Investments are reported at fair value. See note 4 for discussion of fair value measurement.

The Plan may invest in registered investment companies (mutual funds), pooled separate accounts and the common or collective trust funds which include securities with contractual cash flows which may include asset-backed securities, collateralized mortgage obligations and commercial mortgage backed securities. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(f) Income Recognition

Net appreciation in fair value of investments consists of the net change in unrealized appreciation and depreciation during the year on investments held at the end of the year and the realized gain or loss on the sale of investments during the year. Investment transactions are recorded on the trade date. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

(3) Certified Investments

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure. The Plan Administrator determined that the certifications received from the Plan's trustee meet the requirements of ERISA Section 103(a)(3)(C). The trustee has certified that the investments presented in the statement of net assets available for benefits at December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 included in the accompanying financial statements and supplemental schedule are complete and accurate as of and for the years ended December 31, 2024 and 2023.

The Plan's Independent auditors did not extend their audit procedures to the information certified by the trustee, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

(4) Fair Value Measurement

The fair value of assets and liabilities is determined by using a fair value hierarchy that distinguishes between market participant assumptions developed based on market data obtained from sources independent of the reporting entity, and the reporting entity's own assumptions about market participant assumptions developed based on the best information available in the circumstances.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, essentially an exit price.

The levels of the fair value hierarchy are:

Level 1: inputs are quoted prices, unadjusted, in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. A Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: inputs are unobservable and reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Investments in registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments in pooled separate accounts and common or collective trusts are valued based on the NAV provided by the fund. The NAV is based on the fair value of the underlying investments held by the fund. Included in the common or collective trusts is the Galliard Stable Return Fund, which is composed primarily of fully benefit responsive investment contracts that are valued at the NAV of the collective trust. The NAV of these investments is used as the readily determinable fair value. The NAV would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no significant restrictions, redemption terms, or holding periods associated with these investments which would limit the ability of the Plan or the participants to transact at NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the investment, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation

(5) Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2015 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time. In the event the Plan is terminated, participants will receive all benefits to which they are entitled under the Plan.

Certain plan investments are common or collective trust funds and shares of registered investment companies managed by Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan and, therefore, these investments and investment transactions qualify as party--in--interest.
