**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the SEBMG 401K Profit-Share Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General: Sutter East Bay Medical Group, Inc. (the "Employer") established the Plan effective January 1, 2005. The Plan is a defined contribution plan covering all eligible employees of Sutter East Bay Medical Group, Inc. The Retirement Funds Committee of the Employer is responsible for administration and management of the Plan. All investments of the Plan are participant-directed. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Fidelity Management Trust Company ("Fidelity") serves as the trustee and also provides recordkeeping services.

Eligibility: Under the Plan, all eligible employees can begin making elective deferral contributions to the Plan upon attainment of age 21. Union employees whose employment and retirement is governed by a collective bargaining agreement, certain nonresident aliens who have no earned income from United States sources, as well as leased employees are excluded from participating in the Plan.

Vesting: Participants are immediately vested in their elective deferrals plus actual earnings thereon. All safe harbor and profit-sharing contributions are also immediately vested.

Contributions: Participants may contribute from 1% to 75% of defined compensation to the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants may also contribute amounts representing distributions from other qualified plans.

The Employer makes a profit sharing contribution to the Plan on behalf of eligible participants based on classification as defined by the Plan. The amount is discretionary and was equal to 6.8% of eligible compensation for the 2024 Plan year. Safe harbor contributions are also made by the Employer on behalf of eligible participants. These contributions were 5% of eligible compensation for the 2024 Plan year. Employer contributions are subject to certain IRC limitations.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Employer's profit sharing and safe harbor contributions, and Plan earnings, and are charged with withdrawals, Plan losses, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participant Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time directly through Fidelity.

Notes Receivable from Participants: Participants may borrow up to 50% of their vested accounts in the form of a note with a minimum amount of \$1,000 and a maximum amount of \$50,000. Notes are secured by the balance in the participant's account and bear interest at prevailing market rates at the time the funds are borrowed. The term of the notes cannot exceed five years, except for notes to purchase a principal residence in which case the term may not exceed ten years. At December 31, 2024, the interest rate on outstanding notes was between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions and as of December 31, 2024, the notes receivable outstanding are due in various amount through March 2031. A participant may only have one note outstanding at a time.

Benefits Paid to Participants: Upon termination of service due to death, disability, or retirement, each participant can receive their vested account balance in one lump-sum payment. If a participant's vested balance is \$5,000 or less, the participant will receive a single distribution of their entire vested account balance. The Plan provides for the automatic rollover of vested participant balances above \$1,000, but less than \$5,000 into an individual retirement account if the participant does not elect to have the distributions paid directly to an eligible retirement plan in a direct rollover or to receive the distribution directly. Hardship withdrawals are also allowed, subject to the provisions specified in the Plan agreement. Participants may also receive in-service distributions after attaining the age of 59 ½.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants, the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statement as administrative expenses of the Plan. The Employer provides bookkeeping and other administrative services for the Plan at no charge. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net unrealized market appreciation or depreciation of investments and net realized gains and losses on the sale of investments during the period.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds and stable value collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity, overall market volatility, global pandemic and international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability. In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the end of the reporting period.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in collective trusts are based on the net asset values per unit (NAV) as reported by the fund managers. **NOTE 5 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in compliance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds shares of mutual funds managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan’s trustee and recordkeeper and, therefore, these transactions and the Plan’s payment of trustee and recordkeeping fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer.

**NOTE 7 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.
