For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### **1. Description of Plan**

The following description of The Cypress of Charlotte Club, Inc. Retirement Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering all eligible employees of The Cypress of Charlotte Club, Inc. ("the Company") who are 21 years of age or older and completed a minimum of one year of service in which at least 1,000 hours are worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Under the SECURE Act of 2019, any employees who are age 21 and complete 500-999 hours in three consecutive 12-month periods, become eligible to make employee deferrals effective January 1, 2024. Secure 2.0 Act of 2022 shortens that period to two consecutive 12-month periods effective January 1, 2025.

#### ***Contributions***

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes 50 percent of the first 4 percent of eligible compensation that a participant contributes to the Plan. The Company may also make a discretionary contribution. No such discretionary contributions were made in 2024. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts, collective investment trust funds, and mutual funds as investment options for participants. Each participant's account is credited with an allocation of (a) the Company's contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests 20 percent per year starting at two years of service, and is 100 percent vested after 6 years of service.

#### ***Notes Receivable from Participants***

Participants may borrow from their elective deferral contribution and rollover contribution accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

## ***Payment of Benefits***

On termination of service due to death, disability, or normal retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in fixed installments. Early retirement is permitted for participants that attain age 55 with six years of vesting service. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows distributions for reasons of hardship, in addition to in-service withdrawals for participants who have attained age 59 ½.

## ***Forfeited Accounts***

Upon termination of employment and distribution of a Participant's entire vested account balance for any reason other than death or permanent disability, the non-vested Company contributions on their behalf are forfeited and used to pay administrative expenses and to reduce any required Company contributions. As of December 31, 2024 and 2023, forfeitures account balances amounted to \$0. Forfeitures of \$5,958 were used to offset the employer contributions and \$73 was applied to Plan expenses during 2024.

## ***Operating Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. During 2024, loans amounting to \$7,585 were defaulted upon termination of the participants.

### ***Payment of Benefits***

Benefits are recorded when paid.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company as certifying entity, and as agent of Principal Global Investors Trust Company, the trustee of the collective investment trust funds, have certified that the following data included in the accompanying financial statements is complete and accurate.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Shares of pooled separate accounts are valued at the net asset value of units held by the Plan at year end as a practical expedient.

Collective Investment Trust Funds - The plan invests in a stable value fund which holds other collective investment trust funds, investment contracts, and synthetic investment contracts. The fair value of underlying conventional investment contracts are determined using a discounted cash flow methodology. The underlying synthetic investment contracts are generally valued at fair value based on market values obtained from independent pricing services, quotes by dealers who are market makers in these securities, or by a methodology approved by the Trustee. The stable value fund as a whole is valued at its net asset value as a practical expedient.

Mutual Funds - The mutual funds are registered investments traded on public exchanges and are valued at NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

## 7. Tax Status

The Plan was restated effective February 17, 2022, and received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

## 9. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 10. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of pooled separate accounts, mutual funds, and collective investment trust funds managed by Principal Trust Company and Principal Life Insurance Company. Transactions with these parties qualify as party-in-interest transactions.

## 11. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to add the SECURE 2.0 provision for emergency expenses withdrawals up to \$1,000 from a participant's vested account. The Plan was also amended to add a Roth provision and remove the hours requirement for eligibility.
