Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Open Sky Education 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Open Sky Education 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan, as established effective October 15, 2012, is a defined contribution plan which provides retirement benefits to eligible employees of Open Sky Education, Inc. (the Company). All employees are eligible to participate in the Plan, except employees who normally work less than 20 hours a week. Participants may join the Plan immediately. The Plan is subject to the provisions of ERISA.

Contributions

The Plan permits each participant to contribute up to a maximum annual amount specified by the Internal Revenue Code (IRC). The Plan also permits employees to make catch-up contributions if they meet certain criteria specified by the IRC. Effective January 1, 2023, the Company makes safe harbor matching contributions equal to 100% of the participant's contributions up to 6% of his or her compensation. The Company is also allowed to make discretionary contributions under the Plan. The Company did not make any discretionary contributions in 2024.

Effective January 1, 2023, the Plan terminated the automatic enrollment and automatic increase provisions of the adoption agreement for newly eligible participants. Prior to January 1, 2023, eligible participants who have not made an elective deferral election were automatically enrolled in the Plan with pre-tax contributions being set at 1% of their compensation unless affirmatively declined by the participants. Participant contributions would be automatically increased by 1% of their compensation every July 1st to a maximum of 5%, unless opted out by the participant.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses, and charged with withdrawals and an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Investment options include various mutual funds. Each participant is responsible for designating their contributions and Company contributions for investment among the available investment funds.

Vesting

A participant is fully vested immediately as to voluntary salary deferrals, rollover contributions, Company safe harbor matching contributions and related earnings or losses. Employees become fully vested in all other contribution upon completion of three years of service. Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative expenses and to reduce future Company contributions. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$15,098 and \$26,694, respectively. Total forfeitures used to reduce administrative expenses were \$29,833 in 2024. Total forfeitures used to reduce Company contributions were \$12,923 in 2024.

Notes Receivables from Participants

The Plan permits participants to borrow from their accounts. Loans are available to all participants. A participant may borrow an amount not to exceed the lesser of 50% of his or her vested account balance or \$50,000. Loans bear a rate of interest at 1% above the USA Today published prime rate. The minimum loan amount is \$1,000. The maturity date shall not exceed 15 years. As of December 31, 2024 and 2023, the interest rate on outstanding loans was between 4.25% - 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or retirement (age 59½), the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments over a specified time. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$7,000, the Plan administrator will authorize the benefit payment without the participant's consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to management of Plan assets, administration of notes receivable from participants, and benefit payments are shared directly to the participant's account and are included in administrative expense.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF THE INVESTMENT INFORMATION

Ascensus, LLC, as agent for Ascensus Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establishes a hierarchal disclosure framework which prioritizes and ranks the level of observable inputs used in measuring fair value.

Additionally, accounting principles generally accepted in the United States of America defines fair value as the price that would be received upon the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan primarily applies the market approach for recurring fair value measurements and attempts to utilize the best available information. Accordingly, the Plan also utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan is able to classify fair value balances based on the observability of those inputs. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The Plan's assets measured at fair market value are classified in one of the following categories:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 FEDERAL INCOME TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are on the recordkeeper's platform. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the recordkeeping services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

NOTE 9 NONEXEMPT TRANSACTIONS

The Plan failed to remit employee 403(b) deferral contributions for certain payroll periods as soon as administratively feasible. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Plan is in the process of correcting the prohibited transactions, including depositing the lost earnings in participant accounts.
