## **INDEPENDENT AUDITOR'S REPORT**

To the Management of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Four Seasons Heating, Inc. 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Four Seasons Heating, Inc. (the Company) 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### *General Information*

The Company established the Plan as a defined contribution plan designed to comply with section 401(k) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The owner and manager is responsible for oversight of the Plan. Management determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### *Eligibility*

The Plan covers all full-time employees of the Company who have completed three months of service providing they worked at least 240 hours during such plan year and are age 18 or older. Participants who do not have at least 240 hours of service during the initial period must complete 1,000 hours of service in the subsequent year. Participants who have not met the service requirements or are not employed on the last working day of the Plan year are generally not eligible for an allocation of Company contributions for such year.

##### *Certification*

The Plan custodian has certified to the accuracy of the investment transactions, recognition of income, expenses and assets held as of December 31, 2024.

##### *Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan currently offers various mutual funds as investment options for participants. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches contributions equal to 100% of participant contributions that are not in excess of 3% of base compensation plus 50% of contributions that exceed 3% but are not in excess of 5% of base compensation that a participant contributes to the Plan. The matching Company contribution is invested in the same manner and proportion as the employee contributions. Additional profit-sharing amounts may be contributed at the discretion of the Company's trustee and are invested in the same manner as the employer matching contributions. During the year ended December 31, 2024 the Company did not make any discretionary profit sharing contributions to the Plan. Contributions are subject to certain IRS limitations.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 – DESCRIPTION OF PLAN (Continued)

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set as 1% above the Wall Street Journal prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

##### *Payment of Benefits*

On termination of service due to reasons other than death, a participant with a vested account balance less than \$1,000 will receive a lump-sum distribution in cash directly from the plan. Participants with vested account balances of at least \$1,000 but less than \$5,000 may elect to receive either a lump sum distribution in cash or roll over the distribution to an individual retirement account (IRA) or another qualified plan. Participants with vested account balances of at least \$5,000 may elect to receive a lump sum distribution in either cash or as a roll over or may leave the balance in the plan until such time as applicable federal law requires distributions to be made. For termination of service for reasons of death, a participant's beneficiaries may receive the value of the vested interest in their account as a lump sum distribution in cash or as a roll over to an IRA.

##### *Asset Holding Account*

As of December 31, 2024, the asset holding account totaled \$6,633. This account will be used to pay future expenses of the Plan's administration and is funded through annual fees charged to the plan for investment management as part of the custodial arrangement.

##### *Administrative Expenses*

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan. However, in 2024 the Plan began paying certain expenses from the asset holding account. Expenses paid by the Plan for the year ended December 31, 2024 were \$25,714.

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting from information provided by the Company, the plan administrator, and the custodian.

##### *Use of Estimates*

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the

##### *Use of Estimates (Continued)*

liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policy utilizing information provided by the third-party administrator, the investment advisors, and the custodian.

##### *Investment Valuation and Income Recognition (Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions that needed to be distributed for the year ended December 31, 2024.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Expenses paid by the Plan for the year ended December 31, 2024 were \$25,714.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments.

The following is a description of the valuation methodologies used for assets measured at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. All plan investments are Level 1 assets. There have been no changes in the methodologies used for the year ended December 31, 2024.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments. There are no plan assets requiring use of Level 2 or 3 inputs. The Plan's policy is to recognize transfers of investments into or out of Level 2 or 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 2 or 3.

#### NOTE 4 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Capital Bank and Trust Company. Capital Bank and Trust Company, (the custodian) is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Effective January 1, 2024, the custodian provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and the custodian. The custodian receives revenue from mutual fund service providers for services the custodian provides to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan.

If the revenue received by the custodian from such mutual fund service providers exceeds the amount owed under the MSA, the custodian remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or plan sponsor may make a payment to the custodian for administrative expenses not covered by revenue sharing.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian of the Plan.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Capital Bank and Trust Company.

#### NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 7 - TAX STATUS OF PLAN

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024 the Plan's sponsor-maintained bond coverage was \$500,000.
