To the Participants and Plan Administrator of the Elemica, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Elemica, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Elemica, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. Description of Plan

The following description of the Elemica, Inc. 401(k) Plan (the “Plan”) provides only general information. The Plan became effective on January 1, 2010. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Elemica, Inc. (the “Company”) who have attained the age of 21. Employees who are union, non-resident aliens, acquired in a Code section 410(b)(6)(C) transaction, leased employees and interns are ineligible to participate in the Plan. Salary deferral eligibility requirements for these employees have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (“SECURE Act 2.0”). Eligible employees may enter the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for rollovers from other qualified plans. Effective January 1, 2024, the Plan was amended and restated to add an automatic enrollment provision of 3% upon becoming eligible (see Note 10).

The Plan provides for a safe harbor matching contribution equal to 100% of employee deferrals up to 3% of compensation, plus 50% of employee deferrals that exceed 3% of compensation but do not exceed 5% of compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and safe harbor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

Vesting

A participant, at all times, has a fully vested (100%) interest in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) contributions, rollover contributions, and safe harbor matching contributions from the Company, plus actual earnings thereon.

Forfeited Accounts

Generally, participants are fully vested in their accounts; however, forfeitures may occur as a result of miscellaneous corrections from annual compliance testing. Forfeitures are generally used to pay administrative expenses or to offset any employer contributions. The total unallocated forfeiture account balance was \$1,561 and \$29,641 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$28,282 of forfeitures were used to offset employer contributions and \$0 were used to pay expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum amount equal to \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime interest rate on the effective date of the note. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. A participant may have up to one loan outstanding at any given time.

Payment of Benefits

On termination of service due to death, disability, attainment of normal retirement age (59.5), early retirement (age 55 and five years of service) or separation from service, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a distribution is not requested and the balance is between \$1,000 and \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0") the account balance will be transferred by the Plan administrator to an individual retirement account established on behalf of the participant. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In-service and hardship distributions are also permitted from participant accounts, based on the terms of the Plan document.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian, trustee, insurance company and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and safe harbor matching contributions from the Company, are recorded in the year in which employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by Qualified Institutions

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, qualified institutions, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contract, at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, guaranteed investment contract, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds (registered investment companies) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan holds the Massachusetts Mutual Life Insurance Company ("Mass Mutual") Guaranteed Interest Account ("GIA") a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest credited, less participant withdrawals, and administrative expenses.

The GIA is a group annuity contract and is backed by the general account of Mass Mutual. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed minimum interest rate is 1%.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Limitations exist related to excessive trading and for transfers to or from competing funds. Certain events (including but not limited to termination of the contract, Plan disqualification, Plan termination or breach of the contract) might limit the ability of the Plan to transact at contract value with the contract issuer. In the event the Plan sponsor wishes to terminate the contract, the notice period may range up to ninety calendar days. Upon occurrence of such an event, a market value adjustment or withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the group fixed annuity contract values for credit risk of the contract issuer or otherwise. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value via a market value adjustment and/or limit the amount which may be transferred out of the GIA via requiring a five-year or ten-year annual installment transfer periods as detailed in the contract. Mass Mutual may also terminate the contract with advance written notice of at least ninety calendar days.

6. Tax Status

Effective January 1, 2024, the Plan adopted a Limestone Pension Associates, LLC volume submitter defined contribution plan. The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the pre-approved plan document as then designed was in accordance with applicable Internal Revenue Code ("IRC") requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Related-Party and Party-In-Interest Transactions

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower") provide custodial and recordkeeping services to the Plan. Plan investments include a guaranteed investment contract managed by Empower (which acquired the retirement services business of Mass Mutual). Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, these qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Fees paid by the Plan amount to \$87,377 for the year ended December 31, 2024.

During 2023, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$193 within the period prescribed by the Department of Labor regulations. During 2025, the Company made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the processing delays and filed a Form 5330 with the Internal Revenue Service to pay the applicable excise tax. The Company believes that these transactions do not affect the tax status of the Plan and took action prescribed by the regulations to remedy such errors.

During 2024, the Company failed to remit to the Plan's custodian certain employee contributions and loan repayments totaling \$77,270 within the period prescribed by the Department of Labor regulations. During 2025, the Company corrected \$75,789 of late remittances by making contributions to the affected participants' accounts to compensate those participants for potential lost income due to the processing delays and filed a Form 5330 with the Internal Revenue Service to pay the applicable excise tax. During 2025, the Company plans to correct the remaining \$1,481 of late remittances by making contributions to the affected participants' accounts to compensate those participants for potential lost income due to processing delays. The Company believes that these transactions do not affect the tax status of the Plan and has taken actions prescribed by the regulations to remedy such errors.

10. Plan Amendments

Effective January 1, 2024, the Plan was amended and restated for the following:

- Provide for an automatic enrollment provision of 3% upon becoming eligible;
- Provide for in-Plan Roth rollovers;
- Update the definition of compensation.

11. Subsequent Events

Effective January 1, 2025, the Plan was amended and restated through the adoption of a Dunbar, Bender & Zapf, Inc. pre-approved defined contribution plan. Changes to the Plan included updating the determination period for Safe Harbor Matching contributions to on an annual basis, adopting required statutory provisions, and making other general administrative changes.

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.
