### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of C.T.I. Pension Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C.T.I. Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

#### **1. Description of Plan**

The following description of the C.T.I. Pension Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan that covers employees of C. Thorrez Industries, Inc. and affiliated companies (Company or Plan Sponsors). Affiliated companies include Legends Manufacturing, Inc., Synchronous Manufacturing, Inc., Concord Manufacturing, Inc., Belgian Screw Machine Products, Inc., and Stockbridge Manufacturing, Inc. The Plan will count service with Dawlen Corp, a predecessor employer. The Plan does not provide for participant-directed investments. Participants must complete 1,000 or more hours of service within the 12 consecutive-month period commencing with the date of hire to participate in the Plan. Collectively bargained employees and nonresident aliens are excluded from Plan participation.

Entry dates to the Plan are January and July 1<sup>st</sup> of each year. Unless otherwise elected by the participant, participants are automatically enrolled in the Plan with a 1% deferral. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Participants may contribute up to 75% of their annual compensation, subject to a maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined benefit contribution plans. The Company contributes 25% (for employees under 55 years of age) or 50% (for employees 55 years of age and over) of employees' contribution based on the first 6% of the participants' eligible wages.

In addition, the Plan allows for the Company to make a discretionary contribution. For the 2024 and 2023 plan years, the Company paid a discretionary contribution of 2% of the participant's annual compensation (regardless if the employee made deferrals into the Plan) and in certain circumstances, additional contributions. In order to receive the discretionary contribution, the participant was required to be employed on the last day of the plan year, as defined in the Plan document, unless the participant dies, becomes disabled, or retires. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### 1. Description of Plan (continued)

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Plan's Sponsors' discretionary contribution (if and when made), and Plan earnings, and charged with an allocation of Plan administrative expenses. Plan earnings and administrative expenses are allocated based on the ratio of each participant's account balance to the total account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participant contributions to the Plan and earnings thereon are immediately vested in their accounts. Vesting in the Company's matching and discretionary contributions is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service in accordance with the vesting schedule below, as outlined in the Plan document. Regardless of the vesting schedule, employees 65 years of age and over are fully vested.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan deems the note receivable to be in default, the participant note receivable is reduced and a benefit payment is recorded.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances under certain circumstances, as defined in the Plan document. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan. Principal and interest is reimbursed ratably through payroll deductions.

#### **1. Description of Plan (continued)**

##### **Payment of Benefits**

Upon termination of service due to retirement, disability, or death, a participant may elect a lump-sum distribution equal to the value of his or her account or may elect to receive installment payments, a life annuity, or a joint and survivor annuity as defined by the Plan agreement. For termination of service for other reasons, a participant may receive a lump-sum distribution as soon as administratively feasible on or after the first anniversary of the participant's termination. Participants who have reached age 59 ½ may withdraw all or any part of their vested account at any time. Early retirement is also allowed at age 63 with 20 years of service or age 60 with 30 years of service.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$924 as of December 31, 2024 and \$410 as of December 31, 2023. Forfeited nonvested accounts are used to reduce employer contributions or pay administrative expenses. The Plan utilized forfeited accounts totaling \$1,170 in 2024 (\$5,946 in 2023) to fund employer contributions.

##### **Administrative Expenses**

The Plan pays the asset management, trustee, and record keeping fees of the Plan. Additional fees for processing participant loans are paid by the Plan. Certain Plan administrative expenses, including salaries, legal, and accounting, are paid by the Company and qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from estimated amounts.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. See Note 4 for discussion of fair value measurements and investment valuation. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The change in the aggregate fair value and the cost of investments sold, purchased, and held is reflected in the statements of changes in net assets available for benefits as net appreciation in fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Plan management has evaluated subsequent events through October 8, 2025, the date these financial statements were available to be issued.

## **3. Financial Information Certified by the Trustees (Unaudited)**

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including the investment balances, accrued income, interest and dividend income, and net appreciation in fair value of investments was obtained by management and agreed to or derived from information certified as complete and accurate by Huntington Bank (January 1, 2023 through January 12, 2024) and Charles Schwab Trust Bank (Charles Schwab) (January 13, 2024 through December 31, 2024). In addition, Huntington Bank certified the notes receivable from participants balance as of December 31, 2023. This certified information has not been audited by independent auditors.

## **4. Fair Value Measurements**

As defined in the current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The guidance is applicable to all financial instruments that are measured and reported on a fair value basis. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

#### 4. Fair Value Measurements (continued)

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a company's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Unitized funds* – These funds are valued at the net asset value (NAV) as a practical expedient. The funds are managed by Alta Trust with the NAV calculated daily based on purchases, redemptions, fair value of holdings, and other transactions. Alta Trust calculates the unit value for the account; participants transact at this unit value. The Plan transacts at the underlying investment level. The funds are in pooled investment vehicles. The underlying investments of the unitized funds are level 1 investments consisting primarily of cash, exchange-traded funds, bonds, mutual funds, and equity funds. There are no unfunded commitments or restrictions, except 30-days written notice to terminate the Alta Trust contract. There are no redemption restrictions or notice periods.

*U.S. government securities, U.S. treasury bonds, and common equity securities* – Valued at the closing price reported in the active market in which the individual securities are traded.

*Corporate and foreign bonds* – Valued at the closing price reported in the active market in which the bond is traded or based on recent transactions, broker quotations, or bond spread information.

*Mutual funds* – Shares held in mutual funds traded on national securities exchanges are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at year end. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, then divided by the number of shares outstanding. Funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Money market accounts and cash equivalents* – Valued at the closing price reported in the active market in which the individual securities are traded in which cost approximates fair value.

#### 4. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-In-Interest Transactions**

During 2023 and through January 12, 2024, certain Plan investments were managed by Huntington Bank. Starting January 13, 2024, certain Plan investments were managed by Charles Schwab. Huntington and Charles Schwab served as the trustees as defined by the Plan. Fees paid by the Plan to the trustees for recordkeeping, administrative, and other services rendered were \$35,174 for the year ended December 31, 2024 (\$113,428 for the year ended December 31, 2023). In parts of 2023, the Plan also invested in Huntington Bancshares Inc. (a common entity to Huntington Bank). Also in 2023, the Plan invested in money market accounts managed by a common entity to Huntington, therefore these investments qualify as party-in-interest investments. The Plan recordkeeper is Epic Advisors. Notes receivable from participants are also considered party-in-interest transactions. The unitized investment funds are managed by Alta Trust. Andrews Hooper Pavlik PLC is the Plan auditor.

#### **6. Income Tax Status**

The Plan has adopted a prototype plan document. The plan document has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Generally, tax years 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

#### **7. Plan Termination**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
