Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Kelberman Center, Inc. 403(b) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan under section 403(b) of the Internal Revenue Code (the "IRC") available to all employees of Kelberman Center, Inc. (the "Organization"), who meet certain eligibility requirements. The Plan commenced operations on January 1, 2022. The Organization is the sponsor of the Plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal") is the custodian and recordkeeper of the Plan's assets. Actuarial Pension Analysts, Inc. ("APA") is the third-party administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees, excluding non-resident aliens and students who are considered student-teachers, student aid, or students who are temporary employees while attending school, are eligible to begin salary deferrals on their first day of hire pursuant to a properly completed and valid salary reduction agreement entered into by the employee.

Notes Receivable from Participants

Participants may not borrow from their accounts under the Plan. Notes receivable represent legacy borrowing by participants from their previous plan. Legacy notes bear interest at rates of 4.25%-6.50%.

Contributions

Participants may make voluntary contributions subject to certain limitations under the terms of the Plan and the IRC. Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC. The Organization makes discretionary matching contributions and non-elective contributions.

The Organization made matching contributions of 100% on the first 7% of salary reduction for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contributions, an allocation of Plan earnings/losses on all contributions, and expenses. Allocations are based on participant earnings/losses or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately fully vested in their voluntary contributions and actual earnings/losses thereon. Participants are vested in employer contributions according to the following schedule:

Payment of Benefits

Upon termination of service due to death, retirement or other reasons, a participant or beneficiary receives an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in periodic payments if the vested balance exceeds \$5,000. Participants who have reached age 59½ may take in-service distributions.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's elective deferral account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Forfeitures

Forfeitures of non-vested account balances of \$12,164 and \$17,062 were used to pay Plan administrative expenses for the year ended December 31, 2024 and 2023, respectively. Forfeitures of non-vested account balances of \$0 and \$11,439 were used to reduce employer contributions for the year ended December 31, 2024 and 2023, respectively. The total forfeited non-vested balance as of December 31, 2024 and 2023 was \$4,824 and \$4,485, respectively, which will be used to reduce future employer contributions or administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Notes receivable represent legacy borrowing by participants from their previous plan. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments

The Plan's investments are stated in the accompanying financial statements at fair value except for the funds held in insurance company general accounts, which are stated at contract value. The fair value is equal to quoted market value on a national exchange for mutual funds. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of fair value hierarchy under these standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs, other than quoted prices in active markets, that are observable either directly or indirectly and fair value is determined through the use of models or other valuation methodologies.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the asset or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: valued at the closing price on the active market which the funds are traded.

The Plan administrator assesses and approves the fair value measurement policies and procedures on a continuing basis. Periodically, the Plan administrator determines if the current valuation techniques used in the fair value measurements are still appropriate. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefit payments to participants are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administration Expenses

Substantially all administrative expenses associated with the Plan are paid by participants. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Principal Life Insurance Company, the Prudential Guaranteed Option (PFIGO). Principal maintains the contributions in a group annuity (general account). PFIGO contracts are reported at contract value. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. The guaranteed minimum interest rate is 1.55% as of December 31, 2024 and 2023. The crediting interest rate is based on a formula agreed upon with Principal. Under the terms of the existing contract, the crediting rate is currently reset on a semiannual basis. Changes in future interest crediting rates will not affect the amount reported on the statement of net assets available for benefits representing the adjustment for the portion of net assets attributable to fully benefit-responsive investment contracts from fair value to contract value, as fair value is considered book value less early withdrawal charge. PFIGO is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

By definition, PFIGO is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. The contract will terminate on the date when no current deposit arrangements have been made and there are no guaranteed interest funds with a value greater than zero under the contract. Provisions relating to annuities in course of payment would continue to govern payment of such annuities until the final payment under each such annuity is made. Principal has the right to no longer receive deposits; however, they must still make payments as described above. PFIGO offers plan participants stability of principal and a declared interest rate. This contract guarantees principal and provides a stated rate of return backed by the General Account of Principal. Due to the nature of these contracts, they do not have specific underlying assets assigned. There are no redemption restrictions or unfunded commitments related to this investment.

5. INVESTMENTS

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and non-forfeitable. All distributions would be made in accordance with any applicable requirements of the ERISA and the IRC.

7. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan administrator believes that terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the IRC. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

8. TRANSFER OF ASSETS

During 2022, certain employees of an unrelated organization became employees of the Organization. In conjunction with the transfer of these employees, the Plan accepted transfer from a plan sponsored by the unrelated organization of investments of \$4,417,179 and participant loans of \$65,351 for total balances of \$4,482,530. During 2023, total transfers into the Plan were \$720,484. There were no transfers into the plan in 2024.

9. PARTY-IN-INTEREST TRANSACTIONS

Principal is the custodian of the Plan, and the Organization is the sponsor. As such, transactions between Principal and the Organization and the Plan qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, these related transactions qualify as party-in-interest transactions.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
