Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Liberty Hospitality Partners LP 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion on whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with

GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN:

The following description of Liberty Hospitality Partners LP 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all nonunion employees of Liberty Hospitality Partners, LP (Company) and partnerships and corporations which are members of the related controlled group (collectively, the Companies) who have attained 18 years of age and have completed one year of service, as defined. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Custodian

Effective November 1, 2024, the Plan changed its custodian and recordkeeper from Equitable Financial Life Insurance Company (Equitable) to Principal Life Insurance Company (Principal). Plan assets transferred to Principal were transferred into funds comparable to those offered by Equitable. The conversion initiated a blackout period beginning November 15, 2024, and continued through December 15, 2024. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, and the contributions were deposited and invested during the blackout period. At the end of the blackout period, these funds were transferred to Principal and invested in funds, as requested by each participant.

Contributions

Each year participants in the Plan may contribute up to the maximum annual amount allowable by the Internal Revenue Code (IRC) of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Companies contribute a percentage of the participants' elective contribution which is established annually. In addition to these contributions, the Companies may, at the discretion of the Companies' management, make additional contributions to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers one pooled separate account, thirteen collective investment trusts, eighteen mutual funds, and one guaranteed interest option as investment options for participants. Contributions are subject to certain IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Companies contributions, Plan earnings and forfeitures of terminated participants' nonvested accounts. Participants accounts are charged with administrative expenses that are paid by the Plan and reduced by distributions to participants. Allocations are based on participant earnings, account balances or specific participant transactions, as

defined. Any asset transfers from or to other retirement plans are also credited or charged to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to pay plan expenses or to reduce future funding of employer contributions. Forfeited nonvested accounts totaled \$30,435 and \$27,353 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$14 were used to pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and capital gain distributions.

Payment of Benefits

Benefit payments, including payments to participants and direct rollovers to other retirement plan accounts, are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to custodial and recordkeeping services are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has traditional investment contracts with Principal and Equitable for the years ended December 31, 2024 and 2023, respectively. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the traditional investment contracts held by the Plan as of December 31, 2024 and 2023:

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer, but it may not be less than .15% or more than 3% as of December 31, 2024 or less than 1.75% as of December 31, 2023. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include plan termination, contract termination by the plan sponsor, and other withdrawals deemed to be plan sponsor directed as defined by the contract. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts permit the insurance company to terminate the agreement.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at net asset value (NAV) as determined by Principal and Equitable, the custodians of the Plan, for the years ended December 31, 2024 and 2023, respectively.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right

to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION:

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. TAX STATUS:

The Companies adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) which stated that the prototype was acceptable under section 401 of the IRC for use by employers for the benefit of their employees. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. INFORMATION CERTIFIED BY CUSTODIANS (UNAUDITED):

At December 31, 2024 and 2023, the Plan's investments were held by Principal and Equitable, respectively, the custodians of the Plan. The following is a summary of the Plan's financial statements based on information certified by Principal and Equitable, for the years ended December 31, 2024 and 2023, respectively, as complete and accurate in accordance with Section 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

9. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are managed by Principal and Equitable, the custodians, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets held at end of year.

Equitable provided recordkeeping and administrative services to the Plan. Fees paid by the Plan to Equitable for recordkeeping and administrative services amounted to \$41,926 for the year ended December 31, 2024.

Principal provides recordkeeping services to the Plan. Fees paid by the Plan to Principal for recordkeeping services amounted to \$3,437 for the year ended December 31, 2024.

Lifestyle Retirement Company (Lifestyle) provides certain administrative services to the Plan. Fees paid by the Plan to Lifestyle for administrative services amounted to \$376 for the year ended December 31, 2024.

The Company pays directly any other fees related to the Plan's operations.

10. PLAN RESTATEMENT:

Effective April 3, 2024, the Plan changed the third-party administrator from Equitable to Lifestyle, which included the adoption of a new plan document that restated the Plan effective August 1, 2024. The Plan received a favorable opinion letter dated June 30, 2020 from the IRS which stated that the non-standardized pre-approved profit sharing/money purchase/CODA plan was acceptable under Section 401 of the IRC for use by employers for the benefit of their employees.

11. PLAN AMENDMENTS:

Effective January 1, 2024, the Plan was amended to comply with the required SECURE 2.0 Act provision related to discontinuing Roth required minimum distributions prior to a participant's death and the voluntary SECURE 2.0 Act provisions related to increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000.

12. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to comply with the required SECURE 2.0 Act provision related to reducing years of service for eligibility of long-term part-time employees from three consecutive years of at least 500 hours to two consecutive years of at least 500 hours.


