Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of The Arc Morris County Chapter, New Jersey, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the Plan:

The following description of the 403(b) Thrift Plan for Employees of the Arc/Morris County Chapter, New Jersey, Inc. ("Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan sponsored by the Arc/Morris County Chapter, New Jersey, Inc. ("Company" or "Plan Sponsor"). The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan's assets were held by Mutual of America Life Insurance Company from January 1, 2023 through December 31, 2024, and are held by Ascensus, LLC from September 1, 2023 through December 31, 2024, (the "Trustees"), who are responsible for the custody and management of the Plan's assets.

Eligibility - Substantially all full-time employees of the Company who have attained the age of 21 and have completed 1,000 hours and one year of service are eligible to participate in the Plan and receive discretionary matching contributions. There is no minimum age or service requirement to make salary reduction contributions. Enrollment in the Plan occurs immediately upon satisfaction of the requirements.

Contributions - Eligible employees may elect to contribute voluntarily through payroll deductions, subject to certain limitations. In 2024, eligible employees may elect to contribute up to 100% of their salary to a maximum of \$23,000 and employees over the age of 50 can elect to contribute an additional \$7,500. Participants may make elections to invest their account balances and contributions made during the year among various types of investment accounts. Based on the election of the participant, contributions to the Plan may be pre-tax or after-tax pursuant to Section 401(k) of the Internal Revenue Code (IRC).

The Company may make discretionary matching contributions based on eligible participants' compensation. For the year ended December 31, 2024, the Company elected to make discretionary contributions equal to 5% of the participant's compensation. Beginning in September 2023, the Company elected to make discretionary contributions equal to 100% of the participant's elective deferral, not to exceed 3%. Additional amounts may be contributed to the option of the Company's board of directors and are invested in a portfolio of investments as directed by the Company. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution, employer's discretionary match, if applicable, and an allocation of (i) Plan earnings and (ii) administrative expenses. Allocations are based on participant earnings and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer discretionary matching and profit-sharing contribution is based on continuous service. A participant will vest in the employer discretionary match upon the completion of three years of vesting service.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be applied to reduce the employer's matching contributions or also may be used to pay the Plan's administrative expenses. There were no forfeitures utilized to pay Plan administrative expenses or used to reduce employer contributions during 2024. There were unallocated forfeitures as of December 31, 2024 of \$37,963.

Payment of Benefits - On termination of service, the Plan provides for a participant to have the option to receive all or any portion of eligible rollover distribution either (i) paid directly to the participant in the form lump sum or installment payments or (ii) paid in a direct rollover to an individual retirement account or another employer plan. Amounts are not distributable except by reason of retirement, death, disability and separation from service, hardship or the attainment of age 59 1/2.

Money Market Fund - Money market fund includes highly liquid short-term investments purchased with maturities of three months or less.

Plan Amendments - The Plan was amended effective August 1, 2018 to include discretionary employer contributions. This was done to replace the Company's Employee Pension Plan, which was terminated in December 2018. Effective September 1, 2024, the Plan was amended to restate certain definitions in the Plan.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants is measured at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and benefit payment is recorded.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances of salary reduction contributions, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, funeral expenses of a parent, spouse or dependent, payments to repair a principal residence that would qualify as a casualty loss deduction and such other circumstances as the Plan Administrator may determine based upon rules set forth in the Internal Revenue Service (IRS) regulations.

Investment Valuation and Income Recognition - Investments are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 3 and 4 for a discussion of fair value and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Certain expenses incurred in connection with general administration and investment advisory services are allocated to participants pro-rata based on the ratio of the participant individual account balance to the total of all account balances and also included in net appreciation of fair value of investments.

Risks and Uncertainties - Investment funds, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Date of Management's Review - The Plan Administrator has reviewed and evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements FASB ASC 820, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

- *Mutual Funds* - Valued at the closing price in the active market in which the fund is traded.
- *Money market fund* - Valued at the closing price of similar assets in the active market in which the similar assets are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023 there were no significant transfers in or out of Levels 1, 2 or 3.

Note 4 – Guaranteed Investment Contract with Insurance Company:

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contracts meet the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the

Plan by Mutual of America Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract on December 31, 2024 and 2023 was \$376,694 and \$424,069 respectively. The crediting interest rate is based on a formula agreed upon with the issuers. The rate is 1.0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Mutual of America Life Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5 - Party-in-Interest:

During 2024, certain Plan investment transactions were recorded by Ascensus LLC and Mutual of America Life Insurance Company ("Trustees"). The Trustees provide administrative services related to benefit payments and investment advisory services and these transactions qualify as party-in-interest.

Note 6 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 7 - Tax Status:

The Internal Revenue Service has determined and informed the Company by a letter dated July 10, 2003, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8 - Information Certified by the Trustee:

The Plan Administrator has elected the method of reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Ascensus LLC and Mutual of America Life Insurance Company, the Trustees, have certified that the following information included in the financial statements and supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c) Schedule H, Part IV, Line 4i - Schedule of Investments (Held at End of Year), as of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 9 – Notes Receivables from Participants:

Participants may borrow between the minimum of \$1,000 up to the lesser of \$50,000 or 50% of their respective vested account balances and may only have two loans outstanding at a given time. The loans are secured by the balance in the participants' account and bear interest at the prevailing prime rate plus 1% on the origination date of the loan. Principal and interest is generally repayable through payroll deductions within five years, unless the loan provides funding for the purchase of the participant's principal residence in which case it is payable over twenty years.
