## INDEPENDENT AUDITOR'S REPORT

To the Trustees  
**Nextten Stauer, LLC 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Nextten Stauer, LLC 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTE 1: DESCRIPTION OF PLAN

The following description of Nextten Stauer, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all non-union employees of Nextten Stauer, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and Internal Revenue Code ("IRC"). The Company is the administrator and sponsor of the Plan. The Plan is a defined-contribution plan established on June 8, 2015.

**Eligibility:** Employees are eligible to participate if they have completed three consecutive months of employment, employees may enter the Plan beginning on the first day of the quarter (January 1, April 1, July 1, or October 1). Employees are eligible to contribute to the Plan pursuant to an earnings reduction agreement with the Company. Employees are credited with a year of service at the end of the twelve-month period beginning on the date of their hire if they have been credited with at least 1,000 hours of service during such period.

The Plan also has a discretionary matching and profit-sharing program. Employees are eligible to participate in the matching program if they are employed on the last day of the Plan quarter. Employees are eligible to participate in the profit-sharing program if they are employed on the last day of the Plan year and, if they are terminated, will only share in the profit if they are credited with more than 500 hours of service during the Plan year.

**Contributions:** Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Additionally, participants may elect Roth 401(k) contributions of up to 100% of after-tax compensation. Participants may also roll over amounts representing distributions from other qualified plans. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an automatic deferral feature. Accordingly, the Plan will automatically withhold a portion of a participant's compensation from each payroll period and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the participant makes a contrary election. The amount to be automatically withheld from the participant's pay each payroll period will be equal to 8% of their compensation, and that amount will continue to be automatically withheld from their pay in succeeding Plan years and increase by 1% per year up to maximum of 10% unless the Company amends the Plan or the participant enters into a salary reduction agreement.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of a participant's elective deferrals each Plan year quarter. Each year, the Company will determine the formula for the discretionary matching contribution. For the years ended December 31, 2024 and 2023, the Company matched 30% of the participant's first 8% of their elective deferrals.

**NOTE 1: DESCRIPTION OF PLAN (CONTINUED)**

At the discretion of the Company, nonelective profit sharing contributions can also be made. The contributions will be allocated among participants eligible to share in the contributions for the Plan year. This is determined by the nonelective profit sharing contribution amount multiplied by the participant's compensation percentage from total compensation of all participants eligible to share. The Company did not make discretionary profit-sharing contributions in 2024 and 2023.

Contributions are subject to annual limitations prescribed by the IRC.

**Participant Accounts:** Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and an allocation of (a) the profit-sharing contribution and (b) Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 or more years	100%

Participants' interest in their accounts shall become 100% vested and non-forfeitable without regard to their credited years of service if they are employed by the Company at or after age 65, incur a permanent and total disability, or die while employed by the Company.

**Forfeited Accounts:** If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is moved from the participant's account into a forfeitures account. The balance in the forfeitures account may be used to reduce future employer contributions to the Plan or to pay any administrative expenses. At December 31, 2024 and 2023, there was approximately \$15,000 and \$6,000 of forfeited nonvested account balances in the Plan, respectively. During 2024 and 2023, approximately \$2,000 and \$28,000 was used to reduce the employer matching contributions, respectively.

### NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

**Notes Receivable from Participants:** Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through regular payroll deductions over a period not to exceed five years except when the loan is for the purchase of a principal residence for the participant.

**Payment of Benefits:** Upon termination of service due to death, disability, or retirement, a participant becomes fully vested in all of their account balances and may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Benefit payments are recorded when paid.

**Investment Options:** Participants direct the investment of contributions into various investment options offered by the Plan.

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements and supplementary schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

**Use of Estimates:** The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are stated at fair value, with the exception of the guaranteed investment contracts, which are stated at contract value. Shares of mutual funds are valued at the net asset value ("NAV") of shares by the Plan at year-end using quoted market prices. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation in fair value of investments.

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Administrative Expenses:** Plan administration expenses that have not been paid by the Company are paid by the participants of the Plan on a pro-rata basis, based on account balances or the number of participants. Other fees charged for participant loan activity and for transactions are paid by the participant or charged directly to the participant's account. These fees are included in the net appreciation in fair value of investments.

**Risks and Uncertainties:** The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits:** Benefit payments to participants are recorded when paid.

**Notes Receivable from Participants:** Participant notes receivable are valued at their unpaid principal balance plus accrued interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

**Uncertain Tax Positions:** GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 4: FAIR VALUE MEASUREMENTS

The Financial Accounting Standard Board (“FASB”) Accounting Standards Codification (“ASC”) 820, “*Fair Value Measurement and Disclosures*”, provides the framework for measuring fair value. The Framework provide a fair value hierarchy that priorities the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: GUARANTEED INVESTMENT CONTRACT**

In accordance with GAAP, investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan invests in a guaranteed investment contract that is fully benefit-responsive with the Custodian. The Custodian maintain the contributions in a general account. The account is credited with earnings on the underlying investments compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. In 2024 and 2023, the actual average yield earned by the Plan for the guaranteed interest contract was 1.66% and 1.48%. The guaranteed interest contract is charged for participant withdrawals and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment value. Contract values for the guaranteed interest fund that is fully benefit-responsive were \$493,893 and \$646,252 at December 31, 2024 and 2023, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **NOTE 5: GUARANTEED INVESTMENT CONTRACT (CONTINUED)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **NOTE 6: PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by Empower Retirement LLC, the third-party administrator of the Plan, and therefore, these investment transactions qualify as party-in-interest transactions. Fee expenses paid by the Plan to the Trustee, Custodian, and the third-party administrator for investment management services and record keeping services totaled approximately \$36,733 and \$16,392 for 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions. However, the ERISA regulations provide an exemption for such transactions.

### **NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate it at any time subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their employer contributions.

### **NOTE 8: TAX STATUS**

The Plan adopted the Empower Trust Company, LLC defined contribution pre-approved plan. The pre-approved plan obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.
