NOTE 1 - DESCRIPTION OF THE PLAN

The Mission Produce, Inc. 401(k) Savings Plan (the "Plan") was established on January 1, 1990 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees of Mission Produce, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Certain designated officers of the Company serve as the plan administrator. The assets of the Plan are held in a trust by Fidelity Management Trust Company.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

Company employees are eligible to participate in the Plan upon reaching age 21. Leased employees and nonresident aliens who do not receive any earned income from the Company which constitutes United States source income are excluded from becoming eligible to participate in the Plan.

B. Benefits

Benefits under the Plan begin when a participant retires, become disabled, dies or ceases to be an employee, and may be paid as a lump sum or installment payments. Normal retirement age is 65. Hardship withdrawals are permitted. In-service distributions are permitted for participants who are 59½ years of age from all vested account balances. Benefits are recorded when paid.

C. Vesting

A participant is fully vested immediately as to voluntary contributions, rollovers, related earnings and the Company's safe harbor matching contributions.

D. Contributions

Participants may contribute to the Plan through tax-deferred salary reductions of up to 60% of compensation, as defined in the Plan, up to a statutory maximum as determined by the Internal Revenue Code. Participants may contribute tax-deferred salary reductions of up to 80% of compensation. Participants may also contribute to the Plan through after-tax Roth deferral contributions up to the statutory maximum.

The Company makes "safe harbor" matching contributions equal to 100% of the first 3% of employee compensation deferred and 50% of the next 2% of employee compensation deferred, to a maximum matching contribution of 4% of eligible employee compensation. The Company may make matching contributions, other than "safe harbor" matching contributions, during any date of the Plan year.

E. Notes Receivable from Participants

A participant is allowed to borrow a maximum of 50% of his or her vested account balance up to \$50,000. The minimum loan amount is \$1,000. Loans must be repaid through payroll deductions within five years (except that loans for the purchase of a primary residence may be repaid over ten years). All loans bear interest based on the prevailing interest rates charged by the persons in the business of lending money for loans that would be made under similar circumstances.

F. Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

^A In accordance with ASC 820, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Level 1 investments are mutual funds and a money market fund valued at their quoted market prices. The common/collective trust is valued at net asset value. Shares of the common/collective trust may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trust. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

D. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan is based upon a Prototype Plan document that has received tax exempt status from the Internal Revenue Service. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts, and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by Fidelity Management Trust Company, the trustee, or its affiliates. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.
