Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Alfred University Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a mandatory defined contribution retirement plan established for employees of Alfred University (the University), who meet certain eligibility requirements. The Plan is administered by the University. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF), and Fidelity Investments Institutional Operations Company, Inc. (Fidelity Investments) are the recordkeepers of the Plan's assets. Fidelity Management Trust Company, Inc. (Fidelity) is a custodian of certain Plan assets. Reliance Trust Company (Reliance) is a custodian of certain Plan assets. TIAA and CREF are the insurance companies of the Plan. TIAA, FSB, (through July 2023) and TIAA Trust, N.A. (from July 2023 through December 31, 2024) are directed custodians of the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All common law employees of the Non-Statutory Sector of the University are eligible to begin salary deferrals as soon as administratively feasible following their date of employment or reemployment pursuant to a properly completed and valid salary deferral agreement by the participant. Employees are also eligible to receive University contributions upon making their mandatory participant contribution and working, or being scheduled to work, 1,000 hours of service in any year.

Contributions

For active participants, the University contributes to the Plan a percentage of eligible compensation if the employee contributes, in the form of salary reductions, a certain minimum percentage of their eligible compensation as set forth below:

Subject to Internal Revenue Service (IRS) rollover rules, the Plan will, with respect to an eligible employee, accept eligible rollover contributions from another employer's 401(a), 403(b) or governmental 457(b) plan, and qualified annuities under section 403(a), except that after-tax funds from any of the foregoing arrangements may not be transferred or rolled into the Plan. Other than eligible rollover contributions, the Plan does not accept transfers from another plan.

Active participants who wish to make additional contributions may elect to make contributions in whole percentages in the form of salary reductions. Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contribution, the University's contribution and an allocation of Plan earnings/(losses) on all contributions and an allocation of administrative expenses. Allocations are based on participant earnings/(losses) or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Funding Vehicles

Plan contributions are invested in one or more of the funding vehicles made available by the custodians to participants of the Plan. The Plan does not permit plan-to-plan transfers or contract exchanges with any annuity contract or custodial account that is not a funding vehicle specifically approved by the Plan Administrator for use under the Plan.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are fully vested immediately in their voluntary contributions, University contributions and actual earnings/(losses) thereon.

Plan Loans

Plan loans were issued directly from the funds owned by TIAA and CREF and were not issued from a participant's account. Accordingly, these loans are not presented as part of the plan assets on the statements of net assets available for benefits. An adequate portion of the participant's account is held on collateral to cover 110% of the outstanding loan in case of default. Total plan loans outstanding were \$7,111 and \$8,462 at December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, \$5,385 and \$5,093, respectively, of the plan loans were in default. The Plan no longer offers collateralized Plan loans through TIAA and CREF.

Notes Receivable from Participants

Beginning on April 12, 2019, participants may borrow from the portion of their accumulation account attributable to elective deferrals, mandatory participant plan contributions and rollover contributions. Participants can borrow up to the lesser of 50% of their account balances or \$50,000, reduced by the highest outstanding balance of loans attributable to the participant during the 12-month period preceding the making of the new loan. Loans are repayable over not more than five years except in the case of a loan taken for the purpose of purchasing a primary residence. Loans taken for the purpose of purchasing a primary residence are repayable over not more than ten years. All loans are subject to a fixed interest rate of prime plus 1%.

Payment of Benefits

Upon retirement, termination of service, or disability, and depending on the relevant funding vehicle contract, the forms of benefit that may be available under the funding vehicle contract include, but are not limited to: lump sum, installments, single life annuities, joint and survivor annuities, fixed period annuities, and any other annuity and withdrawal option as provided under the funding vehicle contract.

Hardship Withdrawals

Prior to age 59 ½, a participant may withdraw only his or her participant Plan contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America.

Investments

The Plan invests in registered investment companies, pooled separate accounts, and fixed annuity contracts. Registered investment companies, pooled separate accounts, and non-benefit responsive fixed annuity contracts are reported at fair value. Fully benefit responsive fixed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant-directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments (Continued)

The Plan utilizes Retirement Choice (RC) annuity contracts with TIAA, which are included in non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. TIAA maintains Plan contributions in separate accounts. RC contracts provide a floating guaranteed rate between 1-3% based on the 5-year Constant Maturity Treasury Rate less 125 basis points. Under RC contracts, lump-sum withdrawals are available from the TIAA Traditional account only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from the account must be paid in 84 monthly installments (7 years). After termination of employment, additional income options available include income for life, interest-only payments, and IRS required minimum distribution payments.

The Plan also utilizes Retirement Annuity (RA) contracts, which are included in the non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. TIAA maintains Plan contributions in separate accounts. RA contracts guarantee principal and a 3% minimum annual interest rate. Under RA contracts, lump-sum withdrawals are not permitted. Participant initiated transfers or withdrawals may only be made in 10 annual installments over a period of approximately nine years.

The Plan has fully benefit responsive fixed annuity contracts. TIAA maintains Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate between 1-3%.

Fair Value Measurement - Definition and Hierarchy

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

Registered investment companies: Valued using closing quoted prices in active markets.

Pooled separate accounts: A separate account invested in real estate properties and real estate related investments that are valued using closing quoted prices in active markets.

Non-benefit responsive fixed annuity contracts: Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes to the valuation methodologies used during 2024 and 2023.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by Plan participants. Management fees and operating expenses charged to the Plan are deducted from income earnings on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in the fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform with the current year presentation.

5. PARTY-IN-INTEREST TRANSACTIONS

TIAA, CREF, and Fidelity Investments are the recordkeepers of the Plan's assets. TIAA, FSB (through July 2023) and TIAA Trust, N.A. (from July 2023 through December 31, 2024), Fidelity and Reliance are the custodians of the Plan's assets. TIAA and CREF are the insurance companies and issuers of the annuity contracts of the Plan. As such, transactions between TIAA; CREF; TIAA, FSB; TIAA Trust, N.A.; Fidelity; Fidelity Investments; Reliance; and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions.

6. TAX STATUS

The University has adopted a volume submitter plan document that has received an opinion letter from the IRS dated August 7, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although, the Plan has been amended since adopting the volume submitter plan document, the University believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the University has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
