Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. DESCRIPTION OF THE PLAN

The following description of Rumiano Cheese Co 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General** The Plan is a defined contribution plan covering substantially all employees of Rumiano Cheese Co (the Company) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan was originally established as of February 1, 1987, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

**Contributions** Participants may elect to contribute to the Plan, in the form of employee 401(k) salary deferral contributions (pre-tax 401(k) deferrals and Roth 401(k) deferrals), up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions, except for discretionary nonelective contributions, into various investment options offered by the Plan. Discretionary nonelective contributions are invested in a portfolio of investments as directed by the Plan administrator. The Company makes safe harbor matching contributions of 100% of each participant's deferral up to 3% of the participant's eligible compensation, and 50% of the next 2% of eligible compensation. The Company made safe harbor matching contributions of \$242,545 and \$246,546 during the years ended December 31, 2024 and 2023, respectively. Additionally, the Company may make discretionary nonelective contributions. The Company made no discretionary nonelective contributions for the years ended December 31, 2024 and 2023. The Company may also make discretionary matching contributions, of which none were made for the years ended December 31, 2024 and 2023.

**Participant Accounts** Each participant's account is credited with the participant's contributions, Company contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. The Plan's allocation of earnings and administrative fees related to discretionary nonelective contributions are based on participant account balances. The discretionary nonelective contribution is allocated using a two-step integrated allocation formula in the same ratio that each participant's compensation for the Plan year bears to the total compensation of all participants for the year. An additional allocation is then calculated for the employees with compensation greater than the Social Security taxable wage base. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** Participants are immediately vested in their contributions, Company safe harbor matching contributions, and earnings thereon. Discretionary nonelective and matching contributions are subject to vesting. A participant is 100% vested after six years of credited service. Participants are credited with one year of service for each plan year in which they worked at least 1,000 hours.

**Payment of Benefits** Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy.

At December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

**Forfeitures** Forfeitures attributable to discretionary nonelective and matching contributions may be used to reduce Plan expenses, allocated as additional Company contributions, or as a reduction to future Company contributions to the Plan. Forfeited nonvested account balances totaling \$36 and \$211 were allocated as additional Company contributions for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, \$-0- and \$36, respectively, in forfeitures were available to allocate to participants in future years.

**Plan Termination** Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company contributions.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

**Fair Value Measurements** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-Bearing Cash:* Assets are money market mutual funds, which are valued at the net asset value (NAV), generally \$1 per share, and are reported on the active market on which securities are traded.

*Mutual Funds:* Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange-Traded Funds:* Assets are valued at the NAV reported on the active market on which the securities are traded. The valuation occurs throughout the day based on the market value of the underlying securities, as well as the market supply and demand for the particular exchange traded fund.

*Group Annuity Contract:* The group annuity contract account is made up of a variety of sub-accounts, which individually invest in specific established mutual funds. The group annuity contract sub-account net unit value is not a publicly quoted price in an active market. The market value of each sub-account is based on the underlying mutual fund per share. NAV is adjusted for sub-account-specific fees and differing treatment of distributions and mutual fund share splits. Participant transactions (issuances and redemptions) may occur daily. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 12-month notice to liquidate their entire share in the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Payment of Benefits*** Benefits are recorded when paid.

***Expenses*** Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

***Evaluation of Subsequent Events*** The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included in the statements of net assets available for benefits totaling \$5,715,783 and \$5,210,159, and the investment income of \$556,609 and 631,077 included on the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, respectively, were not subject to auditing procedures and have been certified as complete and accurate by John Hancock Life Insurance Company (John Hancock). John Hancock is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

#### 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company is the administrator of the Plan. The Plan's administrator may designate other persons to carry out the day-to-day operations of the Plan. The Plan has an investment contract with Morgan Stanley Wealth Management (Morgan Stanley). Morgan Stanley, as the Plan's broker, qualifies as a party in interest with respect to the investments managed by it; however, it is exempt from the prohibited transaction rules under ERISA.

Certain Plan investments are managed by John Hancock. John Hancock is a custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

John Hancock provides certain administrative services to the Plan pursuant to an agreement between the Plan and John Hancock. John Hancock receives revenue from the mutual funds underlying the group annuity contract sub-accounts, and other service providers for services provided to the funds. This revenue is used to offset certain amounts owed to John Hancock for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by John Hancock from investment providers exceeds the amount owed under the agreement, John Hancock remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or be allocated to the accounts of the participants. The Plan or the Company may make a payment to John Hancock for administrative services not covered by revenue sharing.

#### **7. TAX STATUS**

The Plan has adopted a pre-approved nonstandardized profit sharing plan established by Northwest Retirement Plans. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

#### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has had delinquent participant contributions for a number of years. Management has corrected the late remittances in 2025 and is confident the prohibited transactions will not adversely affect the qualified status of the Plan.

#### **9. SUBSEQUENT EVENT**

The Company sold on May 28, 2025. Management intends to merge the Plan with the buyer's existing plan. The Plan merger is anticipated to be completed in 2025.
