Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by CIMCO Resources, Inc. and Subsidiaries, (the Company). Along with CIMCO Resources, Inc., eligible employers include CIMCO Recycling Sterling, Inc., CIMCO Recycling Ottawa, Inc., CIMCO Recycling Milwaukee, Inc., CIMCO Recycling Loves Park, Inc., CIMCO Recycling Carbondale, Inc., CIMCO Recycling Marion, Inc., CIMCO Recycling Milan, Inc., and Riverside Logistics. Prior to a 2023 plan amendment, all employees of the Company who have completed twelve months of service with at least one-thousand hours during the eligibility computation period, have reached the age of 21 and are not leased, nonresident aliens or seasonal/part-time are eligible to participate in the Plan, and eligible employees may enter the Plan on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended to remove the service requirement entirely, reduced the age requirement from 21 to 18, and changed the plan entry dates for eligible employees to be immediately upon meeting eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan.

Contributions: Participants may contribute a percentage of their eligible compensation as defined by the Plan, subject to the maximum amount allowed by the Internal Revenue Code (IRC) and 80% of compensation. Prior to a 2023 plan amendment, contributory percentages for participant contributions are allowed to be changed on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended so that contributory percentages for participant contributions are allowed to be changed as of the beginning of each payroll period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute a discretionary matching amount on behalf of eligible participants who were employed on the last day of the Plan year and worked a minimum of 1,000 hours of service during the Plan year. There was no Company discretionary matching contribution for 2024. The Company may also contribute a profit-sharing amount and additional amounts, at the discretion of the Company's Board of Directors, to eligible employees who are employed on the last day of the Plan year and completed 501 hours of service during the Plan year. No profit-sharing or additional amounts were contributed for 2024. Company contributions recorded to the 2024 statement of changes in net assets available for benefits are comprised of required qualified non-elective contributions and of contributions funded to correct the amounts of previous distributions to participants. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's matching contributions and an allocation of (a) the Company's profit-sharing and additional amounts and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in the amount of their elective contributions and the allocated earnings thereon. Participants vest in the Company's discretionary matching and profit-sharing contributions, and earnings thereon, based on years of service. Participants vest starting in their second year of service, at a rate of 20% per year with 100% vesting after six years. All participants are also fully vested if their termination is a result of death, disability or retirement.

Note 1. Description of the Plan (Continued)

Investment options: Participants must direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants have the option to transfer monies between investments and change the allocation of their investment elections daily.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the prior 12-month period. Note terms may not exceed five years unless the note is for the purchase of a primary residence, in which case the term may not exceed 10 years. A participant may only have one outstanding note at a time. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the note is made. Principal and interest are paid ratably through payroll deductions or direct payment.

Payment of benefits: On termination of service for any reason, participants may elect to receive benefits in a lump-sum distribution or partial payments of their vested account balance. The Plan also provides for hardship withdrawals and for in-service withdrawals after age 59½. The Plan also has a de minimis rule of automatic cash-outs for accounts less than \$5,000. Any distribution under the de minimis rule that is greater than \$1,000 that is made to a participant without said participant's consent and before their normal retirement date (or age 62, if later) will be rolled over to an individual retirement plan designated by the Plan Administrator.

Administrative expenses: All administrative expenses incurred by the Plan, including audit fees, can be paid by either the Plan Sponsor or the Plan. Expenses paid by the Plan Sponsor are excluded from these financial statements.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,900 and \$30,700, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During the year ended December 31, 2024, approximately \$31,800 was used to reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the term of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reposting purposes and, accordingly, have been included as an investment in the supplemental schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Fidelity Management Trust Company, the Trustee

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfers of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by FMR LLC. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

The Plan's investments include shares of registered investment companies managed by affiliates of the Trustee. An affiliate of the Trustee also serves as the contractual recordkeeping agent for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee or its affiliates amounted to \$1,950 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which no compensation is received from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and excluded from these financial statements.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Prohibited Transactions

During 2024, the Plan sponsor inadvertently failed to deposit \$15,253 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan sponsor's assets and not from assets of the Plan.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by CIMCO Resources, Inc. and Subsidiaries, (the Company). Along with CIMCO Resources, Inc., eligible employers include CIMCO Recycling Sterling, Inc., CIMCO Recycling Ottawa, Inc., CIMCO Recycling Milwaukee, Inc., CIMCO Recycling Loves Park, Inc., CIMCO Recycling Carbondale, Inc., CIMCO Recycling Marion, Inc., CIMCO Recycling Milan, Inc., and Riverside Logistics. Prior to a 2023 plan amendment, all employees of the Company who have completed twelve months of service with at least one-thousand hours during the eligibility computation period, have reached the age of 21 and are not leased, nonresident aliens or seasonal/part-time are eligible to participate in the Plan, and eligible employees may enter the Plan on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended to remove the service requirement entirely, reduced the age requirement from 21 to 18, and changed the plan entry dates for eligible employees to be immediately upon meeting eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan.

Contributions: Participants may contribute a percentage of their eligible compensation as defined by the Plan, subject to the maximum amount allowed by the Internal Revenue Code (IRC) and 80% of compensation. Prior to a 2023 plan amendment, contributory percentages for participant contributions are allowed to be changed on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended so that contributory percentages for participant contributions are allowed to be changed as of the beginning of each payroll period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute a discretionary matching amount on behalf of eligible participants who were employed on the last day of the Plan year and worked a minimum of 1,000 hours of service during the Plan year. There was no Company discretionary matching contribution for 2024. The Company may also contribute a profit-sharing amount and additional amounts, at the discretion of the Company's Board of Directors, to eligible employees who are employed on the last day of the Plan year and completed 501 hours of service during the Plan year. No profit-sharing or additional amounts were contributed for 2024. Company contributions recorded to the 2024 statement of changes in net assets available for benefits are comprised of required qualified non-elective contributions and of contributions funded to correct the amounts of previous distributions to participants. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's matching contributions and an allocation of (a) the Company's profit-sharing and additional amounts and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in the amount of their elective contributions and the allocated earnings thereon. Participants vest in the Company's discretionary matching and profit-sharing contributions, and earnings thereon, based on years of service. Participants vest starting in their second year of service, at a rate of 20% per year with 100% vesting after six years. All participants are also fully vested if their termination is a result of death, disability or retirement.

Note 1. Description of the Plan (Continued)

Investment options: Participants must direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants have the option to transfer monies between investments and change the allocation of their investment elections daily.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the prior 12-month period. Note terms may not exceed five years unless the note is for the purchase of a primary residence, in which case the term may not exceed 10 years. A participant may only have one outstanding note at a time. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the note is made. Principal and interest are paid ratably through payroll deductions or direct payment.

Payment of benefits: On termination of service for any reason, participants may elect to receive benefits in a lump-sum distribution or partial payments of their vested account balance. The Plan also provides for hardship withdrawals and for in-service withdrawals after age 59½. The Plan also has a de minimis rule of automatic cash-outs for accounts less than \$5,000. Any distribution under the de minimis rule that is greater than \$1,000 that is made to a participant without said participant's consent and before their normal retirement date (or age 62, if later) will be rolled over to an individual retirement plan designated by the Plan Administrator.

Administrative expenses: All administrative expenses incurred by the Plan, including audit fees, can be paid by either the Plan Sponsor or the Plan. Expenses paid by the Plan Sponsor are excluded from these financial statements.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,900 and \$30,700, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During the year ended December 31, 2024, approximately \$31,800 was used to reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the term of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reposting purposes and, accordingly, have been included as an investment in the supplemental schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Fidelity Management Trust Company, the Trustee

The following is a summary of the plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$461,345 of net appreciation in fair value of investments, \$452,091 of interest and dividends and \$8,634 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfers of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by FMR LLC. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

The Plan's investments include shares of registered investment companies managed by affiliates of the Trustee. An affiliate of the Trustee also serves as the contractual recordkeeping agent for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee or its affiliates amounted to \$1,950 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which no compensation is received from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and excluded from these financial statements.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Prohibited Transactions

During 2024, the Plan sponsor inadvertently failed to deposit \$15,253 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan sponsor's assets and not from assets of the Plan.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of CIMCO Resources, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by CIMCO Resources, Inc. and Subsidiaries, (the Company). Along with CIMCO Resources, Inc., eligible employers include CIMCO Recycling Sterling, Inc., CIMCO Recycling Ottawa, Inc., CIMCO Recycling Milwaukee, Inc., CIMCO Recycling Loves Park, Inc., CIMCO Recycling Carbondale, Inc., CIMCO Recycling Marion, Inc., CIMCO Recycling Milan, Inc., and Riverside Logistics. Prior to a 2023 plan amendment, all employees of the Company who have completed twelve months of service with at least one-thousand hours during the eligibility computation period, have reached the age of 21 and are not leased, nonresident aliens or seasonal/part-time are eligible to participate in the Plan, and eligible employees may enter the Plan on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended to remove the service requirement entirely, reduced the age requirement from 21 to 18, and changed the plan entry dates for eligible employees to be immediately upon meeting eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan.

Contributions: Participants may contribute a percentage of their eligible compensation as defined by the Plan, subject to the maximum amount allowed by the Internal Revenue Code (IRC) and 80% of compensation. Prior to a 2023 plan amendment, contributory percentages for participant contributions are allowed to be changed on the first day of the first, fourth, seventh, and tenth month of the Plan year. Effective June 19, 2023, the Plan was amended so that contributory percentages for participant contributions are allowed to be changed as of the beginning of each payroll period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute a discretionary matching amount on behalf of eligible participants who were employed on the last day of the Plan year and worked a minimum of 1,000 hours of service during the Plan year. There was no Company discretionary matching contribution for 2024. The Company may also contribute a profit-sharing amount and additional amounts, at the discretion of the Company's Board of Directors, to eligible employees who are employed on the last day of the Plan year and completed 501 hours of service during the Plan year. No profit-sharing or additional amounts were contributed for 2024. Company contributions recorded to the 2024 statement of changes in net assets available for benefits are comprised of required qualified non-elective contributions and of contributions funded to correct the amounts of previous distributions to participants. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's matching contributions and an allocation of (a) the Company's profit-sharing and additional amounts and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in the amount of their elective contributions and the allocated earnings thereon. Participants vest in the Company's discretionary matching and profit-sharing contributions, and earnings thereon, based on years of service. Participants vest starting in their second year of service, at a rate of 20% per year with 100% vesting after six years. All participants are also fully vested if their termination is a result of death, disability or retirement.

Note 1. Description of the Plan (Continued)

Investment options: Participants must direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants have the option to transfer monies between investments and change the allocation of their investment elections daily.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the prior 12-month period. Note terms may not exceed five years unless the note is for the purchase of a primary residence, in which case the term may not exceed 10 years. A participant may only have one outstanding note at a time. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the note is made. Principal and interest are paid ratably through payroll deductions or direct payment.

Payment of benefits: On termination of service for any reason, participants may elect to receive benefits in a lump-sum distribution or partial payments of their vested account balance. The Plan also provides for hardship withdrawals and for in-service withdrawals after age 59½. The Plan also has a de minimis rule of automatic cash-outs for accounts less than \$5,000. Any distribution under the de minimis rule that is greater than \$1,000 that is made to a participant without said participant's consent and before their normal retirement date (or age 62, if later) will be rolled over to an individual retirement plan designated by the Plan Administrator.

Administrative expenses: All administrative expenses incurred by the Plan, including audit fees, can be paid by either the Plan Sponsor or the Plan. Expenses paid by the Plan Sponsor are excluded from these financial statements.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,900 and \$30,700, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During the year ended December 31, 2024, approximately \$31,800 was used to reduce Company contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the term of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reposting purposes and, accordingly, have been included as an investment in the supplemental schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Fidelity Management Trust Company, the Trustee

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfers of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Income Tax Status

The Plan has adopted a pre-approved defined contribution plan sponsored by FMR LLC. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the pre-approved defined contribution plan's qualified status. The pre-approved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

The Plan's investments include shares of registered investment companies managed by affiliates of the Trustee. An affiliate of the Trustee also serves as the contractual recordkeeping agent for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee or its affiliates amounted to \$1,950 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which no compensation is received from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and excluded from these financial statements.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Prohibited Transactions

During 2024, the Plan sponsor inadvertently failed to deposit \$15,253 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan sponsor's assets and not from assets of the Plan.
