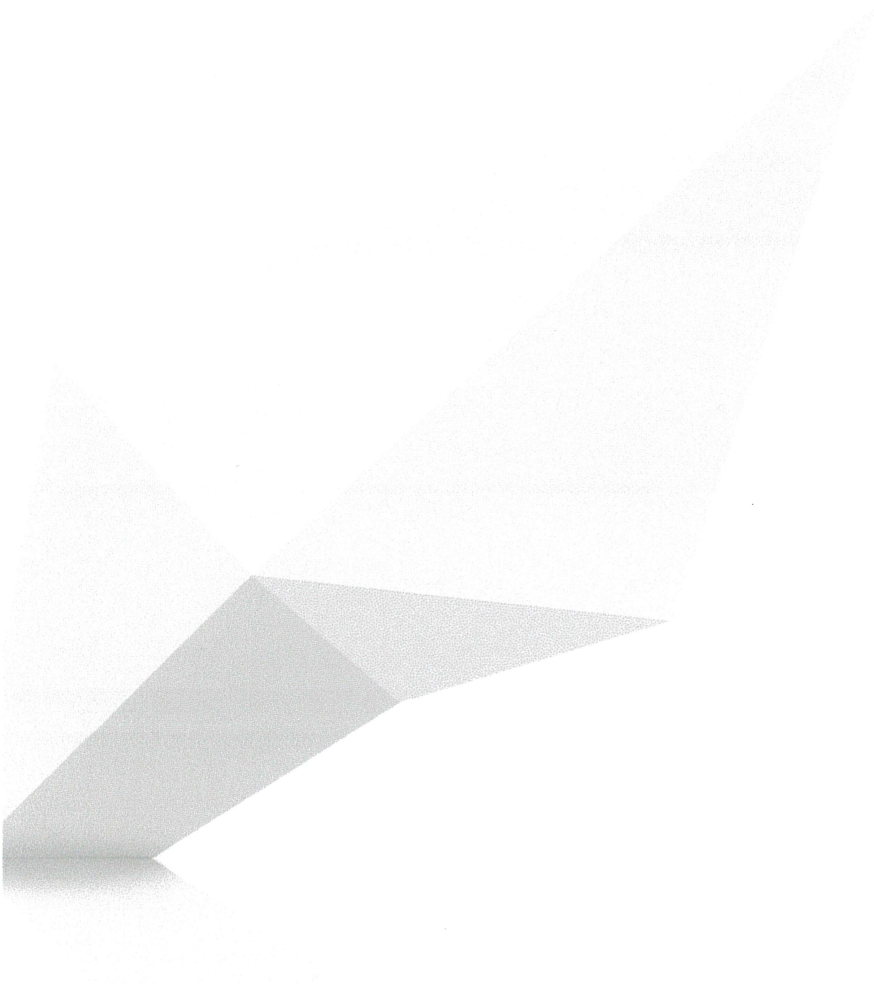

Note 1: Description of Plan

The following description of the C.G. Bretting Manufacturing Company, Inc. Union Employees 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of C.G. Bretting Manufacturing Co., Inc. (the "Company") who are members of Lodge 621 of the International Association of Machinists and Aerospace Workers, AFL-CIO and are union employees. An employee becomes eligible to participate in the Plan immediately following completion of three months of service with the Company and upon attaining the age of 19. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Contributions

Each year participants may contribute pretax annual compensation, as defined by the Plan, and Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes discretionary matching contributions equal to 90% of the first 4% of base compensation that a participant contributes to the Plan. Rollovers are not matched. The Company made discretionary matching contributions of \$348,339, net of forfeitures, during the year ended December 31, 2024.

The Company may also contribute qualified matching contributions (QMACs) and qualified nonelective contributions (QNECs) to nonhighly compensated participants under the terms of the Plan. There were no QMAC or QNEC contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, Company QMACs, Company QNECs, and allocations of plan earnings (losses) and charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Company QMAC and QNEC contributions, plus earnings (losses) thereon. Vesting in the Company's discretionary matching contributions plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year and become fully vested after five years of continuous full-time service.

Notes Receivable From Participants

The Plan does not allow participants to borrow from their fund accounts.

Payment of Benefits

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, substantially equal installments, or in partial withdrawals if the withdrawal is a minimum of \$5,000. If the participant's vested account balance does not exceed \$5,000, it can only be distributed in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account along with earnings are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching contributions. These forfeitures may be used at the discretion of the Company. The amount of unused forfeitures were \$1,601 and \$6,019 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$7,731 were used to reduce Company matching contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company absorbs various plan expenses including audit fees and 75% of the third-party administration fees, which are excluded from these financial statements. The remaining 25% of administration fees are allocated proportionately to plan participants based on their respective account balances. Fees related to the administration of benefits paid to participants are charged directly to the participant's account and included in administrative expenses. All investment management and advisory fees are allocated proportionately to plan participants based on their respective account balance and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 2: Summary of Significant Accounting Policies (Continued)

Subsequent Events (Continued)

Effective January 1, 2025, the Plan was amended to freeze the Company discretionary matching contribution and include safe harbor provisions whereby the Plan will provide for a safe harbor matching contribution in an amount equal to 100% of employee contributions that are not in excess of 5% of a participants' eligible compensation.

Prior to this amendment, the Plan was not a safe harbor plan and was subject to annual nondiscrimination testing. As a result of this change, the Plan will be exempt from the annual Actual Deferral Percentage and Actual Contribution Percentage nondiscrimination tests.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and FBRIC held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Life Insurance Company and The Nationwide Financial Services, Inc., including its subsidiary Nationwide Trust Company, FSB, a division of Nationwide Bank (collectively "Nationwide"), the Custodian of the Plan.

Note 5: Fully Benefit-Responsive Investment Contract

The Plan invests in a FBRIC with Nationwide in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Nationwide maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Nationwide is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5: Fully Benefit-Responsive Investment Contract (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was 2.43% for the year ended December 31, 2024, and is reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Nationwide including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

Note 6: Excess Contributions Payable

At December 31, 2024, amounts payable to participants totaling \$584 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Company distributed the 2024 excess contributions to the applicable participants before March 15, 2025, in accordance with regulations. At December 31, 2023, the Plan had a liability for contributions in excess of IRS limits totaling \$24,861. The Company distributed the 2023 excess contributions to the applicable participants before March 15, 2024, in accordance with regulations.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching contributions.

Note 8: Tax Status

The Company adopted a nonstandardized pre-approved profit sharing plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Party-in-Interest Transactions

Certain plan investments are managed by Nationwide, the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan pays investment management and advisory fees to LPL Financial LLC. These transactions also qualify as party-in-interest transactions.

The Plan also pays third-party administrative fees to Nationwide and Blue Chip Retirement Plans, Inc., which qualify as party-in-interest transactions.
