Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Child Care Resource Center 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2024 and the schedule of assets (held at year end) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

Notes to Financial Statements
Years ended December 31, 2024 and 2023**

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Child Care Resource Center (CCRC or the Company) 403(b) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan, as defined under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has been adopted to provide employees with the opportunity to save for retirement on a tax-advantaged basis and to provide additional income for retirement.

CCRC also offers a Roth Account.

Eligibility

Employees are eligible to participate in the Plan from the first day of hire, provided they are not one of the following:

- Nonresident aliens who have no earned income from sources within the United States
- Employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless such agreement expressly provides for participation in this Plan

Employees are eligible to participate in the employer contributions if they have met all of the following:

- Attained the age of 18
- Completed one year of service

Contributions

An employee makes before-tax payroll contributions to the Plan each payroll period up to the maximum limit allowed by the Internal Revenue Service (IRS). A participant may elect to reduce compensation by a fixed dollar amount. An employee who attained the age of 50 or older before the end of a plan year can contribute an additional catch-up contribution to the Plan, subject to the IRS limits.

The Plan Administrator may contribute a discretionary employer contribution from two percent to six percent of the participant's base salary.

Additionally, participants may rollover amounts representing distributions from other qualified retirement or profit-sharing plans.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited or charged with employer contributions, rollover contributions, matching contributions, net earnings, gains, and losses, as well as any appreciation or depreciation in the fair value of investments.

Vesting

Participants are always 100% vested for their elective deferrals, including catch-up contributions, rollover contributions and employer contributions.

Payment of Benefits

If employment terminates for reasons other than death, disability, or attainment of retirement age, the participant will be entitled to his/her "vested percentage" of his/her account balance.

Amounts attributable to elective salary deferral contributions may be distributed to a participant provided that such distribution shall not occur until the participant has either attained the age of 59½, severed employment, died, became totally disabled, experienced hardship or a withdrawal is made to provide a Plan loan.

Benefits may be paid in a single lump-sum payment in cash. The Plan also provides that vested participant account balances of \$5,000 or less are to be paid out without an affirmative election from the participant. In accordance with applicable regulations, vested account balances of \$1,000 or less are to be distributed to the participant in a lump sum, and vested account balances exceeding \$1,000 but not exceeding \$5,000 are to be distributed in the participant's name as a direct rollover to an IRA product. Effective November 15, 2023, partial withdrawals were added as a form of distribution and continue to be available in 2024.

Notes Receivable from Participants

Participants may borrow against their vested accounts, provided the minimum loan amount is \$1,000 and will not exceed the lesser of \$50,000 or 50% of the qualified fund balances. Loans may be taken out at a reasonable rate of interest as determined by the Plan Administrator. Loan processing and administrative fees are charged against the participants' contributions. If the loan purpose is for the purchase of a primary residence, the loan period can be up to 30 years. The loan period with purposes other than the purchase of a primary residence is from one to five years.

Investment Options

Participants may invest their entire account in specific assets, specific funds or other investments permitted under the Plan. All participant-directed investments shall be credited or charged with the net earnings, gains, losses, and expenses, as well as any appreciation or depreciation in the fair value of investments. The participants may change their investment options daily.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value. Quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

The Plan accounts for its annuity contracts at contract value which approximates fair value. See Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation (Depreciation) in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Participant loans are recorded at amortized cost, which represents unpaid principal plus accrued interest balance at year end.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

All usual and reasonable expenses are paid by the employer, and any expenses not paid by the employer may be paid from the Plan assets if not prohibited by applicable laws or regulations.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Reclassification

Certain reclassifications have been made to the prior year amounts to enhance comparability with the current year's presentation. Interest from participant loans is now presented separately as interest on notes receivable from participants. Previously, it was included under interest and dividends. The reclassifications had no impact on the previously reported statement of changes in net assets available for benefits.

NOTE 3 FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 FAIR VALUE MEASUREMENT (CONTINUED)

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact purchases and sales at that price. The mutual funds held by the Plan amounting to \$44,190,474 and \$34,640,869 at December 31, 2024 and 2023, respectively, are actively traded and are classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INVESTMENTS AT CONTRACT VALUE

The Plan has entered into a group annuity contracts issued by American United Life Insurance Company (AUL) and Voya Retirement Insurance and Annuity Co. (Voya). The contract value of the annuity contract was \$1,081,398 and \$1,113,160 as of December 31, 2024 and 2023, respectively. The contracts offer a fixed interest investment option (the Fixed Option) through AUL and Voya general accounts and a number of variable investment options through an AUL separate account. Funds allocated to the Fixed Option are placed in the general accounts, where they are invested in accordance with AUL general account investment policies. The objective of those investment policies is to maximize long-term, risk-adjusted returns. General accounts assets are predominantly fixed-income investments (bonds, mortgages, and private placements). The average maturity for these assets is nearly ten years, and the average duration is between five and six years.

Following are some features and characteristics of the Fixed Option:

- Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rates are based on the return AUL and Voya expect on new investments made and held within the general accounts, and they will always equal or exceed the contractually guaranteed rates.
- All contributions received during the quarter will earn the declared interest rates until the end of the calendar year following the current year.
- At the beginning of each year, a new interest rate is established and declared for each Annual Package. This rate is based on past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments.

- All benefit-responsive plan benefit payments made prior to contract liquidation are made at book value (principal invested plus interest earned).

All financial information related to the contract's Fixed Option is reported to a Plan participant at contract value (principal invested plus interest earned) (also known as the participant's Fixed Option "Account Value"). Participant-initiated benefit-responsive plan withdrawals from the Fixed Option and transfers between the Fixed Option and the variable investment options, as allowed under the terms of the Plan and the contract, are performed at contract value. The contract's Fixed Option has no liquid market value because it is not tradable or assignable, and there are no defined maturities of the cash flows.

Liquidation of the entire contract issued by AUL may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan participants, and can only be initiated by the Fiduciary Committee upon termination of the Plan or complete termination of the contract.

NOTE 5 FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by AUL and Voya, the custodians of the Plan. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians related to the Plan's assets are complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

- Investments and notes receivable from participants, as reflected in the Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Notes 3 and 4 of the Plan's financial statements; and,
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain funds of the Plan are managed by AUL and Voya. These entities are the custodians as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$7,741 and \$6,367 for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 8 INCOME TAX STATUS

The Plan has adopted a volume submitter 403(b) plan which is the subject of a favorable opinion letter dated November 22, 2017. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of liability (asset) or disclosure in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are normally exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 NONEXEMPT TRANSACTIONS

In 2024, the Plan Sponsor inadvertently failed to deposit approximately \$221 in participant loan repayments within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor intends to deposit the lost interest to correct this failure in 2025.

NOTE 11 NEW LAWS AND REGULATIONS

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (SECURE Act 2.0) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE Act 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plan years beginning after December 31, 2024.

The IRS issued proposed regulations in February 2023 addressing the use and timing of forfeitures in qualified retirement plans. These regulations apply to plan years beginning on or after January 1, 2024. The regulation states that forfeitures must be used no later than 12 months after the end of the plan year in which the forfeitures were incurred. However, the transition rule also provides that any forfeitures that were incurred in any plan year beginning before 2024 are treated as having been incurred in the first plan year that begins on or after January 1, 2024, and, thus, must be used no later than December 31, 2025, for a calendar year plan.

For plan years beginning in 2026, catch-up contributions for participants age 50 or older earning more than \$145,000 annually will be required to be made on a Roth (after-tax) basis. Management is monitoring regulatory guidance and evaluating administrative updates required to comply with this provision.

The Plan will implement the above legislative changes and intends to formally execute the required plan amendments reflecting their implementation by the deadline of December 31, 2026.

NOTE 12 SUBSEQUENT EVENTS

The Plan Administrator has evaluated events subsequent to December 31, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through October 13, 2025, the date the financial statements were available to be issued. Based upon this evaluation, it was determined that no subsequent events occurred that required recognition or additional disclosure or adjustment to the accompanying financial statements other than the matters described below:

- Effective January 1, 2025, the Plan will include automatic enrollment at a 3% deferral rate and an automatic annual deferral increase of 1%, up to a maximum of 10%. These automatic provisions will apply to new hires only.
