Opinion

NOTE 1 - DESCRIPTION OF PLAN

General

The **Lutheran Social Services Group, Inc. 401(k) Retirement Plan** is a safe harbor defined contribution plan that covers all eligible employees of **Lutheran Social Services Group, Inc.** (the Plan Sponsor). The Plan Sponsor is a not-for-profit social service agency exempt from income taxes under Section 501(c) (3) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan. The Pension Subcommittee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligible pension salaries are salaries of all employees who are at least 21 years of age and have completed at least 1,000 hours of service during the plan year.

Contributions

The Plan Sponsor makes 100% matching contributions up to 5% of the employees' eligible compensation. Employees are 100% vested for matching contributions. Participants may contribute a percentage of eligible pay on a pretax basis every pay period, not to exceed IRS limits (\$23,000 for 2024 and \$22,500 for 2023). Plan participants also have the option of contributing on a post-tax basis (Roth elective deferrals). Plan participants may make catch-up elective deferral contributions (\$7,500 for 2024 and 2023) in a taxable year if the plan participant will be at least age 50 by the end of that year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor maintains the right to make discretionary contributions to the plan. Vesting of discretionary employer contributions occurs after the first year (20%), and increases by 20% for each succeeding eligible year through year five, at which time the participant becomes fully vested. There were no discretionary contributions for 2024 or 2023.

Payments of Benefits

On termination of service, a participant may elect to receive any portion of the value of the participant's vested interest in their account in the form of a lump-sum, a partial withdrawal, or installments over a period of time. The plan also allows in-service distributions in case of financial hardship or attainment of age 59 ½.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's matching contribution, (b) the Plan Sponsor's discretionary contribution and, (c) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Upon employee termination, any nonvested contributions are forfeited by the employee and become available to offset expenses of the Plan and to reduce Plan Sponsor contributions.

Reclassifications

Certain prior year amounts have been reclassified to conform with the current year presentation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments

Investments held by the Plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The Plan provides for individual self-directed accounts which permit participants to exercise investment control over the assets held in their individual accounts. The Plan provides approximately thirty investment options to the Plan participants. Participants should refer to the Plan Enrollment Form for descriptions of these options.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Unrealized Appreciation or Depreciation of Investments

In accordance with the policy of stating investments at fair value, unrealized appreciation or depreciation on investments held at year end is reflected in the statements of changes in net assets available for benefits. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gains totaling \$273,165 and \$114,371 are reported as dividends and capital gain distributions in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, respectively, but are included in net investment gain from registered investment companies on Schedule H of the IRS Form 5500.

Administrative Fees

Administrative expenses of the plan are paid by plan participants or through forfeitures.

NOTE 3 - FAIR VALUE MEASUREMENTS

Certain Plan investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Topic 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs on the hierarchy consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices in active markets for similar assets or liabilities or quoted prices in inactive markets for identical or similar assets or liabilities. Level 3 inputs on the hierarchy are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments.

The following is a description of the valuation methodologies used for the investments measured at fair value.

Registered investment companies – Funds are valued at quoted market prices in an active market. These investments are classified as Level I investments.

Common/collective trusts – The Principal Stable Value Fund has a fair value that is based on the Fund's net asset value (NAV) per share of units held, which is obtained from audited information and is used as a practical expedient. The objective of the fund is to provide preservation of capital and relatively stable returns regardless of the volatility of the financial markets.

As of December 31, the Plan's investments measured at fair value consisted of the following instruments and classifications within the fair value hierarchy.

NOTE 4 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain plan investments are sponsored by the Plan Custodian, Principal Life Insurance Company. Total investments held by the custodian at December 31, 2024 and 2023 that are party-in-interest transactions under ERISA amounted to \$1,407,719 and \$1,866,906, respectively. Also, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Total expenses paid by the Plan to Principal Life Insurance Company were \$44,143 and \$63,695 for the years ended December 31, 2024 and 2023, respectively.

These transactions are party-in-interest transactions under ERISA and are exempt from the prohibited transaction rules.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - TAX EXEMPT STATUS

The *Lutheran Social Services Group, Inc. 401(k) Retirement Plan* is exempt from federal and state taxation under Section 401 of the Internal Revenue Code. The Plan follows a prototype plan, which has obtained its latest determination letter in March 2014. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's Form 5500 is subject to examination by the Internal Revenue Service; plan years that remain open for examination include the years ended December 31, 2021 and later.

NOTE 8 - SUBSEQUENT EVENTS

Subsequent events were evaluated by Management through July 1, 2025, which is the date the financial statements were available to be issued.
