## **INDEPENDENT AUDITOR'S REPORT**

To the Trustees

### **Opinion**

We have audited the accompanying financial statements of Diagnostic Radiology & Imaging Employee Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits - cash basis of Diagnostic Radiology & Imaging Employee Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - cash basis for the years then ended, in accordance with the cash basis of accounting described in Note 2(a).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### (1) Description of Plan

The following description of the Diagnostic Radiology & Imaging Employee Benefits Plan ("Plan") provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

- (a) **General** - The Plan, established January 1, 2020, is a qualified defined benefit welfare plan, providing health, prescription drug and vision benefits, covering all employees and their dependents of Diagnostic Radiology & Imaging, LLC ("Company"). At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums, may change.

Effective January 1, 2023, the Plan is available to employees who work at least twenty-four hours per week, and have satisfied the eligibility requirements of the Plan. Previously employees had to work thirty hours per week. Former employees and their dependents are eligible for continued coverage for the number of months specified in the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA"), if they so elect.

A voluntary employees' beneficiary association ("VEBA") trust arrangement has been established for the funding and the payment of certain specified medical expenses of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

- (b) **Contributions** - The Plan is funded by contributions from covered employees and the Company and all contributions are irrevocable. Contributions from employees are through payroll deduction. If any contribution is made in error, or if the deduction of any contribution is disallowed, the then value of such contribution will be returned to the Company or employee if within the time allowed by law. The Plan had 126 and 129 participants at December 31, 2024 and 2023, respectively.

The Plan provides for a special class of participants for employees who retire at age fifty-five or older with at least ten years of service with the Company. This class may continue medical coverage under the Plan as an alternative to COBRA coverage until the earlier of: (1) reaching age sixty-five, (2) becoming covered under another comparable group medical plan, (3) becoming entitled to Medicare, or (4) failing to timely pay any required premium for such coverage. Dependents of retired employees are eligible as well under similar circumstances.

- (c) **Payment of Benefits** - Effective January 1, 2021, the Plan pays for all approved health, prescription drug and vision claims up to a maximum of \$60,000 per participant.

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for individual participant claims over those specific dollar amounts. For the years ended December 31, 2024 and 2023, the Company paid \$454,130 and \$393,262, respectively, in stop loss insurance premiums. The specific stop loss coverage is evaluated annually based on the Plan's experience, change in the health care cost-trend rates, currently averaging increases of 7-10%, and the number of participants in the Plan. The specific stop loss coverage is \$60,000 per participant for the 2025 Plan.

- (d) **Plan Termination** - The Company expects to continue the Plan indefinitely, but reserves the right to terminate the Plan in whole or in part at any time upon giving written notice to all parties concerned subject to the provisions of ERISA.

- (e) **Expenses** - Certain expenses of maintaining the Plan are paid by the Company and excluded from these financial statements.

### (2) Summary of Accounting Policies

- (a) **Basis of Accounting** - The financial statements have been prepared using the cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The primary difference between accounting principles generally accepted in the United States of America and the cash basis of accounting is the recognition of contributions receivable and liabilities for benefit claims payable.
- (b) **Cash** - At various times throughout the year, the Plan had cash on deposit with a bank which exceeded the \$250,000 federally-insured limit. Whenever cash balances exceed the amount insured, there is a risk of monetary loss.
- (c) **Payment of Benefits** - Health, prescription drug and vision claims are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with claims paid.
- (d) **Prescription Rebates** - Prescription drug rebates are recorded when received and are shown netted with claims paid.
- (e) **Management Estimates** - The preparation of the financial statements in conformity with the cash basis of accounting requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### (3) Benefit Obligations

Benefit obligations of the Plan at December 31, 2024 and 2023 for claims incurred by participants but not reported were approximately \$104,000 and \$135,000, respectively. The changes in the Plan's benefit obligation at December 31, 2024 and 2023 are as follows:

As described in Note 1(b), the Plan provides for benefits to employees who retire at age fifty-five with ten years of service. No benefits were paid on behalf of retired employees for the year ended December 31, 2024 and 2023. The ultimate obligation for postretirement benefits is not recognized because management cannot reasonably estimate the amounts; however, management has determined that the obligation would be immaterial to the financial statements, based on the participants covering the expected cost of such benefits and that a 1% increase in the assumed health care cost-trend rate would not have a significant effect on the Plan's benefit obligations.

### **(4) Party-In-Interest Transactions**

Cigna Health and Life Insurance Company ("Cigna"), the Plan's Supervisor, provides third party administrator and consulting services for the Plan and is a Party-in-Interest within the meaning of ERISA. Cigna processes all enrollments, claims, and excess loss claims for the Plan and was paid \$60,155 and \$49,990 by the Company for their services for the years ended December 31, 2024 and 2023, respectively.

### **(5) Tax Status**

The VEBA trust, established under the Plan to hold the Plan's net assets, complies with the requirements of Section 501(c)(9) of the Internal Revenue Code ("IRC"), so that the trust's net investment income, if any, is exempt from income taxes. A determination letter, dated August 31, 2007, to the effect that the trust is qualified has been received from the Internal Revenue Service. The Plan has been amended subsequent to the IRS determination; however, the Plan sponsor and trustees believe the Plan, as amended, is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is not currently under examination for any tax periods. The Plan is generally subject to examination by taxing authorities for a period of up to three years after the date on which the returns are filed.

### **(6) Subsequent Events**

The Plan's management has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued.
