Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of East End Welding LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The East End Welding LLC 401(k) Plan (the “Plan”) is a retirement savings plan designed to invest voluntary pre-tax and post-tax employee contributions, and matching employer contributions for the benefit of the participating employees. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established by East End Welding LLC (the “Company”) on July 19, 2021 as a defined contribution 401(k) plan designed to provide employees of the Company with tax advantaged long-term savings for retirement. The Plan is administered by the Company along with Empower Trust Company, LLC (the “Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

All employees of the Company who were active employees as of July 19, 2021, the inception date of the Plan, are eligible to participate in the Plan immediately. All other employees of the Company are eligible to participate in the Plan after completing one month of service, with an entry date of the first day of the month coinciding with or next following the date the employee satisfied the eligibility requirements.

Contributions

The Plan provides for pre-tax contributions by participants and Roth elective deferrals, through payroll deductions, and for matching and discretionary contributions by the Company. New employees are automatically enrolled in the Plan, unless they elect otherwise, at a rate of 5% of the employee’s eligible compensation.

The Plan provides for a matching contribution from the Company of 100% of the first 3% and 50% of the next 2% of eligible earnings contributed by each participant. The Company may also make a discretionary contribution in an amount determined by the board of directors on an annual basis. There were no discretionary contributions made for the years ended December 31, 2024 and 2023.

Vesting and Distributions

Participants are immediately and fully vested in all participant contributions and earnings thereon. The employer matching contributions and discretionary employer nonelective contribution vest by 25% for each year of service completed, with 100% vesting at the completion of four years of service. On termination of service due to death, disability, or retirement, a participant receives a lump-sum payment.

Participant Accounts

Each participant’s account is increased, or decreased as appropriate, with (a) the participant’s contribution, (b) the Company’s matching contributions and discretionary employer nonelective contribution, (c) net investment earnings based on the participant’s account balance and composition, (d) administrative expenses, (e) loan disbursements and repayments, and (f) distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Administrative Expense

Administrative fees are paid by the Plan or the Plan Sponsor. There are also indirect fees deducted directly from investment earnings of the Plan.

Notes Receivable from Participants

Subject to certain limitations, the Plan permits loans to participants. The minimum loan amount is \$1,000. The maximum amount a participant may borrow is the lesser of (1) one-half of a participant's vested balance or (2) \$50,000. Participants may borrow from the value of their balances invested in any of the various investment funds at their discretion. The interest rate on the loans is equal to 1% plus the Prime lending rate at loan origination date. The terms of the loans are one to five years. A loan term may extend beyond five years if the loan is used for the purchase of a primary residence. Principal and interest are paid bi-weekly through payroll deductions.

Notes are in default when payments are not made by the end of the calendar quarter following the quarter in which the payment was due, if there is still an outstanding balance on the note's maturity date, or employment with the Plan Sponsor is terminated. In the event of default, the entire outstanding note balance, consisting of the missed payments, remaining principal, and all accrued but unpaid interest, will be reported to the IRS as taxable income. If a note has not been fully repaid by the end of its term, the outstanding balance will be treated as a deemed distribution and will be reported to the IRS as taxable income.

Rollovers

Rollover contributions consist of amounts rolled over by participants from another qualified plan as defined by the Internal Revenue Code ("IRC").

Allocation of Forfeitures

Forfeitures attributable to Plan Sponsor matching contributions are used to reduce the Plan Sponsor's contribution or to pay Plan expenses. There were accumulated forfeitures of \$8,693 and \$2,589 at December 31, 2024 and 2023, respectively. There were \$5,788 and \$16,848 of forfeitures used to reduce the Plan Sponsor's contributions during the years ended December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Trustee would value the trust and the shares of all participants as of the termination date and would distribute, as soon as possible, the balance of the accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Investment income consists of interest and dividend income and participant loan interest. The net appreciation in the fair value of investments consists of realized gains or losses and the unrealized appreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the basic financial statements and related notes to the financial statements. Actual results could differ from those estimates. The Plan utilizes various investment instruments, including mutual funds, common collective trust funds, and a stable value fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

Uncertain Tax Positions

Under the Income Taxes Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC"), Plan management is required to identify potential uncertain tax positions taken, assess and quantify those positions and record reserves. As of and for the years ended December 31, 2024 and 2023, Plan management has identified no uncertain tax positions.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 4 - INVESTMENTS

The Plan's investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. The fair value amounts presented in the below tables are intended to permit reconciliation of the fair value hierarchy to total investments at fair value. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.
- Common/collective trusts: Value at the NAV of the underlying investments held by the funds. NAV is used as a practical expedient to estimate fair value.
- Stable value fund: Value at the NAV of the underlying investments held by the funds. NAV is used as a practical expedient to estimate fair value.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan, an adopted standardized prototype profit sharing plan with cash or deferred arrangement, obtained its determination letter as on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
