### (1) Description of Plan

The following brief description of the Airline Hydraulics Corporation (the Company) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the trust agreement for a complete description of the Plan's provisions.

#### ***General***

The Company established the Plan effective January 1, 2005. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The administrative committee, appointed by the Company's Employee Stock Ownership Trust, is responsible for oversight of the Plan. The Plan was amended and restated effective January 1, 2024.

#### ***Eligibility***

All employees of the Company and its participating subsidiaries (except employees whose terms of employment are determined by collective bargaining agreements) become eligible to participate in the Plan if they are age 21 and have completed 1,000 hours of service during the first full 12 months of employment or subsequent plan year. A participant's entry date is the January 1 immediately preceding the latter of the completion of 1,000 hours of service during an eligibility computation period or the date the employee attains the age of 21. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

#### ***Payment of Benefits***

Each participant who owns 5% or more of the Company shall begin receiving distributions of his or her account under the Plan in accordance with the IRC no later than April 1st of the year following the calendar year in which the participant attains age 73, whether or not the participant is still employed by the Company. Each retired or terminated participant that does not own 5% or more of the Company shall begin receiving distribution of his or her account under the Plan in accordance with the IRC no later than April 1st of the year following the calendar year in which the participant attains age 73. Active participants who are age 65 or older are also eligible for in-service distributions, subject to payout provisions as defined by the Plan. Terminated participants may also elect to receive distributions commencing no later than one year after the fifth year following the plan year in which such termination occurs.

#### *Payment of Benefits, Continued*

Prior to January 1, 2023, the distribution of the participant's account was made in five equal installments annually in an amount equal to the number or value of the shares of the Company stock in the participant's account divided by the remaining number of annual installments to be paid. Effective January 1, 2023, the distribution of the participant's account will be made in three annual installments based on the value of the participant's account. Participants with an account balance less than \$350,000 will receive a lump sum payment equal to the value of their account. Participants who terminate employment with the Company and its participating subsidiaries with vested balances of \$7,000 or less will receive a lump sum by the end of the plan year following the plan year in which such termination occurs.

Under the provisions of the Plan, the Plan is obligated to repurchase participants' shares which have been distributed under the terms of the Plan as long as the shares have not been publicly traded. The Company makes contributions in cash to the Plan to enable the Plan to repurchase the shares. During 2024 and 2023, the Plan repurchased from participants 1,175 and 1,499 shares, respectively, at prices determined from the independent appraisal.

#### *Voting Rights*

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee shall vote such allocated shares of Company stock as instructed by participants. Allocated shares for which no instruction is received shall be voted by the trustee at their discretion.

#### *Plan Termination*

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be fully vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan and the IRC. Upon termination of the Plan, the trustee will pay all liabilities and expenses of the trust fund and sell shares of financed stock, if any, held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

#### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of plan earnings, the Company's contributions and any forfeitures. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation, as defined. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to the total Plan balance. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

#### *Put Option*

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### *Vesting*

Subject to certain provisions as fully described in the plan document, the portion of the participant's account that is vested (nonforfeitable) on any specified date shall be determined on the basis of his or her years of service in accordance with the following schedule:

A participant's account shall also become 100% vested and nonforfeitable upon the participant's attainment of his or her normal retirement age (age 65) and five years of participation in the Plan while employed by the Company, or upon the participant's death or disability while employed by the Company.

#### *Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 and with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash or rollover distribution.

#### *Forfeited Accounts*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants at December 31, 2024 and 2023, totaled \$270,449 and \$424,328, respectively.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The common stock of the Company is stated at estimated fair value on December 31, 2024 and 2023. Estimated fair value is determined by an annual independent appraisal. Other plan assets are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

#### *Investment Valuation and Income Recognition, Continued*

Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of plan assets includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Administrative Expenses*

The Administrative Committee controls and manages the operation of the Plan. TI-Trust, Inc. serves as the trustee and custodian of the Plan. Certain administrative expenses of maintaining the Plan are paid by the Company.

#### *Subsequent Events*

The Plan has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include

  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual fund:* Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

*Airline Hydraulics Corporation, common stock:* The Company's stock is not actively traded and significant other observable inputs are not available. Thus, the fair value of the common stock is determined by an annual independent appraisal. Certain administrative functions of the Plan are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.

### (5) Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 25, 2013, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Risks and Uncertainties

The Plan's investment in Company common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. The Plan invests in a mutual fund which is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### (1) Description of Plan

The following brief description of the Airline Hydraulics Corporation (the Company) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the trust agreement for a complete description of the Plan's provisions.

#### ***General***

The Company established the Plan effective January 1, 2005. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The administrative committee, appointed by the Company's Employee Stock Ownership Trust, is responsible for oversight of the Plan. The Plan was amended and restated effective January 1, 2024.

#### ***Eligibility***

All employees of the Company and its participating subsidiaries (except employees whose terms of employment are determined by collective bargaining agreements) become eligible to participate in the Plan if they are age 21 and have completed 1,000 hours of service during the first full 12 months of employment or subsequent plan year. A participant's entry date is the January 1 immediately preceding the latter of the completion of 1,000 hours of service during an eligibility computation period or the date the employee attains the age of 21. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

#### ***Payment of Benefits***

Each participant who owns 5% or more of the Company shall begin receiving distributions of his or her account under the Plan in accordance with the IRC no later than April 1st of the year following the calendar year in which the participant attains age 73, whether or not the participant is still employed by the Company. Each retired or terminated participant that does not own 5% or more of the Company shall begin receiving distribution of his or her account under the Plan in accordance with the IRC no later than April 1st of the year following the calendar year in which the participant attains age 73. Active participants who are age 65 or older are also eligible for in-service distributions, subject to payout provisions as defined by the Plan. Terminated participants may also elect to receive distributions commencing no later than one year after the fifth year following the plan year in which such termination occurs.

#### *Payment of Benefits, Continued*

Prior to January 1, 2023, the distribution of the participant's account was made in five equal installments annually in an amount equal to the number or value of the shares of the Company stock in the participant's account divided by the remaining number of annual installments to be paid. Effective January 1, 2023, the distribution of the participant's account will be made in three annual installments based on the value of the participant's account. Participants with an account balance less than \$350,000 will receive a lump sum payment equal to the value of their account. Participants who terminate employment with the Company and its participating subsidiaries with vested balances of \$7,000 or less will receive a lump sum by the end of the plan year following the plan year in which such termination occurs.

Under the provisions of the Plan, the Plan is obligated to repurchase participants' shares which have been distributed under the terms of the Plan as long as the shares have not been publicly traded. The Company makes contributions in cash to the Plan to enable the Plan to repurchase the shares. During 2024 and 2023, the Plan repurchased from participants 1,175 and 1,499 shares, respectively, at prices determined from the independent appraisal.

#### *Voting Rights*

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee shall vote such allocated shares of Company stock as instructed by participants. Allocated shares for which no instruction is received shall be voted by the trustee at their discretion.

#### *Plan Termination*

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be fully vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan and the IRC. Upon termination of the Plan, the trustee will pay all liabilities and expenses of the trust fund and sell shares of financed stock, if any, held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

#### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of plan earnings, the Company's contributions and any forfeitures. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation, as defined. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to the total Plan balance. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

#### *Put Option*

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### *Vesting*

Subject to certain provisions as fully described in the plan document, the portion of the participant's account that is vested (nonforfeitable) on any specified date shall be determined on the basis of his or her years of service in accordance with the following schedule:

Years of Service	Percentage
Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

A participant's account shall also become 100% vested and nonforfeitable upon the participant's attainment of his or her normal retirement age (age 65) and five years of participation in the Plan while employed by the Company, or upon the participant's death or disability while employed by the Company.

#### *Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 and with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash or rollover distribution.

#### *Forfeited Accounts*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants at December 31, 2024 and 2023, totaled \$270,449 and \$424,328, respectively.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The common stock of the Company is stated at estimated fair value on December 31, 2024 and 2023. Estimated fair value is determined by an annual independent appraisal. Other plan assets are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

#### *Investment Valuation and Income Recognition, Continued*

Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of plan assets includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Administrative Expenses*

The Administrative Committee controls and manages the operation of the Plan. TI-Trust, Inc. serves as the trustee and custodian of the Plan. Certain administrative expenses of maintaining the Plan are paid by the Company.

#### *Subsequent Events*

The Plan has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.

### (3) Fair Value Measurements

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual fund:* Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

*Airline Hydraulics Corporation, common stock:* The Company's stock is not actively traded and significant other observable inputs are not available. Thus, the fair value of the common stock is determined by an annual independent appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraisal takes into account historical and projected cash flow and net income, return on assets, return on equity, market comparable, and estimated fair value of Company assets and liabilities. As of December 31, 2024 and 2023, the stock was valued at \$6,675 and \$5,410 per share, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### *Changes in Fair Value of Level 3 Investments*

During 2024 and 2023, there were no transfers into or out of the investment and no purchases of the investment included in level 3 of the fair value hierarchy. The unrealized gain on the Company's common stock is included in the net appreciation in fair value of investments on the statements of changes in net assets available for benefits.

#### (4) Related Party Transactions and Party-In-Interest Transactions

Plan investments are managed by TI-Trust, Inc., the custodian of the Plan, and Principal Trust Company serves as the plan record keeper. In addition, certain administrative fees were paid to TI-Trust, Inc. and Principal Trust Company. Transactions with these parties qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. The Company pays certain other expenses related to the Plan's operations directly.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.

### (5) Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 25, 2013, that the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Risks and Uncertainties

The Plan's investment in Company common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. The Plan invests in a mutual fund which is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
