**1. Description of Plan**

McAngus Goudelock and Courie, LLC (the “Firm”) adopted the McAngus Goudelock and Courie, LLC 401(k) Profit Sharing Plan (the “Plan”) to provide retirement benefits to substantially all of its employees. The following description of the Plan provides only general information. Participants may refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan benefits the employees of the Firm and MGC Sports, LLC through a multiple-employer arrangement in which the employers do not have common ownership, as well as Congaree Title and Abstracting, LLC (collectively, the “Companies”) through a participation agreement. The Plan is a defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees may become participants in the 401(k) employee deferral portion of the Plan after completing thirty days of service and attaining age twenty-one. Employees are required to complete 1,000 hours of service during the Plan year and be employed by the Companies on the last day of the calendar year to participate in the Companies’ matching and profit sharing portions of the Plan. Once an employee has met all of the eligibility requirements, they are automatically enrolled into the Plan at a deferral rate of 3% of pretax compensation and must opt out of the Plan in order to decline to participate.

**Contributions**

Participants may contribute any percentage or amount of pretax annual compensation, after-tax Roth 401(k) contributions, or a combination of the two, up to the maximum annual amount permitted by statute. Participants may also contribute rollover distributions from other qualified benefit plans. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows for discretionary safe harbor contributions determined by the Firm on an annual basis. The Companies made no discretionary safe harbor contributions in 2024 and 2023. The Plan permits other discretionary contributions, including: non-safe harbor matching, qualified non-elective, qualified matching, and discretionary contributions made to the profit sharing portion of the Plan. The Firm approved discretionary contributions totaling \$2,250,000 and approximately \$1,275,000 for 2024 and 2023, respectively.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's 401(k) account is credited with the participant's contributions, administrative expenses, and earnings or losses thereon. Each participant's profit sharing account is credited with an allocation of the Companies contributions, if any, and Plan earnings or losses, and is charged with an allocation of any administrative expenses paid by the Plan. The Companies' safe harbor contributions are allocated based on the ratio of each participant's compensation, as defined, to the total compensation of all Plan participants for the Plan year. Other contributions by the Companies are allocated based on the ratio of each participant's compensation, as defined, to the total compensation in the participant's designated employee group as defined by the Plan.

Participants may elect to allocate current contributions into any of the investment options offered by the Plan. Participants may change their investment options at any time. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are always 100% vested in their deferrals, Firm safe harbor, Firm qualified non-elective, and Firm qualified matching contributions to the Plan. For all other Firm contributions, a participant is 20% vested at the end of two years of continuous service, with additional vesting of 20% annually for each of the next four years, resulting in 100% vesting after the sixth year. A participant's account is also 100% vested under the Plan upon death, disability, or attaining normal retirement age regardless of years of service.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, participants, or their beneficiaries, may elect to receive their vested portion of Plan assets under several payout options specified in the Plan. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions. Subject to certain conditions, participants are permitted to make hardship withdrawals from their vested account balance in the Plan in cases of severe financial hardship while employed.

## **1. Description of Plan (continued)**

### **Forfeited Accounts**

Participant forfeitures may be used to pay Plan expenses or reduce the Companies' contributions. As of December 31, 2024 and 2023, unallocated forfeited non-vested accounts totaled approximately \$43,000 and \$41,000, respectively. The Plan used approximately \$41,000 and \$32,000 to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

### **Notes Receivable from Participants**

Participants may borrow from their accounts, subject to certain restrictions. Loans must be made available to all participants on a reasonably equivalent basis and must not exceed 50% of each participant's vested account balance. The minimum amount of any loan is \$1,000 and may not exceed \$50,000. Loan terms range from one to five years, except for loans made for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 5.25% to 10.50% as of December 31, 2024. Interest rates are established on the date of the loan and are based on prime plus two percent at the date the loan is issued. Principal and interest are paid ratably through payroll deductions. A participant may have no more than one note receivable outstanding at any time.

### **Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company's contributions.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

### **Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Gains and losses included in changes in net assets available for plan benefits are reported in net appreciation (depreciation) in fair value of investments.

### **Indirect Compensation**

Management has established a segregated account within the Plan which receives Rule 12b-1, shareholder servicing and sub-transfer agency payments paid by mutual funds in which the Plan invests. The Plan received approximately \$299,000 and \$256,000 from these sources in 2024 and 2023, respectively, which is recorded as indirect compensation in the accompanying statements of changes in net assets available for plan benefits. Indirect compensation is used to pay Plan expenses and any excess funds are available to be allocated to participants.

Plan assets include unallocated indirect compensation of approximately \$169,000 and \$127,000 at December 31, 2024 and 2023, respectively.

### **Risks and Uncertainties**

The Plan may invest in investment securities that are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for plan benefits.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

The Plan paid approximately \$225,000 and \$148,000 for contract administration, investment and professional fees during 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions, but are exempt from the prohibited transaction rules of ERISA.

## **3. Plan Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, net appreciation (depreciation) in fair value of investments, and interest was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

## **4. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan's mutual fund investments and money market fund were valued using Level 1 inputs, based on quoted market prices of the shares held by the Plan.

**4. Fair Value Measurements (continued)**

The Plan's investments include the Federated Capital Preservation Fund, a collective trust that invests in a variety of fully benefit-responsive investment contracts. The Federated Capital Preservation Fund is valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of the fund is based on the fair value of the underlying investments held, less the fund's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the trust provider reserves the right to temporarily delay withdrawal from the fund in order to ensure that security liquidations will be carried out in an orderly business manner.

**5. Income Tax Status**

The Plan is a volume submitter plan, provided by CDM Retirement Consultants, Inc., designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Internal Revenue Service ("IRS") has determined by a letter dated June 30, 2020 that the volume submitter plan, as then designed, was in accordance with applicable sections of the IRC. The volume submitter plan has been amended since receiving the opinion letter. However, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. As a result, Plan management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

During 2024, operational errors were discovered related to delinquent participant contributions. Management determined that the impact of the errors on the Plan's 2024 financial statements is not significant and expects to make the necessary corrections in 2025 in order to preserve the Plan's tax exempt status.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Subsequent Events**

The Plan evaluated events and transactions after December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued. No subsequent events were noted.
