Independent Auditor's Report

Opinion

We have audited the financial statements of the CBC Companies, Inc. Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Description of Plan

The following description of the CBC Companies, Inc. (the Company) Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. Effective January 1, 2019, the Plan was restated, however the administration of the Plan and participant benefits remain materially consistent under the restated Plan agreement.

General

The Plan provides hospital, medical insurance and life benefits, covering substantially all full-time employees of the Company and their dependents and designated beneficiaries. Effective January 1, 2016, the Plan was amended to change the name of the Plan and include benefits for dental, vision, short-term disability (STD), long-term disability (LTD) and accidental death and dismemberment (AD&D) coverage to the same aforementioned employees, dependents and their beneficiaries. Effective January 1, 2024, the Plan added supplemental health benefits including accident, critical illness, and hospital indemnity coverage. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan covers full-time employees working at least 35 hours per week. Full-time employees working at least 30 hours per week are eligible for medical coverage only, pursuant to the Affordable Care Act.

For medical (including the supplemental health benefits), dental and vision coverage, exempt employees are eligible the first of the month following employment. Non-exempt employees are eligible for medical coverage the first of the month following two months of employment, and eligible for dental and vision coverage the first of the month following three months of employment. For basic life, voluntary life, LTD and AD&D coverage, employees are eligible the first of the month following six months of employment. For STD coverage, employees are eligible the first of the month following one year of employment.

During 2024 and 2023, current claims of active participants and their dependents and beneficiaries are provided for under group insurance contracts with Anthem Blue Cross Blue Shield (Anthem), Delta Dental Plan of Ohio (Delta), and Voya Financial (Voya). During 2023, the vision carrier was Anthem Blue View Vision. The vision carrier changed to National Vision Administrators (NVA) in 2024.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Description of Plan (continued)

Contributions

The Company remits on behalf of its employees their portion of insurance premiums, which is based upon a predetermined amount per pay period for major medical coverage. For the medical coverage (excluding additional supplemental health benefits added in 2024), the Company makes contributions to the Plan for benefits in an amount equal to health claims paid by Anthem in excess of participant contributions.

Premiums for dental, vision, voluntary life, accident, critical illness and hospital indemnity insurance is fully funded by employees, which is based on a predetermined amount per pay period and remitted to Delta (dental), NVA (vision, commencing in 2024), Anthem Blue View Vision (vision, up through change in provider in 2024), and Voya (voluntary life, accident, critical illness and hospital indemnity), respectively. Premiums for short term-disability insurance is funded half by the employees, which is based on a predetermined amount per pay period and remitted to Voya. Premiums for basic life, long-term disability and accidental death and dismemberment insurance are funded entirely by the Company, which is remitted to Voya.

The Plan also offers a health savings account to employees eligible for medical coverage. During 2024 and 2023, any employee enrolled in the health savings account was provided with a \$750 contribution from the Company.

Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims, eligibility credits, claims payable and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Stop Loss

The Plan maintains insurance for stop-loss coverage for health claims at both an individual and aggregate level and is fully insured for death benefits. Credits from stop-loss coverage were not material during 2024 and 2023, and have been included within health care benefits paid in the accompanying financial statements.

Concentration of Credit Risk

Cash is held in an interest bearing checking account at one financial institution. The Plan occasionally maintains cash deposits in excess of federally insured limits.

Benefit Obligations

Benefit obligations at December 31, 2024 and 2023 are related to medical claims payable that are currently due and claims incurred but not yet reported to the Plan for active participants. The obligations are estimated primarily based on the most recent year's claims experience. Actual results could differ from the estimated benefit obligation.

Administrative Expenses

Anthem provides custodial and administrative services related to the medical benefit payments of the Plan. All medical benefit claims are managed, evaluated for propriety and disbursed by Anthem. The Plan includes any rebates and similar cost offsets received during the Plan year as an offset to administrative expenses. When the total of rebates and similar cost offsets exceed administrative expenses, the Plan presents the total as other income in the accompanying financial statements.

Plan Termination/Modification

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Tax Status

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Trust's net investment income is exempt from income taxes. The Plan was restated effective January 1, 2019. The Company obtained its latest determination letter on September 28, 1999, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the IRC. The Company believes that the Plan continues to qualify and to operate as designed. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Parties-in Interest Transactions

The Plan paid premiums, stop-loss insurance premiums, and third-party administration fees to Anthem of approximately \$392,000 and \$1,001,000 in 2024 and 2023, respectively.

Subsequent Events – Date of Management’s Evaluation

Management has evaluated subsequent events through the date of the Independent Auditor’s Report, the date on which the financial statements were available to be issued.
