**Notes to the Financial Statements
December 31, 2024 and 2023**

1. DESCRIPTION OF THE PLAN

The following brief description of the Elsie Whitlow Stokes Community Freedom Public Charter School Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan was created on February 1, 2002 and is a defined contribution 403(b) plan which provides retirement, death and disability benefits for employees of Elsie Whitlow Stokes Community Freedom Public Charter School (the School). The Board of Directors is responsible for oversight of the Plan. The Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

The Plan was last amended and restated effective January 1, 2018.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

Contributions

The employer makes contributions to the Plan on behalf of qualifying participants based on eligible compensation, as defined by the Plan document. Qualifying participants are those who have completed one year of service. Participants may also rollover distributions from other qualified defined contribution plans. Employee deferrals and Roth contributions are not permitted. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Employer contributions are based on years of service, as follows:

Greater than 1 but less than 4	3%

1. DESCRIPTION OF THE PLAN (continued)

Contributions (continued)

Upon enrollment, a participant may direct contributions into any of the Plan's investment options. Participants may change their investment options for future contributions as well as transfer existing account balances within the Plan's investment options at any time.

Participant Accounts

Each participant's account is credited with the employer contributions, as well as allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific transactions as defined by the Plan. The participant is entitled to a benefit that cannot exceed their vested account.

Vesting

Participants are immediately vested in the employer's contributions plus actual earnings thereon.

Payment of Benefits

Participants or their beneficiaries are eligible for distributions in the form of partial distributions, installment payments, annuity contracts or lump sum benefits upon termination, retirement, or death. Participants who are still actively employed are eligible for distribution after reaching age 59½. In the event of hardship, as defined in the Plan document, participants may withdraw some or all of their vested account balance.

Plan Termination

Although it has not expressed any intent to do so, the School has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants remain 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The School determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Employer contributions are recorded when due to the Plan.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's management evaluated subsequent events and transactions through October 3, 2025, the date these financial statements were available for issue, and have determined that no other subsequent events have occurred that would affect the information presented or require additional disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA and CREF, the custodian of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Traditional Annuity: The TIAA Traditional Annuity is reported at contract value. The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers, if any, less any withdrawals and transfers, if any. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled Separate Account: The TIAA Real Estate Account (REA) is valued at the market value of the underlying real estate holdings or other real estate related investments as well as such liquid fixed income investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA also holds liquid, fixed income investments. These are generally priced using quoted prices in active markets or values obtained from independent pricing sources. Accumulation units are available for transactions at the closing accumulation unit value on any date the New York Stock Exchange (NYSE) is open for business.

5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments consist of an insurance annuity contract with TIAA, a pooled separate account with TIAA, and various registered investment companies managed by TIAA and CREF and, therefore, these transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

6. TAX STATUS

The Plan was designated using a volume submitter plan document which received an opinion letter from the Internal Revenue Service (IRS) stating that the volume submitter plan document was in compliance with the applicable requirements of Internal Revenue Code (the Code).

On December 23, 2022, the School filed with the Internal Revenue Service (IRS), proposing a retroactive amendment to the Plan that would conform the terms of the Plan document relating to the employer contributions to the actual operation of the Plan. During the year ended December 31, 2023, the retroactive amendment was denied, and the School amended the Plan to conform to employer contributions to the actual operation of the Plan which was the intent of the Plan's sponsor. The Plan's sponsor is currently in the process of calculating the additional required contributions to participants. Plan management believes the amount of the additional contributions, lost earnings, and applicable penalties will be immaterial to the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's management performed an evaluation of uncertain tax positions as of December 31, 2024 and 2023. Management believes any penalties as a result of the issues noted in the previous paragraph, if any, would be assessed to the Plan's sponsor and not to the Plan and thus no liability would be required to be accrued in the accompanying financial statements. Management also believes, after consultation with legal counsel, the Plan will retain its tax-exempt status. The Plan Administrator believes the Plan remains qualified and tax-exempt and is no longer subject to income tax examinations for years prior to 2021.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.


