## INDEPENDENT AUDITOR'S REPORT

To the plan administrator and participants of

### 1. Plan Description

The following description of Society of St. Vincent de Paul Council of Los Angeles 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan, originally effective October 1, 2010, and restated January 1, 2020, is a defined contribution plan organized under Section 403(b) of the Internal Revenue Code (IRC) covering all employees of Society of St. Vincent de Paul Council of Los Angeles (the Employer), excluding employees who normally work less than 20 hours per week and certain other classes of employees as set forth in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### b. Contributions

Participants are immediately eligible to contribute up to 100 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. The Plan provides for automatic election of deferrals at a rate of 3 percent of compensation for all new participants. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year.

Employer contributions are discretionary. Participants are eligible to receive employer contributions upon completing one year of credited service and 1,000 hours, as defined in the plan document. During 2024, the Employer made nonelective contributions totaling \$100,638.

#### c. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and the Plan's earnings or losses. Certain transaction expenses or other fees are paid by the participant who incurred them. Each participant is entitled only to the benefits that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### d. Distribution of Benefits

Upon termination of service due to death, disability, or retirement, participants may elect to receive the value of their vested account balance in a lump-sum distribution or installment payments. Additionally, certain annuity options may be available based on the provisions of the Plan's group or individual annuity contracts. In-service withdrawal options are available to participants under certain circumstances.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions portion of their accounts plus actual earnings thereon is based on years of credited service as follows:

f. Notes Receivable from Participants

The Plan allows for loans to be made to participants subject to ERISA and plan guidelines. A participant may request a loan for up to the lesser of a) 50 percent of the participant's vested interest or b) a maximum of \$50,000 minus any outstanding loan balance(s) in the last 12 months. The loans are secured by the balance in the participant's account and bear interest at 5.25 to 10.50 percent. Loan terms may range up to five years and may be longer if the loan is used by the participant to acquire a principal residence. Principal and interest are paid ratably through payroll deductions.

Loans that were issued under individual annuity contracts with MassMutual Ascend Life Insurance Company (MassMutual Ascend) are collateralized by the portion of the participant's account balance under the contract. Loan proceeds are issued from the general assets of MassMutual Ascend and not from the borrowing participant's own account. Principal and interest are paid directly to MassMutual Ascend. As such, these loans are not included in plan assets. Interest rates for loans issued by MassMutual Ascend average approximately 3.00 percent and are subject to a maximum rate of 8.00 percent. A total of \$1,299 in participant account balances at MassMutual Ascend served as collateral for loans to participants at December 31, 2023. There was no balance at December 31, 2024.

g. Forfeited Accounts and Unallocated Assets

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,168 and \$3,895, respectively. These accounts will be used to pay plan expenses and reduce future employer contributions. During 2024, forfeited non-vested accounts were used to pay for \$3,912 of plan expenses. In addition, unallocated deposits have been deposited into an unallocated assets account. At December 31, 2023, unallocated assets totaled \$2,473. There were no unallocated assets as of December 31, 2024. During 2024, unallocated assets were used to pay for \$2,554 of plan expenses.

### 2. Summary of Significant Accounting Policies

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### c. Investment Valuation and Income Recognition

Except as noted below, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value, also referred to as book value, is equal to total contributions allocated to the investment, less withdrawals and expenses, plus accrued interest.

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets available for benefits.

Insurance contracts, as distinguished from investment contracts, subject the issuer to insurance risks including, but not limited to, mortality or morbidity of plan participants. Insurance contracts are permitted but not required to be reported at fair value. FASB ASC 962-325, paragraph 35-6, prescribes valuing insurance contracts in the same manner as they are reflected in the Form 5500. For the Plan's insurance contracts, this is contract value, which is the amount determined by and provided to the Plan by the insurance entity. Contract value, also referred to as book value, is equal to total contributions allocated to the investment, less withdrawals and expenses, plus accrued interest.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in the Form 5500 and related supplemental schedules. Delinquent loans are treated as distributions based upon the terms of the plan document. Certain participant loans that are collateralized by the participants' accounts are not included in plan assets (see Note 1f).

e. Payment of Benefits

Benefits are recorded when paid.

f. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

g. Subsequent Events

The Plan has evaluated the subsequent events through September 23, 2025, the date the financial statements were available to be issued.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Exempt Status

The Employer has adopted a volume submitter plan document that received a favorable advisory letter from the IRS dated February 1, 2018. The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Employer routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Certified Investment Information

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company and MassMutual Ascend Life Insurance Company, the Insurers of the Plan, and Reliance Trust Company, the Custodian of the Plan, have certified that the following investment information is complete and accurate:

- Fair value and contract value of investments and carrying amount of cash noninterest-bearing as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income as reflected in the Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024.
- Investment information as reflected in Note 4 to these financial statements.
- Investment information reflected in the Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

### 7. Investment Contract with Insurance Company

The Standard Stable Asset Fund is a fully benefit-responsive investment contract with Standard Insurance Company. Standard Insurance Company holds the contributions in its general account. The contract is credited with interest as declared by the insurance company each quarter, with a guaranteed minimum rate of 1 percent. The investment contract issuer is contractually obligated to repay the principal and interest at the guaranteed rate to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### 9. Plan Termination

The Employer has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

### 10. Insurance Contracts

The Plan holds insurance contracts with MassMutual Ascend Life Insurance Company. The contracts are carried at accumulated contract value in the Plan's financial statements as reported by the insurance companies. Accumulated contract value equals the total cash contributions, transfers, and interest credited to the contract, less the total of withdrawals, transfers and administrative expenses deducted from the contract.

10. Insurance Contracts (Continued)

Surrender charges are established based on the terms of the insurance contracts and reduce the amount of the contract's value upon liquidation. Surrender charges, also referred to as contingent deferred sales charges, are applicable to withdrawals that exceed 10 percent of the accumulated value of the contract within any single annual period. Certain waivers are set forth in the contracts under which surrender charges would not be applicable (e.g., in the event of the disability of the participant).

Surrender charges apply based on schedules set forth in the contracts under which a maximum surrender charge is established for the first year, followed by decreases in subsequent years based on the surrender charge schedule set forth in the contract. Surrender charge schedules range from 7 to 14 years in duration and have a maximum surrender charge of 15 percent. Surrender charge schedules may be rolling or non-rolling. Rolling surrender charge schedules are separately applicable to each individual premium payment, whereas non-rolling schedules apply at the contract level and begin for all premium payments at the date the contract was established and issued to the participant. Surrender charges applicable to insurance contracts held at December 31, 2024 and 2023, totaled \$0 for both years.


