NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN

The following description of the Bridge Homecare Partners (Company) 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution 401(k) profit sharing plan covering substantially all employees of Bridge Homecare Partners who are 21 years or older. Effective May 1, 2019, the Plan was amended to include a service requirement of 60 days. Employees become participants on the first day of the month following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions - Each year, participants may make Roth deferrals and pre-tax elective deferrals up to a maximum dollar limit set by law, as defined in the Plan. All employees hired on or after April 1, 2019 will be sent an auto enrollment notice by the Plan Administrator. If an eligible employee fails to make a deferral or opt-out election, they will automatically be enrolled with a pre-tax elective deferral of 4%. Each January, participants will receive automatic 1% annual deferral increases up to a maximum of 10%. The Company will make a safe harbor non-elective contribution to the Plan in an amount not less than 3% of the employee's eligible earnings, even if the employee does not make any elective deferrals. The Company may make a matching contribution, qualified non-elective contribution, and/or profit sharing contribution to the Plan at its discretion. Eligibility for profit sharing contributions include at least 1 hour of service during the Plan year. Participants may make both before-tax and Roth rollovers to the Plan.
3. Participant Accounts - Each participant's account is credited with his or her contribution, the Company's safe harbor contribution and an allocation of Plan earnings. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. If applicable, matching contributions, qualified non-elective contributions, and/or profit sharing contributions will be credited to the respective accounts for each participant. Benefit amounts of discretionary contributions are determined by the Company. Roth rollovers will be recorded in a Roth rollover account.

A. DESCRIPTION OF PLAN - (Continued)

4. Vesting - Participants are always 100% vested in their elective deferral, safe harbor non-elective, rollover and qualified non-elective contributions, plus actual earnings thereon. Participants also become fully vested in the Company's contributions regardless of years of service at age 65 or upon death or disability. If a participant leaves the Company for any other reason, vesting in the participant's matching contributions account and profit sharing contributions account, plus any earnings thereon is based on years of vesting service. A year of vesting service is defined as a plan year in which 1,000 hours of service is completed. A participant is 100% vested in such contributions after four years of credited service, with 25% vesting each year.
5. Notes Receivable from Participants - Participants may borrow up to 50% of their vested account balance with a maximum of \$50,000. The \$50,000 is reduced by the highest outstanding loan balance the participant had under the Plan during the previous one-year period. The minimum loan is \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates of prime plus 2%. Principal and interest is paid ratably through weekly payroll deductions.
6. Investment Options - The participant directs the investment of their contributions and the Company's matching contribution into various investment options offered by the Plan.
7. Payment of Benefits - On termination of service for any reason, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals for financial hardship are permitted provided certain conditions are satisfied.
8. Forfeited Accounts - At December 31, 2024 and 2023 forfeited, non-vested accounts totaled \$1,221 and \$2,966, respectively. These accounts will be used to reduce future employer contributions, reduce plan expenses, or reallocated as employer contributions. Employer matching contributions were reduced by \$0 and \$0, and plan expenses were reduced by \$2,054 and \$0 during the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$26 and \$617 were reallocated as employer profit sharing during the years ended December 31, 2024 and 2023, respectively.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions were distributed in the amount of \$0 and \$0 during the years ended December 31, 2024 and 2023, respectively.

6. Payment of Benefits

Benefits are recorded when paid.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

8. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

C. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Investments are held in Pooled Separate Accounts (PSA's). The PSA's offered are proprietary to Voya and many invest exclusively in one underlying mutual fund traded on an established market. The underlying mutual funds held by the Plan are deemed to be actively traded. All of Voya's PSA choices are valued daily using publicly available quoted market prices.

D. INVESTMENTS

During 2024 and 2023, the value of the Plan's investments (including investments bought, sold, and held during the year) appreciated in fair value by \$1,029,583 and \$1,701,899, respectively.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The plan holds a traditional investment contract with Voya Retirement Insurance and Annuity Company ("VRIAC"). VRIAC maintains the contributions in a general account (the Voya Fixed Account). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT - (Continued)

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the established floor rate. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or the plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

F. TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments were managed by Voya Retirement Insurance and Annuity Company, trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Voya Retirement Insurance and Annuity Company for contract administration services amounted to \$9,950 and \$4,600 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan transactions were managed by Dynamic Pension Services Inc., third party administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Dynamic Pension Services Inc. for contract administration services amounted to \$20,195 and \$4,745 for the years ended December 31, 2024 and 2023, respectively.

G. PLAN TERMINATION

In March of 2024, the Plan partially terminated due the closure of a division. At that time, the terminated participants became 100 percent vested in their accounts. Although it has not expressed any intent to fully terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to fully terminate the Plan subject to the provisions of ERISA. In the event of full Plan termination, participants will become 100 percent vested in their accounts.

H. INCOME TAX STATUS

The prototype plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
