## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Binford Metals 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

#### NOTE 1. Description of the Plan

The following description of the Binford Metals 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

#### General:

The Plan is a contributory defined contribution plan established October 1, 2008 covering all eligible employees of Binford Metals L.L.C., the Sponsor. Eligible employees are those employees who have reached eighteen years of age and completed one year of service. Employees that are covered by a collective bargaining agreement and a non-resident alien are not eligible to participate in the Plan. Eligible employees may enter the Plan to make salary deferral contributions and receive matching contributions at the first day of the Plan year or the seventh month following the date eligibility requirements are met.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has until December 31, 2026 to formally amend the Plan documents. The Plan is implementing required provisions in accordance with the applicable effective dates and is continually evaluating the optional provisions.

#### Contributions:

Each year participants may contribute pre-tax and Roth 401(k) salary deferrals of annual compensation as defined in the Plan up to the maximum amount allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers) prior to becoming a participant in the Plan.

The Sponsor contributes safe-harbor matching contributions which was 3 percent of eligible wages for the year ended December 31, 2024.

The Sponsor may also make non elective matching contributions at the discretion of the Sponsor. For 2024, the Sponsor did not make any non elective matching contributions.

**NOTE 1. (Continued)**

Participant Accounts and Investment Options:

Contributions from Plan participants and the related Plan Sponsor's safe-harbor matching contribution are recorded in the year in which the employee contributions are withheld from compensation.

Contributions to participant accounts are deposited into participant-directed funds at Empower Annuity Insurance Company of America and Empower Trust Company, LLC. The Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant's account is credited with the participant's contribution and allocation of the Sponsor's contribution and Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

The participants are 100 percent vested in employee salary deferrals, rollovers, Sponsor safe harbor, and the related earnings at all times. Vesting in the Sponsor's discretionary contributions and the related earnings is based on years of credited service. Generally, a participant is 100 percent vested after six years of credited service or upon retirement, death, disability, or termination of the Plan.

Forfeited Accounts:

There were no forfeited accounts during 2024 and 2023, nor were forfeitures utilized for the year ended December 31, 2024.

Payment of Benefits:

A Participant who terminates employment with a vested account balance exceeding \$5,000 may receive a distribution of their vested account balance in any form permitted and terminated participants with a vested account balance less than \$1,000 will automatically be paid as defined in the Plan Document. Terminated participants with account balances that do not exceed \$5,000 may receive a lump sum distribution of their vested account balance.

In addition, the Plan allows for in-service withdrawals upon attainment of age 59 ½, and will only be permitted if the participant is 100 percent vested in the source from which the withdrawal is taken, as specifically permitted by and outlined in the Plan Document. Additionally, if a participant remains employed and must receive required minimum distributions, the participant may elect a lump-sum amount or installment payments.

#### NOTE 2. Summary of Significant Accounting Policies

##### Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

##### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

##### Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Notes 5 and 6 for discussion of fair value measurements and contract value investments, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Date Through Which Subsequent Events Evaluated:

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 9, 2025, which is the date on which the financial statements were available to be issued.

**NOTE 3. Risks and Uncertainties**

The Plan is exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **NOTE 5. Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds (Registered Investment Companies):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques and inputs are appropriate and consistent with other market participants, the use of different techniques and inputs or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 6. Fully Benefit-Responsive Investment Contract

The Plan invests in a traditional, fully benefit-responsive investment contract (FBRIC) with Empower Annuity Insurance Company of America and Empower Trust Company, LLC who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

#### NOTE 6. (Continued)

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than -0- percent. The crediting rate is reviewed on a quarterly basis for resetting. Termination of the FBRIC prior to the scheduled maturity date is prohibited.

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America and Empower Trust Company, LLC represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

The contract value of the investment contract at December 31, 2024 and 2023, was \$192,290 and \$107,954, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

1. Amendments to the plan documents (including complete or partial plan termination or merger with another plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary).
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
5. Premature termination of the contract.

No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from the contract value. Examples of such events include the following:

1. The contract owner's failure to abide by state or federal law.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without the consent of the contract issuer.

### **NOTE 7. Party-in-Interest Transactions and Administration of Plan Assets**

A party-in-interest is defined as a fiduciary or employee of the plan, any person who provides service to the plan, an employer whose employees are covered by the plan, an employee organization whose members are covered by the plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

The Plan's investment options are managed by Empower Retirement, which is an affiliate of Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodian of the Plan. Any transaction executed with Empower Retirement qualifies as a party-in-interest transaction.

As described in Note 2, the Plan Sponsor paid certain expenses related to the Plan operations and investment activities to various service providers.

The Plan Sponsor, Binford Metals, L.L.C., is a party-in-interest. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. The Sponsor has discretion to appoint or remove any trustee or agent of the Plan. The Trustees have full power to administer the Plan and apply all of its provisions on behalf of the Sponsor.

**NOTE 8. Tax Status**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Farmer & Betts, Inc. which received a favorable opinion from the Internal Revenue Service (IRS) dated June 30, 2020. Although the advisory letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

**NOTE 9. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all amounts credited to participant accounts shall become 100 percent vested, regardless of the Plan's current vesting schedule.
