Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Liberty Lift Solutions, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

Liberty Lift Solutions, LLC 401(k) Plan (the Plan) is a defined contribution plan covering all full-time employees of Liberty Lift Solutions, LLC (the Company). The Plan was originally adopted on January 1, 2013 and was most recently amended and restated effective May 15, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Administration: The Board of Directors of the Company is responsible for oversight of the Plan. The 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

Eligibility: All eligible employees of the Company are eligible to participate in the Plan upon date of hire. Participants may enter the Plan on the first day of the month coinciding with or next following the date in which they satisfy the eligibility requirement.

Contributions: Effective January 1, 2024, the Plan was amended and restated to adopt automatic enrollment and escalation features for new participants. Participants are automatically enrolled in the plan at 3% unless affirmative election is made not to do so. Participants may elect to defer up to 89% of their eligible compensation into the Plan on a pre-tax or Roth basis, not to exceed the dollar limit set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to start, increase, or reduce elections to contribute to the Plan effective as soon as administratively feasible. Participants may suspend their elections at any time.

The Company may make a discretionary matching contribution to the Plan on behalf of eligible Plan participants as a percentage of participants salary deferrals. The Company will make a matching contribution equal to 100% of the participants' salary deferrals that do not exceed 4% of their compensation. During 2024, the Company made a matching contribution of \$1,943,360 to the Plan.

The Company may make an additional discretionary profit-sharing contribution to the Plan on behalf of eligible Plan participants in an allocated amount. Participants are eligible to receive profit sharing contributions to the Plan if they are employed by the Company on the last day of the Plan year. The Company will decide each year how much, if any, they wish to make as a discretionary profit-sharing contribution. During 2024, the Company did not make a discretionary profit-sharing contribution to the Plan.

Participants may roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan into this Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct their investment into the Plan into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund and common collective trust funds as investment options for participants. Participants may redirect the investment of future contributions or exchange existing balances among available investment securities at any time.

Vesting: Participants are immediately vested in their deferral contributions, including Roth and catch-up contributions, employer matching contributions, rollover contributions, and discretionary matching contributions, plus any earnings thereon. Vesting in the discretionary profit-sharing contributions is based on years of vesting service. Participants will become 100% vested after five years of service.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Notes Receivable from Participants: Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the excess of their highest outstanding balance of loans during the prior one-year period or 50% of their vested account balance, whichever is less. The loans are adequately secured by the balance in the participant's account and bear a reasonable rate of interest at rates commensurate with local prevailing rates as determined by Plan management. Principal and interest are paid ratably through bi-weekly payroll deductions over a term not to exceed five years unless the loan was obtained to acquire a principal residence.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. If a participant's vested account balance does not exceed \$5,000, then the participant's account balance may only be distributed in a single lump-sum payment. If a participant's account balance exceeds \$5,000, the participant must consent to any distribution before it may be made.

Participants may be entitled to receive an in-service distribution. A participant may request a hardship withdrawal to satisfy certain immediate and heavy financial needs. Participants who have attained age 59½ may receive an in-service distribution from the Plan from fully vested accounts prior to termination of employment.

Forfeited Accounts: If a participant terminates employment before being fully vested, they will forfeit the nonvested portion of their account balance when they receive a distribution. Forfeitures may be used to pay administrative expenses or to reduce employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested. The Company will arrange for distributions upon Plan termination as soon as administratively feasible.

Administrative Expenses: Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. No events have occurred since December 31, 2024, that require adjustment to or disclosure in the financial statements.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Company to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefit are recorded when paid.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – *Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.*
- *Level 3* – *Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.*

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money market and mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair value of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance requirement. The NAV is determined as of the financial statement measurement date. There are no redemption restrictions or unfunded commitments associated with these investments. These collective trusts invest primarily in equities and are subject to risks inherent in such investments, including market volatility and interest rate fluctuations.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 5 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, plan management believes that the Plan is currently being operated in accordance with the IRC. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. T. Rowe Price (T. Rowe) is the Plan's recordkeeper and performs various administrative and investment-related services. Reliance Trust Company serves as the Plan's trustee and custodian. These entities are considered parties-in-interest to the Plan. Certain Plan investments are managed by T. Rowe and as a result, transactions involving these investments and services provided by T. Rowe and Reliance Trust Company qualify as party-in-interest transactions.

Administrative expenses incurred for services provided by these parties may be paid directly by the Plan or by the Company. The Plan permits the use of revenue-sharing arrangements to offset certain fees; however, no revenue-sharing amounts were credited to the Plan during the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.
