### **EFFECTIVE DATE**

The effective date of the plan was January 1, 2018. The plan was last amended effective January 1, 2024.

### **ELIGIBILITY**

An Employee who (a) has attained age 21 on or before July 1, 2018; (b) has completed one Year of Eligibility Service on or before July 1, 2018, or has a corporate title of Managing Director on December 1, 2018; and (c) is an Employee on December 1, 2018, shall be a Participant hereunder on the later of January 1, 2018, or the Employee's date of hire in 2018 by the Employer. An Employee not described in the preceding sentence shall become a Participant on the Entry Date coincident with or next following (a) the date on which the Employee attains age 21, or (b) the date on which the Employee completes one Year of Eligibility Service.

### **EMPLOYEE**

Any common law employee of the Employer with one of the following corporate titles: Vice President, Senior Vice President, Principal, Managing Director or Senior Managing Director; or any individual who is a Partner.

### **ENTRY DATE**

January 1 or July 1.

### **Definitions**

#### **ACCRUED BENEFIT**

The Accrued Benefit means, as of any determination date, the Participant's Cash Balance Account on such date projected, if necessary, with estimated Interest Credits between the determination date and the Participant's Normal Retirement Date, and then converted to an Actuarial Equivalent immediate annuity.

#### **ACCUMULATION CYCLE**

Each business day of the Plan Year.

#### **ACTUARIAL EQUIVALENT**

For converting the accrued benefit to any payment form, an interest rate which is the lessor of 5.00% and the 30-year Treasury Rate for the October preceeding the Plan Year, and post-retirement mortality using the applicable mortality table under code section 417(e)(3)(B).

#### **CASH BALANCE ACCOUNT**

The sum of Contribution Credits and Interest Credits, defined by the Plan as the Cash Balance Account. In no event shall a distribution of the Cash Balance Account be less than the sum of all Contribution Credits credited to the Participant's Cash Balance Account, or greater than the Participant's Contribution Credits had the Plan used a fixed annual interest crediting rate equal to 8.5% for all Contribution Credits credited to the Cash Balance Account since the establishment of such account.

#### **COMPENSATION**

Compensation as defined under Code Section 415(c) and the Treasury Regulations thereunder.

### CONTRIBUTION CREDITS

As of the last day of each Plan Year, a Contribution Credit shall be credited to the Cash Balance Account of each Participant who is an Employee. The Contribution Credit shall be equal to the greater of the following, increased by the Supplemental Amount, if any, assigned for the Plan Year:

- (a) The Benefit Level Multiplier, if any, assigned to the Participant, multiplied by the Participant's Plan Compensation for the Plan Year.
- (b) The Minimum Contribution Credit for the Plan Year.

A Participant shall only earn a Contribution Credit for the Plan Year if he or she has been credited with 1,000 Hours of Service for that Plan Year. If the Participant completed at least 1,000, but less than 2,000, Hours of Service during the Plan Year, the Contribution Credit for such Participant shall be equal to the amount specified above, multiplied by a fraction, the numerator of which is the number of Hours of Service completed by the Participant during the Plan Year and the denominator of which is 2,000.

The Contribution Credit determined above shall not exceed the Maximum Contribution Credit applicable to the Participant for the Plan Year.

### HOURS OF SERVICE

An Employee is credited with 45 Hours of Service for each week during which the Employee is credited with at least one hour of service. For purposes of determining a Participant's Contribution Credit, a "week" means the seven-day period beginning on the first day of the Plan Year and each subsequent seven-day period.

### INTEREST CREDITS

For each Accumulation Cycle the Plan shall determine an Interest Credit on behalf of each Participant. Each such Interest Credit shall be credited to the Cash Balance Account as of the end of such Accumulation Cycle. The Interest Credit is equal to the Rate of Return for the Accumulation Cycle, multiplied by the Participant's Cash Balance Account as of the beginning of the Accumulation Cycle prior to the Contribution Credit, if any, credited to the Participant's Cash Balance Account for the current Accumulation Cycle. Interest Credits shall cease to be credited to a Participant's Cash Balance Account as of the last day of the Accumulation Cycle immediately preceding the Accumulation Cycle in which (1) a lump sum distribution occurs, or (2) a monthly annuity commences.

For any Accumulation Cycle, the Return for such Accumulation Cycle divided by the Adjusted Assets for such Accumulation Cycle, as defined below:

- (a) Return: The market value of the assets in the Trust Fund at the end of the Accumulation Cycle, reduced by the market value of the assets in the Trust Fund at the end of the immediately preceding Accumulation Cycle and contributions made to the Trust Fund during the Accumulation Cycle, if any, & increased by the benefit payments paid from the Trust Fund during the Accumulation Cycle, if any.
- (b) Adjusted Assets: The market value of the assets in the Trust Fund at the end of the immediately preceding Accumulation Cycle, reduced by the benefit payments paid from the Trust Fund during the Accumulation Cycle, if any.

### **SUPPLEMENTAL AMOUNT**

The amount assigned to the Participant in Appendix E of the plan document for the specified Plan Year.

### **Payment of Retirement Benefits**

#### **BENEFIT AMOUNT**

The Cash Balance Account, or its Actuarial Equivalent payable as an annuity, subject to IRS maximums.

#### **BENEFIT ELIGIBILITY**

##### Normal Retirement Benefit

Reaching Normal Retirement Date.

##### Terminated Vested Benefit

Termination of employment after having earned a vested Accrued Benefit.

##### Death Benefit

The spouse or other named beneficiary of an active or terminated participant is eligible upon the participant's death prior to Normal Retirement Age and before benefit payments commence.

#### **BENEFIT PAYMENT FORMS**

The normal form of payment for a single participant is a straight life annuity and for a married participant is a reduced qualified joint and survivor annuity, with 50% of the benefit continuing to the surviving spouse upon the earlier death of the participant.

In lieu of the normal form of payment, a participant may elect a single lump sum payment (with proper spousal consent, if married). A married participant may elect a 75% joint & survivor annuity.

#### **VESTING**

A Participant is fully vested in his or her Cash Balance Account at all times.
