1. Plan description:

United States Distilled Products Co. Employees' 401(k) Plan (the Plan) was established to assist employees to provide for their future security after retirement through employer contributions and employee salary deferrals. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

The Plan was established on March 1, 1999. The Plan is a defined contribution plan covering all individuals who are employed by United States Distilled Products, Co. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan after one hour of service, except for part time, temporary and seasonal employees who are regularly scheduled to work less than 1,000 hours in the Plan's eligibility computation period.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to maximum amounts established by the Internal Revenue Code. The employer may make a discretionary matching contribution. Participants direct the investment of their contributions and matching contributions into various investment options offered by the Plan. For the years ended December 31, 2024, and 2023, the employer matched 30% of employee deferrals up to 18% of eligible compensation.

The employer may also make a discretionary profit-sharing contribution. A profit sharing contribution was not made for the years ended December 31, 2024 or 2023.

Employees are automatically enrolled with a salary deferral of 4%, unless the employee elects not to participate in the Plan or chooses an alternative election percentage. Employees' deferral percentage rates automatically increase annually by one percent, up to a maximum of ten percent, of eligible compensation, unless the participant elects not to have the increase take place.

Participants' account:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or losses, and charged with an allocation of certain transaction charges. Administrative expenses, with the exception of certain transaction charges, are paid by the employer. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant benefits:

Vested amounts credited to each participant's account are generally made available upon retirement, disability, or death of the participant, discontinuance of employment or termination of the Plan. Effective January 1, 2020, the Plan was amended to include all contribution types for in-service hardship distributions.

1. Plan description (continued):

Vesting:

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Participants are vested after three years of service in which each year they have at least 1,000 hours of service for contributions made by the employer.

Forfeitures:

Forfeitures of terminated participants' non-vested accounts are used to reduce future employer contributions. The ending balances in the forfeiture account were \$37,984 and \$21,661 as of December 31, 2024 and 2023, respectively. Forfeitures used were \$15,152 and \$96,372 for the years ending December 31, 2024 and 2023, respectively.

Notes receivable from participants:

Participants may borrow from their Plan accounts. The minimum loan amount is \$1,000 up to a maximum of \$50,000 but not more than 50% of their vested account balance. All loans are to be amortized over a reasonable period, not to exceed five years, or longer for the purchase of a primary residence. Loans are to be secured by the balance in the participant's account and are to bear interest at a rate of 1% plus prime at the date of the loan. The prime interest rate at December 31, 2024 and 2023 was 7.50% and 8.50%, respectively. Principal and interest are to be paid not less than quarterly through payroll deductions.

Employer advance:

The Plan received funding from the Plan Sponsor for contributions related to the first payroll of 2025, related to the January 2, 2025 paid date. These funds are considered an advance and will be applied as contributions to participant balances in 2025.

Subsequent events:

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

2. Summary of significant accounting policies:

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market and participants at the measurement date. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies (continued):

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Fair value measurements:

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value utilizing a hierarchy that prioritizes the valuation inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust (CCT): Measured at fair value using NAV per share as a practical expedient for the shares held at year end. The NAV is determined in accordance with a valuation methodology adopted by the Common Collective Trust's trustee.

2. Summary of significant accounting policies (continued):

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Interest income on notes receivable from participants is recorded when it is earned. The allowance for loan losses is evaluated using current year activity, historical trend information and specific identification. If a participant ceases to make loan repayments and the administrator deems the participant loan to be a distribution, the delinquent note receivable is reduced and a benefit payment is recorded based upon the terms of the plan document. No allowance for uncollectible loans has been recorded as of December 31, 2024 and 2023.

Administrative expenses:

Substantially all Plan expenses are absorbed by the Plan sponsor except for admin transaction fees. These expenses are borne by the participants and are presently separately on the financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

Benefits paid to participants:

Benefits paid to participants are deducted from net assets available for benefits during the year in which the benefits are paid.

Concentrations:

At December 31, 2024 and 2023, approximately 55% and 50%, respectively, of investments were held in four mutual funds in each year.

3. Information Certified by Principal Insurance, N.A.:

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023 and for the years then ended, included throughout the Plan's financial statements and supplemental schedules, that were prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. 5. Tax status: \_\_\_\_\_

In 2022, the Plan was restated effective July 15, 2022 to bring it into compliance with other legislative and regulatory changes. The Plan restated its plan in 2022 using the Principal Financial Group Non-Standardized Pre-Approved Profit Sharing Plan With CODA – (PFGPSP). Principal Financial Group received an IRS Opinion letter dated December 31, 2018, saying the PFGPSP was acceptable for use by employers. Although the Plan has been amended since receiving the Opinion Letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate regulatory authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan termination: \_\_\_\_\_

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
