### *Scope and Nature of the ERISA Section 103(a)(3)(C)*

We have performed audits of the financial statements of Clinica Family Health 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Description of Plan

The following description of the Clinica Family Health 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan available to eligible employees, as defined by the Plan Document, of Clinica Family Health (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Custodian and Administration of the Plan*

The custodian and record-keeper of the Plan is Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Custodian or Principal). The administrator of the Plan is the Employer. The Custodian holds all assets of the Plan in accordance with the provisions of the service provider contract with the Employer. The Plan's Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

An employee becomes eligible for the Plan on the first day of employment, as defined by the Plan Document. Eligible employees may enter the Plan on the first day of employment. Leased employees are not eligible for the discretionary non-elective contribution.

#### *Contributions*

Each year, eligible participants may contribute on a pre-tax, and after-tax Roth basis up to 100% of their eligible compensation, as defined, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as defined by the Plan, subject to internal revenue service (IRS) limitations. The Plan also allows special 403(b) catch-up contributions to participants that have at least 15 years of service. Participants may terminate or change their salary deferral agreements according to procedures and limitations as determined by the Plan Document.

Rollover contributions transferred from other qualified retirement plans or from Individual Retirement Accounts (IRA), are accepted as permitted by the Plan Document.

The Employer, at the discretion of management, may make a discretionary non-elective contribution to each participant who has completed 12 months of service with at least 1,000 hours (at the end of the participant's first 12 consecutive months of employment). For the year ended December 31, 2024, the Plan Sponsor made a non-elective contribution to eligible employees of 2% of compensation on a pay period basis, through June 7, 2024, at which time, the Employer stopped making non-elective contributions. Contributions are subject to certain IRS limitations. See Note 9 for additional information.

## Notes to Financial Statements

### ***Participants' Accounts***

Each participant's account is credited with the participant's rollover contributions, participant and Employer contributions, and an allocation of net plan investment earnings and losses and charged with distributions and expenses. The investment earnings or losses are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participants may direct the investment of their account balance into various investment options offered by the Plan.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary non-elective contribution portion of their accounts is based on years of continuous service as follows:

Participants are fully vested upon death, disability (as defined), or retirement age.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan terms range from one to five years, and up to 30 years for a principal residence loan. The loans are secured by the balance in the participant's vested account and bear interest at current market rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

### ***Benefit Payments***

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum cash distribution or a direct rollover to another qualified retirement plan, as defined, in an amount equal to the value of the participant's vested interest in his or her account. If a participant terminates employment and does not make a request for distribution and the participant's account balance was never greater than \$5,000, the plan administrator will authorize a mandatory benefit payment in a single lump sum. In addition, upon attaining age 59½, a participant may withdraw any part of his or her account.

### ***Forfeitures***

Forfeitures represent the portion of the Employer's discretionary non-elective contribution that is lost by a participant who terminates employment prior to becoming fully vested under the Plan's vesting schedule. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,362 and \$38, respectively. These accounts can be used to reduce future administrative expenses of the

Plan with any remaining forfeitures applied to reduce future Employer non-elective contributions. For the year ended December 31, 2024, \$31,956 was used to pay Plan administrative expenses and \$15,292 was used to reduce the Employer non-elective contribution.

## 2. Summary of Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan Sponsor determines the Plan's valuation policies utilizing information provided by an investment advisor and Custodian.

Purchases and sales are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, as well as capital gains reinvested.

### *Accounting for Fully Benefit-Responsive Investment Contracts with Insurance Companies*

The Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a custodial account. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. There are no reserves against the contract value for credit risk of the contract issuer. The crediting interest rate is based on a formula agreed upon with Principal Life but may not be less than 0%. Interest rates are reset each June 1 and December 1. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with Principal Life. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan

withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Employer does not believe any of these events are probable of occurring.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Contributions***

Participant contributions are recognized in the period during which the Employer made the respective payroll deduction from the participant's compensation. Employer non-elective contributions are recognized in the plan year to which the participant's compensation relates.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in assets available for benefits. In addition, investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## **3. Fair Value Investments**

Accounting Standards Codification (ASC) 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, qualified institutions.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Principal, the custodian, or affiliates thereof. Certain recordkeeping fees related to the plan year were paid from plan assets to Principal as well as certain investment fees are included in net appreciation (depreciation) of the funds. Certain investment advisory and third-party administrator fees were also included in the net appreciation (depreciation) of the funds. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These are transactions with related parties that qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its discretionary non-elective contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 7. Tax Status

Effective January 1, 2020, the Plan was amended and restated under a Volume Submitter 403(b) Plan that received an advisory letter from the IRS dated March 31, 2017 stating that the form of the Volume Submitter Plan was acceptable under Section 403(b) of the IRC and was therefore exempt from Federal income taxes. The Company believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, thus no provision for income taxes has been provided for in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks, and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### 9. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

In 2024, the Plan sponsor merged with the Mental Health Center of Boulder County under new name of Clinica Campesina Family Health Services. Effective January 1, 2025, the Plan was amended to align certain provisions with Mental Health Center of Boulder County, Inc. Employee Retirement Plan, including implementing 4% automatic enrollment for new employees and updating eligibility waiting period for employer contributions. The Clinica Family Health 403(b) Plan and the Mental Health Center of Boulder County, Inc Employee Retirement Plans will merge in late 2025 and all assets from both plans will transition to Empower, who will provide recordkeeping, custodial, compliance, and participant services for the Plan.

During January 2025 the Company reinstated Employer non-elective contributions that were paused previously.
