Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Farmers Realty Company 401(k) Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of the Plan

The following description of The Farmers Realty Company 401(k) Profit-Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan, which went into effect January 1, 1989, that is generally available to all employees of The Farmers Realty Company (the "Company", "Plan Sponsor", or "Plan administrator") and Equitable Savings and Loan Association (collectively, the "Employer"). The Plan excludes part-time/temporary/seasonal employees and reclassified employees. Employees become eligible to participate in the Plan after completing thirty days of service and may enter the Plan on the first day of the month coinciding with or next following the date they meet the Plan's eligibility requirements. Under the SECURE Act of 2019, certain long-term part-time ("LTPT") employees became eligible for participant contributions on January 1, 2024, after completing 500 hours of service for three consecutive years and meeting the Plan's age requirement. Under the SECURE 2.0 Act of 2022, certain LTPT employees become eligible for participant contributions on January 1, 2025, after completing 500 hours of service for two consecutive years and meeting the Plan's age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Amendment. Effective January 1, 2024 the Plan document was amended to provide for the following:

- The Plan's eligibility requirements for purposes of all contributions was changed from six months to sixty days;
- The Plan's entry date was changed from quarterly to monthly; and
- An automatic contribution arrangement was added such that eligible employees are automatically enrolled at a 5% pretax elective deferral contribution.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. The Plan provides for an automatic contribution arrangement ("ACA") such that an eligible employee without an affirmative election will be auto-enrolled into the Plan and have 5% of their compensation withheld as an elective deferral contribution. Participants who are auto-enrolled under the ACA can elect a permissible withdrawal within 90 days of their first automatic deferral. A participant's total contributions cannot exceed \$23,000 (\$30,500 if age 50 or older) in calendar year 2024.
- Safe Harbor Employer Nonelective Contributions – The Employer makes a safe harbor Employer nonelective contribution each Plan year equal to 3% of an eligible participant's compensation.
- Employer Matching Contributions – The Employer makes matching contributions each payroll period equal to 100% of an eligible participant's elective deferral contributions up to 5.5% of a participant's compensation.
- Discretionary Employer Contributions – The Employer may make a discretionary contribution to eligible participants who have completed 1,000 hours of service and are employed on the last day of the Plan year. Participants who die, become disabled, or terminate employment on or after attaining normal retirement age are also eligible to receive an allocation of the discretionary Employer contribution. This contribution is allocated to eligible participants' accounts in the ratio that each participant's compensation bears to the compensation of all eligible participants. For the year ended December 31, 2024, the Employer did not make a discretionary Employer contribution.

Note 1 – Description of the Plan (continued)

- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation.

Investment Options. Participants may direct their investments into various pooled separate accounts and registered investment companies.

Participant Accounts. Each participant's account is increased and/or decreased, as applicable, with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (safe harbor nonelective, matching, and discretionary), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their elective deferral contributions, rollover contributions, safe harbor Employer nonelective contributions, and related earnings thereon. Employer matching and discretionary Employer contributions made to a participant's account vest according to the following schedule:

Furthermore, employed participants become 100% vested in their Employer matching and discretionary Employer contribution accounts upon the following events:

- Participant's death;
- Participant becomes disabled as defined under the Plan;
- Participant reaches his/her normal retirement age; or
- Termination or partial termination of the Plan.

Forfeitures. When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay Plan expenses, used to reduce Employer contributions, or are reallocated to eligible participants as a discretionary Employer contribution. During 2024, forfeitures of \$63 were used to pay Plan expenses. The balance in the unutilized forfeitures account as of December 31, 2024 and 2023 was \$20,098 and \$8,422, respectively.

Note 1 – Description of the Plan (continued)

Payment of Benefits. Benefits to participants or beneficiaries are generally payable as a lump-sum, partial payment, or installments equal to the value of their vested account balance upon retirement, termination of employment, death or disability. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Participants may also elect a rollover distribution of their vested account balance into another qualified plan or Individual Retirement Account. Additionally, participants may elect in-service withdrawals of their rollover contributions account, upon attainment of age 59 ½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefit Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are contract administrator, recordkeeping, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.
- Pooled Separate Accounts ("PSAs") are valued at the NAV of units held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company ("Principal Life") and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust"), the custodians of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and Note 3;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- The investment information presented in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedules.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 6 – Tax Status

The Plan Sponsor has adopted a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of pooled separate accounts offered by Principal Life. As Principal Life and Principal Trust are the custodians of the Plan, these transactions qualify as party-in-interest transactions. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in pooled separate accounts and registered investment companies. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, there were two investments which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 10 – Nonexempt Prohibited Transactions

During 2024, 2023, 2022, and 2021, the Company had nonexempt prohibited transactions related to participant contributions not remitted to the trust in a timely manner as listed on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company corrected a portion of the late contributions by remitting lost earnings into the Plan's trust in October 2024. The Company intends to correct the remaining late contributions by remitting any remaining principal amounts and lost earnings into the Plan's trust as soon as administratively feasible.

Note 11 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
