INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
North Atlanta Primary Care 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of North Atlanta Primary Care 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of North Atlanta Primary Care 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about North Atlanta Primary Care 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

North Atlanta Primary Care 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the North Atlanta Primary Care (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company except for certain employees covered under collective bargaining agreements and non-resident aliens. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees of the Plan are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitoring investment performance.

Plan assets are held by both Empower Trust Company, LLC (Empower), the qualifying institution which provides a certification, and Morgan Stanley Smith Barney, LLC (Morgan Stanley), which holds participant self-directed brokerage accounts, which does not provide a certification. These custodians invest contributions and Plan earnings and make investment transactions as directed by the Trustees. Empower Retirement LLC provides record keeping services of the non-self-directed brokerage accounts. FuturePlan provides recordkeeping services for the self-directed brokerage accounts and recordkeeping services at the Plan level. FuturePlan also acts as the third-party administrator for the Plan and performs certain plan administration and annual ERISA compliance testing.

On December 29, 2020, North Atlanta Primary Care (NAPC), completed a reorganization and certain employees of NAPC became employees of Southeast Primary Care Partners, LLC, an affiliate of NAPC. The reorganization had no effect on the employees' eligibility to participate in the Plan. Moreover, effective December 29, 2020, Southeast Primary Care Partners, LLC adopted the Plan and became a participating employer in the Plan.

Eligibility

Employees are eligible to make deferral contributions on the first day of each calendar month once they are 21 years of age and have completed three consecutive months of service with the Company.

Contributions

Each year, participants may contribute up to 100% of their pretax annual eligible compensation, as defined in the Plan, not to exceed the amount allowed by law for income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3%, with an automatic 1% per year escalation up to 6% of compensation, and their contributions invested in a designated balanced fund until changed by the participant.

North Atlanta Primary Care 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

Contributions (continued)

The Company contributes a non-discretionary safe harbor matching contribution of 100% of employee deferrals up to 1% of compensation and 50% of employee deferrals over 1%, up to 6% of compensation. Effective August 1, 2023, participants are eligible for the safe harbor match after reaching 1 year of employment. The Company may make a discretionary profit sharing contribution as determined by the board of directors of the Company. For the years ended December 31, 2024 and 2023, there were no discretionary profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of Plan earnings, and is charged with withdrawals. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, and qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings is based on a five year grading scale. Participants are immediately vested upon disability or death while employed by the Company.

Vesting in the Company's discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

Benefit Payments

On termination of service, death, or disability, a participant or beneficiary receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for benefit payments to be made in either periodic installments, annuities or designated sums from time to time as elected by the Participant. In-service withdrawals are allowed if the participant has reached certain age and vesting requirements, as defined by the Plan. If the participant's account balance exceeds \$1,000, the distribution need not commence prior to attainment of normal retirement age unless the participant elects otherwise.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$135,787 and \$113,198, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$107,709 and \$34,398, respectively, from forfeited nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Distributions to participants are recorded when paid.

North Atlanta Primary Care 401(k) Plan Notes to Financial Statements

Note 2: SUMMARY OF ACCOUNTING POLICIES (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer. Investment related expenses are included in net appreciation of fair value of investments. During the years ended December 31, 2024 and 2023, expenses of \$103,718 and \$108,571, respectively, were paid by the Plan and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued October 13, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: CORRECTION OF A MISSTATEMENT

The Plan restated employee and employer contributions receivable and employee and employer contributions as of and for the year ended December 31, 2023, by \$271,776, to correct a material error in the recorded receivable relating to a correction due to the Company not using the correct definition of Plan compensation. The Company remitted this correction in July 2025.

Note 5: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Common and preferred stocks (held in the Self Directed Brokerage Accounts): Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds (held in the Self Directed Brokerage Accounts): Valued at the NAV of shares held by the Plan at year-end or reported in the active market where the fund is traded on a daily basis.

Guaranteed interest account: Guaranteed interest accounts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (See Note 6). Fair value is defined as the liquidation value of the investment, which includes retirement, death, disability, termination of employment and loans. The fair value / liquidation value is equal to the book value as defined in the contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 6: GUARANTEED INTEREST ACCOUNT WITH INSURANCE COMPANY

The Plan entered into a guaranteed interest account with Massachusetts Mutual Life Insurance Company (MMLIC) totaling \$410,093 for 2024 and \$234,803 for 2023. The account is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuation in the market. The fair value of the guaranteed interest account is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Note 7: TAX STATUS

On June 30, 2020, the IRS stated that the preapproved profit-sharing plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The preapproved profit-sharing plan has been amended since receiving the opinion letter and the Plan has not received a letter of determination specific to the Plan itself. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower and Morgan Stanley are the custodians of the Plan and certain Plan investments are managed by Empower and Morgan Stanley and, therefore, these transactions qualify as party-in-interest transactions. Moreover, certain expenses are paid by the Plan to FuturePlan, who is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, investment advisory and management fees of \$103,718 and \$108,571, respectively, were paid to the custodians and recordkeepers.

Note 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 10: PLAN COMPLIANCE

The Company determined that for the years ended December 31, 2023 and 2022, the correct definition of Plan compensation was not applied to participant contributions and employer contributions, which resulted in participant deferral elections not being applied to bonus, PTO, and various other pay codes. The Company calculated and remitted corrective contributions and lost earnings for the 2022 errors of \$80,417 during 2024 and amounts are included under employee contribution receivables as of December 31, 2023 in the accompanying financial statements. The Company calculated and remitted corrective contributions and lost earnings for the 2023 errors of \$46,516 for employee contributions and \$57,167 for employer contributions during 2025 and amounts are included under contribution receivables as of December 31, 2024 in the accompanying financial statements.
