- (1) Eligibility for Participation
Eligible employees of Kimble Chase Life Science and Research Products LLC (the “Company”) who were employed on January 1, 1994 (the “Effective Date”) who completed at least one year of service and attained age 21 became eligible to participate in the Plan on the Effective Date. Effective January 1, 1996, eligible employees of the Company are eligible to participate in the Plan on the January 1 or July 1 following the completion of 1000 hours of service during the first year of employment or in any current or subsequent calendar year. The plan was frozen to new participants on June 30, 2001.
- (2) Definitions
Plan Year: January 1 through December 31.
Credited Service: Total period of employment measured from later of January 1, 1994 and date of hire. Credited service for purposes of determining a participant’s accrued benefit shall not include any service earned after June 30, 2001.
Average Earnings: The average of compensation earned over all plan years as an active participant on or before June 30, 2001.
Accrued Benefit: The accrued benefit is equal to (a) 1.0% of Average Earnings (or \$120 if greater) multiplied by Credited Service, not in excess of 35 years, plus (b) 0.65% of Average Earnings in excess of covered compensation multiplied by Credited Service, not in excess of 35 years.
- (3) Normal Retirement Benefit
 - (a) Eligibility: Age 65.
 - (b) Benefit: Accrued Benefit as of the date of normal retirement.
- (4) Early Retirement Benefit
 - (a) Eligibility: Age 60 and 15 Years of Credited Service.
 - (b) Benefit: Accrued Benefit as of the date of Retirement, reduced actuarially for commencement preceding normal retirement.
- (5) Disability Retirement Benefit
 - (a) Eligibility: 5 Years of Credited Service.
 - (b) Benefit: Accrued Benefit as of the date of Retirement, reduced actuarially for commencement preceding normal retirement.
- (6) Delayed Retirement Benefit
 - (a) Eligibility: After Normal Retirement.

 - (b) Benefit: Accrued Benefit determined at date of termination, payable at Normal Retirement, or as early as age 60, reduced actuarially for commencement preceding Normal Retirement.
- (8) Death Benefit
 - (a) Eligibility: a vested Participant with a surviving spouse who has been married to the Participant for the 12 month period preceding death.
 - (b) Benefit: minimum statutory qualified preretirement survivor annuity commencing on the month following the month in which the Participant would have reached the earliest retirement date. An enhanced death benefit is payable to a participant's beneficiary if the participant dies during a delayed retirement period. The enhanced death benefit is equal to the actuarial equivalent of the participant's Delayed Retirement Benefit as of the date of death.
- (9) Forms of Payment
 - (a) Normal Form: Life annuity, if single; actuarially-reduced 50% joint and survivor annuity, if married.

Actuarial Methods

Actuarial Cost Method

The actuarial cost method used to determine the Plan's funding requirements is the Unit Credit method. Under this method, the funding target is the actuarial present value of accrued benefits as of the valuation date for all participants. The target normal cost is the actuarial present value of benefits expected to accrue in the current Plan year for each active participant under the assumed retirement age.

Asset Valuation Method

Plan assets used to determine the Plan's funding requirements are equal to a 3-year averaged fair market value of assets. Under this asset valuation method, Plan assets are equal to the average of (1) the adjusted fair market value of assets based on the December 31, 2021 market value of assets modified to reflect 2022 and 2023 distributions, contributions and expected investment income, (2) the adjusted fair market value of assets based on the December 31, 2022 market value of assets modified to reflect 2023 distributions, contributions and expected investment income and (3) the fair market value of assets as of the current Plan year. Expected investment income for the 2024 Plan year is based on a 6.50% return, limited to 5.59%, and for the 2023 Plan year was based on a 6.50% return, limited to 5.74%, and for the 2022 Plan year was based on a 6.50% return, limited to 5.92%. The resulting value cannot be less than 90%, nor greater than 110%, of the fair market value of assets.
