### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Wayne UNC 401(a) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

### 1. Description of Plan

The following description of the Wayne UNC 401(a) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan established January 1, 2005 covering all employees of Wayne Memorial Hospital, Inc. and affiliates (the “Hospital” or “Employer”) who meet certain eligibility requirements. Employees of the Hospital are eligible to participate in the employer match, employer retirement, and employer supplemental contribution components of the Plan upon age 18 and after completing 1,000 hours of service within 12 months from the employee’s date of hire. For the employer supplemental contribution, participants must also be employed on the last day of the Plan year. The Retirement Committee is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *Contributions*

Contributions are available only to employees who (i) are not actively participating in the Hospital’s Pension Plan, (ii) had at least 1,000 hours of service in the Plan year and (iii) were employed on the last day of the Plan year for the employer supplemental contributions. The employer matching contribution is equal to 25% of deferrals made to the Wayne UNC 403(b) Plan up to 4% of eligible compensation. The employer supplemental contribution is determined based on years of service and ranges from 25% to 100% of deferrals made to the Wayne UNC 403(b) Plan up to 4% of eligible compensation. The employer retirement contribution is based on years of service and ranges from 3% to 4% of eligible compensation.

The Plan does not provide for participant contributions.

#### *Participant Accounts*

Each participant’s account is credited with the employer contributions and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

#### *Vesting*

All Employer contributions are subject to the following vesting schedule below:

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment options as provided by the Plan. The Plan allows in-service distributions upon demonstration of financial hardship, disability, or after the participant reaches the age of 59 ½ years. Vested account balances below \$1,000 may be automatically paid to participants at the discretion of the Hospital.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$194,846 and \$86,211, respectively. These accounts are available to reduce future Employer contributions or Plan expenses. Forfeitures in the amount of \$177,312 and \$102 were used to reduce Employer contributions and were applied to Plan expenses, respectively, for the year ended December 31, 2024.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by its investment adviser and custodian. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 5) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of benefits***

Benefit payments are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### **3. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), a qualified institution.

### **4. Fair Value Measurements**

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds:** Mutual funds represent investments with various investment managers. The funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held in the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Group Annuity Contract

The Plan holds group annuity accounts with Principal Life Insurance Company, an insurance company registered in the state of Iowa.

Annuity accounts are credited with a guaranteed minimum rate of interest. The guaranteed minimum interest rate will be first established at the contract date. Subsequently, the guaranteed minimum interest rate will be determined each time composite crediting rates are announced. The guaranteed minimum interest rate will be determined by taking the average of five-year constant maturity treasury rates twelve months prior to Principal Life Insurance Company announcing the composite crediting rate, reducing this average by 1.25%, and rounding this amount to the nearest 0.05%. Constant maturity treasury rates means those rates posted by the board of governors of the Federal Reserve System or by an agency that provides similar information. The guaranteed minimum interest rate will never be less than 1% or greater than 3%.

Contributions to the annuity accounts are grouped into “vintages” comprised of deposits received over defined time periods. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the assets supporting that vintage.

These group annuity contracts are considered fully benefit-responsive investment contracts as defined by ASC 962, because they are fully liquid and immediately cashable once a participant terminates employment with the Employer.

### **6. Related Party and Party-In-Interest Transactions**

Certain investments are managed by Principal. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### **8. Tax Status**

The IRS has determined and informed the Plan by a letter dated January 21, 2016, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.
