Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of BerlinRosen Holdings 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of BerlinRosen Holdings 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of BerlinRosen Holdings, LLC and its subsidiaries (the "Company") with no service or age requirements. The entry date for eligible participants is on the first day of the month coinciding with or following the date of employment. The Plan was established on January 1, 2006 and subsequently restated on January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and is responsible for the administration of the Plan. Effective January 1, 2024, Fidelity Workplace Services, LLC functions as the investment manager and recordkeeper, and Fidelity Management Trust Company (the "Trustee") functions as the custodian and trustee. The Plan pays investment management fees and trustee fees in accordance with the plan agreement.

Prior to January 1, 2024, Reliance Trust Company functioned as the trustee and custodian, and Automatic Data Processing, Inc. functioned as the investment manager and recordkeeper.

Contributions

The Plan provides for employee salary deferral contributions a minimum and maximum of 1 and 90 percent, respectively, of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute a minimum and maximum of 1 up to 90 percent, respectively, of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2024. The Company remitted all lost earnings in 2025.

The Plan provides for employer matching contributions of 100 percent of the first 4 percent of employees' deferred compensation, which are contributed each pay date.

The Company may make annual discretionary contributions. Participants who have completed 1,000 hours of service during the plan year and are employed on the last day of the plan year will be eligible to receive an allocation of the Company's discretionary contribution.

The employer matching contributions for the year ended December 31, 2024 amounted to \$4,453,860. There were no discretionary matching contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their account balance investments into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Notes receivable are collateralized by the participant's account balance and bear interest at rates that range from 4.25 to 10.50 percent, which are commensurate with prevailing rates determined by the plan administrator, and mature on dates through September 2029. A general-purpose participant note receivable may be used for any reason and may have a term of up to 5 years. A participant note receivable for the purchase of a principal place of residence may have a term of up to 15 years. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

On termination of service due to death, disability, retirement, or attainment of 59½ year of age, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the Trustee or its affiliates; therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. In addition, the Company pays certain administrative fees on behalf of the Plan. The Plan provides for loans to participants, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market values. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 4 for additional information.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Effective February 6, 2025, Small Girls 401(k) Plan was merged into the Plan. Accordingly, all assets, participants, and their related account balances of \$4,343,013 were transferred into the Plan during 2025.

In September, 2025, the Company submitted to the IRS a compliance statement under the IRS Voluntary Correction Program (VCP) to resolve certain plan discrepancies identified relating to the definition of compensation, affecting plan years 2016 through 2023. A total correction of \$1,732,451 was calculated to account for the missed participant deferrals, Company match, and corresponding lost investment returns, which has been recorded within employer contributions receivable as of December 31, 2024.

Note 3 - Certified Information

Effective January 1, 2024, Fidelity Management Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Prior to January 1, 2024, Reliance Trust Company was the trustee and held the Plan's investments and executed all related transactions. The balances as of December 31, 2023 are based solely on information certified by Reliance Trust Company.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities to be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan can access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Plan Merger

Effective January 1, 2024, Inhouse 401(k) Plan; Derris LLC 401(k) Plan; and Glen Echo Group, LLC 401(k) Profit Sharing Plan were merged into the Plan. Accordingly, assets, participants, and their related account balances of \$11,288,561, \$4,683,110, and \$2,335,234, respectively, were transferred into the Plan during 2024.

Effective February 1, 2024, Message Lab 401(k) Profit Sharing Plan was merged into the Plan. Accordingly, assets, participants, and their related account balances of \$1,011,345 were transferred into the Plan during 2024.

Effective March 5, 2024, M18 401(k) Plan was merged into the Plan. Accordingly, assets, participants, and their related account balances of \$1,489,507 were transferred into the Plan during 2024.
