### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. Plan Description**

The following description of the IQ Solutions Incorporated (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General - The Plan became effective April 1, 1996 and is a defined contribution plan covering substantially all employees of the Company who are age 21 or older and have completed 30 consecutive days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. Contributions - Participants may make voluntary contributions to the Plan. The amount that may be contributed is limited by the Internal Revenue Code applicable to the type of plan. The Company matches a percentage, determined every year, of participant contributions. For the years ended December 31, 2024 and 2023, the matching percentage was 50% of each participant's contribution, up to 6% of each participant's wages. The Company may also make a discretionary contribution, but no such contribution was made for either 2024 or 2023. Investments of contributions are participant-directed.
- c. Participant accounts - Each participant's account is credited with the participant's contribution, the Company's match of that contribution, and an allocation of (a) the Company's discretionary contributions, if any, and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- d. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting on the remainder of their account is based on years of service with a minimum of 1,000 hours of service per year. Participants vest 20% annually after one year of service with full vesting after five years. Participants, however, are fully vested upon retirement, death, disability, early retirement age, or plan termination as defined in the Plan document.

**1. Plan Description (continued)**

- e. Investment options – Upon enrollment in the Plan, a participant may direct the investment of contributions in any of the available investment options. Participants may change their investment option daily. At December 31, 2024 and 2023, investment options include money market accounts and registered investments such as mutual funds and exchange traded funds through the Vanguard Group.
- f. Payment of benefits - The Plan defines normal retirement age as 59.5. Upon attainment of normal retirement age, participants that are still employees of the Company can elect to receive in-service distributions.

Upon termination of service due to retirement, death, or disability a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants must take a distribution for their nonelective account balance upon termination within 30 days, if their vested balance is less than \$1,000. If their vested balance is between \$1,001 and \$5,000, their balance will be moved into an individual retirement arrangement (IRA) account that it is established for the participant if no action is taken within 30 days of termination. Upon termination and thereafter, participants can rollover their account balances, under certain conditions, to another eligible retirement plan as defined by the Internal Revenue Code. If a terminated employee reaches the age of retirement and still has funds in the Plan, the employee will receive a single payment. Under Plan provisions, in certain hardship situations, participants may withdraw from their vested elective account balances. However, such withdrawals are limited to the amount dictated by the hardship. Benefits are recorded when paid.

- g. Notes receivable from participants – Participants may elect to borrow from their participant accounts the lesser of 50% of the vested account balance or \$50,000, reduced by any outstanding loan balance, with a minimum loan of \$1,000. Loan terms range from one to five years. Employees may only have a maximum of two loans at one time. Loans taken for residential loans can have terms up to 15 years. Loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through semi-monthly payroll deductions.
- h. Forfeited accounts – Forfeitures from the accounts of participants who have terminated employment are used to offset employer contributions. As of December 31, 2024 and 2023, the forfeitures available to offset future employer contributions was \$153,506 and \$118,313, respectively.

**2. Summary of Significant Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payments of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued interest. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Expenses

The Company absorbs all of the Plan's recordkeeping expenses. The Plan pays other administrative expenses.

Subsequent events

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Financial reporting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the *money market account* of Vanguard Group (Vanguard) are generally valued at amortized cost. The account determines its unit value each day.

Investments in *registered investments (mutual funds and exchange traded funds)* of Vanguard DFA are carried at their estimated market value provided by Vanguard, representing reported prices of the units held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Investments**

Ascensus is the custodian of the Plan's investments and was responsible for collecting receipts and handling trust asset transactions. The custodian has certified all Plan investments, transactions, and income included in the accompanying financial statements and the schedule of investments.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contribution.

**6. Tax Status**

The Company has received an opinion letter from the Internal Revenue Service that the Plan and related trust are designed in accordance with Section 401(a) of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC.

**6. Tax Status (continued)**

Accounting principles generally accepted in the United States requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**7. Party-in-Interest Transactions**

Plan investments consist of units of registered investment accounts and shares of exchange-traded funds managed by Vanguard. Vanguard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

Administrative fees paid by the Plan for management services totaled \$127,801 and \$110,022 for the years ended December 31, 2024 and 2023, respectively.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is likely that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
