## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GSM Services, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

December 31, 2024 and 2023

**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of GSM Services, Inc. 401(K) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established effective January 1, 1994, and is a defined contribution plan which covers substantially all employees of GSM Services, Inc., who are at least 21 years of age and have completed 90 days of service. The Plan is subject to other provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may elect to defer a percentage of their pretax annual compensation which includes overtime, bonuses and commissions, subject to the annual dollar limit set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute a discretionary amount each year in the form of a matching percentage or a discretionary profit sharing contribution. The employees’ contributions are made each pay period and invested as directed by the Plan participants.

Upon enrollment in the Plan, a participant may direct contributions in any of the Plan’s fund options. Participants may change their investment options at any time.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Employees are vested 100% in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)**

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used by the Plan for several purposes. Any forfeiture will be added to any employer discretionary profit sharing contribution. However, any forfeiture attributable to matching contributions will be used to reduce matching contributions.

Participant loans

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local rates. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, or upon death, disability or retirement, a participant may receive an amount equal to the vested value of his or her account, payable in a lump sum.

If vested benefits exceed \$5,000 (excluding amounts attributable to rollovers), the participant can elect how to receive benefits. Distributions of vested account balances less than and in excess of \$5,000 will be made as soon as administratively feasible following termination of employment. Involuntary cash-outs are allowed in the event the vested account balance is less than \$5,000. With respect to vested account balances between \$1,000 and \$5,000, the balance may be rolled over to an IRA in the participant's name. Should the vested account balance be less than \$1,000 a lump sum distribution will be made to the participant with applicable taxes withheld.

Plan termination

Although it has not expressed any intent to do so, the Company retains the right under the Plan to discontinue employer contributions at any time and terminate the Plan. In the event of a termination of the Plan, participants are immediately 100% vested in their account.

**NOTE 2: SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Such estimates and assumptions could change in the future as more information becomes known, which could impact the amounts reported and disclosed herein.

Investment valuation and income recognition

The Plan's investments are stated at fair market value. Shares of registered investment companies and common collective trust funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**NOTE 3: INVESTMENTS**

Lincoln Financial Group, trustee of the Plan's assets, holds the Plan's investment assets and executes transactions thereon. All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, investment income and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee.

For the years ended December 31, 2024 and 2023, the Plan's investment assets (including investments bought, sold, as well as held during the period) appreciated in fair value by \$575,584 and 684,284, respectively.

**NOTE 4: RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Lincoln Financial Group. Lincoln Financial Group was the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services amounted to \$12,265 and \$11,843 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor has elected to pay substantially all of the administrative expenses incurred by the Plan.

**NOTE 5: INCOME TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service dated August 30, 2001, stating that the Plan qualifies under Section 401(a) of the Internal Revenue Code (Code), and therefore, the Plan is exempt from taxation under present income tax law. Once qualified, the Plan is required to operate in conformity with the code to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to the year ended December 31, 2021.

**NOTE 7: FAIR VALUE MEASUREMENTS**

The Plan adopted the provisions of FASB ASC 820-10, "Fair Value Measurements". FASB ASC 820-10 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosures about fair value measurements.

Fair Value Hierarchy

Under FASB ASC 820-10, the Plan groups assets at fair value in three levels, based on the markets in which the assets are traded and the reliability of the assumptions used to determine fair value. These levels are:

Level 1: Valuation is based upon quoted prices for identical instruments traded in active markets.

Level 2: Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.

Level 3: Valuation is generated from model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.
