- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Investments**

As discussed in Note F, the financial statements include an investment representing 31% and 34% of total assets as of December 31, 2024 and 2023, respectively, whose fair value has been estimated by an independent appraisal, in the absence of readily ascertainable fair values, with the assistance of management and approved by the trustee. Because of the inherent uncertainty of the valuation, the estimated value may differ significantly from the value that would have been used had a market for the investment existed, and the difference could be material. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held at end of year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following brief description of Frontier Bancshares, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan document for more information.

General

The Plan is a defined contribution profit sharing plan which was formed for the purpose of providing retirement benefits to employees of Frontier Bancshares, Inc. (Plan Sponsor).

The Plan provides the opportunity for participants to make before tax (401(k)) salary reduction contributions under the guidelines provided by Internal Revenue Service regulations. In addition, participants may make rollover contributions to the Plan from other qualified plans.

During 2023, Pentegra Retirement Services (Pentegra), the former administrator of the plan, partnered with Empower Retirement, LLC (Empower) and, as a result, the Plan's assets were moved from Reliant Trust Company, the former trustee and custodian of the Plan, to Empower, the current trustee and custodian of the Plan.

Contributions

The Plan is funded primarily by voluntary employee contributions. Total deferrals by an individual participant in any calendar year may not exceed a dollar limit set by law and was \$23,000 in 2024 and \$22,500 in 2023. Plan participants who are at least 50 years old by the end of the year may make special "catch up" contributions. The limit for "catch up" contributions was \$7,500 in 2024 and \$7,500 in 2023. This limit could be increased in future years for cost of living changes.

During 2024 and 2023, the Plan Sponsor elected to make a safe harbor matching contribution to participant accounts. During 2024 and 2023, the match was 100% of participant contributions up to 3% and 50% of the next 2% allocated total eligible compensation to all eligible participants. The Plan also provides for profit sharing contributions. In 2024 and 2023, the Plan Sponsor did not make profit sharing contributions.

Eligibility

All employees who are 21 years old and have completed two months of service are eligible to participate in the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 5% of eligible compensation unless they affirmatively elect not to participate in the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Plan Sponsor’s contributions, (b) Plan earnings (losses), and charged with an allocation of administration expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested amount. Participant direct contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their pre-tax salary reduction contributions, and rollover contributions, safe harbor employer contributions and earnings thereof. Vesting in the Plan Sponsor matching contributions and profit sharing contributions is as follows:

Payment of Benefits

A participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account upon termination of service due to separation of service, death, disability, retirement, or other reasons.

On termination of employment, if the participant’s account is less than \$1,000, the benefit will be paid in a lump sum. For terminated participants’ account balances that are at least \$1,000 but less than \$5,000, the Plan Administrator may transfer the entire amount into an individual retirement account without the participant’s consent. If the participant’s account balance exceeds \$5,000 the participant may choose to keep the funds in the Plan, request a direct rollover to another qualified plan, or take a lump sum distribution.

Upon the participant reaching the normal retirement age of 65, benefits will be provided at the option of the participant. Early retirement is available when the participant reaches 55 years of age or older and has 5 years of vested service. The participant may defer benefit payments after reaching normal retirement age of 65. Benefits must start being paid when the participant reaches age 72 .

Forfeitures

Forfeitures represent the non-vested portion of the Plan Sponsor contributions plus earnings thereon, which are not distributed to participants who terminate employment before they are 100% vested. At December 31, 2024 and 2023, forfeited non-vested accounts of \$40,058 and \$32,187, respectively, are available to reduce future employer contributions. During 2024 and 2023, \$47,640 and \$51,348, respectively, of forfeitures were used for employer contributions.

Notes Receivable from Participants - Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Assets in the employer stock fund are not available for loans. The loans are secured by the balance in the participant's account. Interest is calculated using 1% point over the prime interest rate. Principal and interest is paid ratably through payroll deductions. Loans that become in default status are treated as distributions to the participants.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America (US GAAP).

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator and management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures. Accordingly, actual results may differ from those estimates.

Investments and Income Earned

In accordance with Accounting Standard Codification (ASC) 820, *Fair Value Measurements*, issued by the Financial Accounting Standards Board (FASB), the Plan's investments are reported at fair value. FASB ASC 820 establishes a framework for measuring fair value. Purchases and sales of securities are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Net loss or gain on pooled separate accounts include realized and unrealized gains and losses.

Payment of Benefits

Benefits are recorded when paid.

Receivables

Employer matching contributions declared but not funded at year end are reflected as receivables. Employee contributions received but not remitted to the custodian at year end are reflected as receivables. Employer profit sharing contributions declared, but not paid until after year end are reflected as receivables.

The Plan allows for Employer matching contribution true-ups at the end of the year for participants who may have received additional funds had they structured their employee deferrals evenly throughout the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan's administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant loan is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

Fees and expenses incurred in the administration of the Plan, to the extent not paid by the employer, are charged to and paid from the Plan's assets.

Fair Value Measurements

The Plan follows ASC 820, issued by the FASB. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Fair Value Measurements - Continued

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in active markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value as of December 31, 2024 and 2023:

Money market funds: Valued based at the subscription and redemption activity at a \$1 stable net asset value (NAV). However, on a daily basis the funds are valued at their daily NAV calculated using the amortized cost of the securities held in the fund.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unitized Fund: Valued at the fair value of the underlying stock of Frontier Bancshares, Inc. which is valued annually by an independent third party utilizing observable inputs plus an uninvested cash portion.

Subsequent Events

Management of the Plan has evaluated subsequent events for disclosure through the date of the independent auditors' report, the date the financial statements were available to be issued.

NOTE C - INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. No provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

NOTE E - CERTIFIED FINANCIAL INFORMATION (UNAUDITED)

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, Empower (for 2024 and 2023) and Reliance Trust Company (for only 2023) (the Custodians) have certified to the Plan Administrator that all investments (stated at fair value) and participant notes receivable, together with all other transactions which affect plan investments and notes receivable, are complete and accurate.

The Plan's investments and notes receivable are held by the Custodians. Investments are presented at fair value as determined by quoted market or contract prices as determined by the Custodians. The Plan's investments and participant notes receivable, as reported by the Custodians at December 31, 2024 and 2023, are summarized as follows.
